**AMENDMENT NO. 1 TO INTERLOCAL AGREEMENT  
FOR USE OF THE GUILFORD COUNTY HIGH INTENSITY  
DRUG TRAFFICKING AREA (HIDTA) GRANT BY THE  
GREENSBORO POLICE DEPARTMENT**

THIS CONTRACT AMENDMENT is hereby made and entered into this 11<sup>th</sup> day of June, 2013, and is effective as of the 1<sup>st</sup> day of November, 2011, by and between GUILFORD COUNTY, on behalf of the GUILFORD COUNTY SHERIFF'S OFFICE, hereinafter referred to as the "COUNTY" and the CITY OF GREENSBORO, on behalf of the GREENSBORO POLICE DEPARTMENT, hereinafter referred to as the "SUB-RECIPIENT," both governmental units organized and existing under the laws of the State of North Carolina, and also collectively referred to as the "Parties."

WITNESSETH:

WHEREAS, the COUNTY applied for and was awarded grants from the Executive Office of the President, Office of National Drug Control and Policy (ONDCP); and,

WHEREAS, the COUNTY engaged the SUB-RECIPIENT to assist the COUNTY in utilizing such funds; and,

WHEREAS, the Parties entered into an Interlocal Agreement which was effective November 1, 2011, and which established terms and conditions under which the SUB-RECIPIENT will use the funds to disrupt and dismantle drug trafficking and money laundering organizations through participation in intelligence-driven multijurisdictional operations; and,

WHEREAS, the initial Interlocal Agreement may be revised or amended with a written Contract Amendment executed by the Parties.

WHEREAS, the Parties now wish to amend the terms of the Interlocal Agreement by causing it to be continuous, and for an ongoing period of time, subject to HIDTA grants received by GUILFORD COUNTY.

NOW, THEREFORE, the Parties mutually agree that, as of the effective date of this Amendment, the following changes are hereby made to the initial Contract as follows:

1. The title of the Interlocal Agreement is hereby revised to:

**INTERLOCAL AGREEMENT FOR USE OF THE GUILFORD COUNTY HIGH INTENSITY DRUG TRAFFICKING AREA (HIDTA) GRANT BY THE GREENSBORO POLICE DEPARTMENT.**

2. Section 2 of the Interlocal Agreement is hereby replaced as follows:

**Section 2. Term, Services and Scope to be Performed and Presumption that Duty is SUB-RECIPIENT'S.** The term of this Contract is from November 1, 2011, until such time as all HIDTA grant funds are expended. This Contract is to continue from year to year, as long as GUILFORD COUNTY receives any grant funds under the HIDTA program. When all HIDTA grant funds are expended, this operation and all payments hereunder shall cease. (The first year's **HIDTA Grant Award and Agreement** documentation are attached hereto as **Attachment C.**)

All other provisions of the initial Interlocal Agreement are hereby ratified and shall continue in full force and effect without change, unless and until revised upon mutual written Agreement of the Parties, or terminated as provided herein.

IN WITNESS WHEREOF, the COUNTY and SUB-RECIPIENT have set their hands and seals, all pursuant to authority duly granted as of the day and year first above written.






