### Moment of Silence

The meeting opened with a moment of silence.

### Pledge of Allegiance to the Flag

Mayor Vaughan recognized Councilmember Abuzuaite to lead the Pledge of Allegiance to the Flag.

Assistant City Manager Barbara Harris recognized Hart Crane of the Planning Department who served as Courier for the meeting.

221-18 RESOLUTION RECOGNIZING THE IMAGINE A DAY WITHOUT WATER CAMPAIGN BEGINNING OCTOBER 10, 2018

The City of Greensboro is committed to recognizing the "Imagine a Day Without Water" campaign beginning October 10, 2018, the day water agencies, organizations, elected officials, corporations, environmental advocates and others across the country join together to highlight the critical importance of clean water in our lives and the

investment in infrastructure that is necessary to protect this valuable resource. On October 10, 2018-October 17, 2018, the Department of Water Resources will promote the "Imagine a Day Without Water" campaign by sharing information about the values of water on a daily basis.

WHEREAS, the infrastructure that brings water to and from homes and businesses is essential to the quality of life and economic vitality of the City of Greensboro; and

WHEREAS, the city population of 287,027 residents on average utilizes 54.7 gallons of water per person, per day; and

WHEREAS, the Greensboro community has a distribution system that consists of treatment facilities and pumping stations that produce an average of 32.7 million gallons of water per day, and 1,510 miles of public water line that date back to the early 1900's; and

WHEREAS, utilities nationwide are grappling with aging infrastructure and lack reliable revenue and funding to maintain and upgrade their systems; and

WHEREAS, changes in weather patterns are causing epic drought and widespread flooding in regions throughout the United States putting pressure on water systems that are ill-equipped and ill-prepared to manage such extreme events; and

WHEREAS, one-fifth of the U.S. economy would grind to a halt without a reliable and clean source of water; and

WHEREAS, managing water responsibly is critical to our nation's environmental health and to a high quality of life through economic commerce, power generation, and recreation; and

WHEREAS, investing in our drinking water and wastewater systems will secure a bright and prosperous future for generations to come; and

WHEREAS, innovation in water conservation and water reuse will drive job growth, economic development, and establish a 21st century paradigm of water management in the United States; and

WHEREAS, green stormwater infrastructure will not only ease the burden on our sewers but will provide a maximum return in benefits to the public, the economy and the environment; and

WHEREAS, for every one job created in the water sector, another 3.68 jobs are added in the national economy. And for every \$1 spent on infrastructure improvements, the US generates \$6 in returns; and

WHEREAS, different regions face different water challenges, so the solutions to strengthen our drinking water and wastewater systems must be locally driven, but reinvestment in our water must be a national priority.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

1. That the City of Greensboro recognizes that water is essential to the quality of life and economic competitiveness and acknowledges the importance of educating the public about the value of water through the "Imagine a Day Without Water" campaign.
2. That the City of Greensboro is dedicated to investing in water, wastewater, and stormwater infrastructure and encourages our federal partners to bring much-needed funding and innovation to protect and restore our critical water infrastructure.

WHEREAS; The Greensboro Police Department wishes to amend the City contract with the Kellin Foundation for Child Response Initiative until June 30, 2019; and

WHEREAS; The funds will supplement the program by provide salaries for personnel, training and office supplies for general day to day activities, maintaining program records and promotional materials to support the Greensboro Child Response Initiative Program that are not covered by the Governor's Crime Commission grant; and

WHEREAS: The Greensboro Police Department wishes to amend the contract to continue supplementing the program in the amount of \$70,000.

WHEREAS; the Edward Byrne Memorial Justice Assistance Grant (JAG) Program, authorized under Federal Regulation 42 U.S.C. 3751(a), is the primary provider of federal criminal justice funding to state and local jurisdictions; and

WHEREAS; the JAG Program (CFDA #16.738) provides states and units of local governments with critical funding necessary to support a range of program areas including law enforcement, prosecution and court programs including indigent defense, prevention and education programs, corrections and community corrections, drug treatment and enforcement, crime victim and witness initiatives, and planning, evaluation, and technology improvement programs; and

WHEREAS; this grant is a disparate allocation between the Greensboro Police Department, High Point Police Department and Guilford County Sheriff's Department which requires an application process for the funder to approve the proposed use of funds; and

WHEREAS; A disparate allocation occurs when a city or municipality is allocated more funds than the county, while the county bears more than 50 percent of the costs associated with prosecution or incarceration of the municipality's Part 1 violent crimes; and

WHEREAS; approval of the proposed funding and a Memorandum of Understanding (MOU), executed by the participating jurisdiction's is required from all disparate applicants; and

WHEREAS; in accordance with the JAG Program disparate grant formula, the participating jurisdictions agree it is in their best interests to reallocate the \$209,245 in JAG funds to the Greensboro Police Department (\$113,616); Guilford County Sheriff's Department (\$53,206); and the High Point Police Department (\$42,423).

WHEREAS, the Federal Transportation Administrator has been delegated authority to award Federal financial assistance for a transportation project; and

WHEREAS, the grant or cooperative agreement for Federal financial assistance will impose certain obligations upon the City of Greensboro, and may require the City of Greensboro to provide the local share of the project cost; and

WHEREAS, the City of Greensboro has or will provide all annual certifications and assurances to the Federal Transit Administration required for the project.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That the City Manager is authorized to execute and file an application for Federal assistance on behalf of the City of Greensboro with the Federal Transit Administration for Federal assistance authorized by 49 U.S.C. chapter 53, Title 23, United States Code, or other Federal statutes authorizing a project administered by the Federal Transit Administration. The City of Greensboro is the Designated Recipient as defined by 49 U.S.C. § 5307(a)(2).

That the City Manager is authorized to execute and file with its applications the annual certifications and assurances and other documents the Federal Transportation Administration requires before awarding a Federal assistance grant or cooperative agreement.

That the City Manager is authorized to execute grant and cooperative agreements with the Federal Transit Administration on behalf of the City of Greensboro.

Mayor Vaughan stated the item had been withdrawn by the applicant.

City Attorney Carruthers explained the process of the withdrawal; and read the withdrawal letter into the record.

Mayor Pro-Tem Johnson asked for clarification on the provider that had been awarded the contract; and spoke to complaints that had been received from transit riders.

City Attorney Carruthers confirmed Keolis Transit Services as the new provider.

Councilmember Hightower spoke to citizen and employee concerns; to innovative ideas; to change; the need for job

security for current employees; and to employee pensions.

City Attorney Carruthers stated Keolis representatives were present if needed; and recognized Deputy City Attorney James Dickens.

Councilmember Hightower requested to hear from the company representatives; spoke to budgetary concerns; voiced the need for drivers that were familiar with bus routes; and spoke to the minority workforce.

Deputy City Attorney Dickens highlighted Federal laws that offered protection for Union workers; spoke to the process for filling job vacancies; to working with current employees; outlined terms of vacation policies; spoke to job qualifications; to turn-over for non-Union positions; and to the Keolis management team.

Francis Wood, Keolis Vice President for Human Resources stated for the record that the company had operations on the east coast; spoke to the history of hiring 98% of workforce in previous transitions; to driving credentials; and to background checks.

Councilmember Hightower inquired about driving requirements.

Mayor Vaughan explained being a second chance City; and requested Keolis have a second chance attitude.

Ms. Wood stated requirements were mandated by the Division of Transportation; spoke to safety records; to being concerned and sensitive to employees; and to providing opportunities.

Deputy City Attorney Dickens outlined an approximate 90 day transition period; and confirmed the effective date of the contract as January 1, 2019.

Councilmember Hightower asked if transportation services would be impacted; and reiterated her workforce concerns.

Public Transit Manager Bruce Adams spoke to a smooth transition; confirmed he would provide oversight during the transition; and verified there would be a minimal impact.

242-18 RESOLUTION AWARDING SERVICE CONTRACT TO KEOLIS TRANSIT SERVICES, LLC FOR THE MANAGEMENT AND OPERATIONS OF TRANSIT SERVICES PROVIDED BY THE GREENSBORO TRANSIT AUTHORITY EFFECTIVE JANUARY 1, 2019 – JUNE 30, 2022 WITH TWO ONE YEAR OPTIONS TO RENEW

WHEREAS, City Council rescinded Council Resolution 17-0630 awarding the service contract for the management and operations of transit services provided by GTA to Transdev Services, Inc. on December 19, 2017; and,

WHEREAS, the City/GTA initiated an Addendum to the Request for Proposal (RFP) process for the service contract for the management and operations of transit services provided by GTA on April 2, 2018, with the term of the new contract period beginning January 1, 2019 and ending June 30, 2022, with two one year options; and,

WHEREAS, the RFP called for a "full service" contract, in which the contractor would manage, train and supervise the GTA contracted employees; operate and maintain the vehicles; provide dispatch services; staff the customer service call center; provide the ADA paratransit reservations services; maintain the transit amenities and facilities; and other tasks necessary to operate the GTA transit system. The RFP indicated that the work performed under the contract would be paid on an hourly rate per revenue hour for Fixed Route and HEAT transit services, and by a rate per ADA Paratransit trip; and,

WHEREAS, the RFP process was conducted in full compliance with the FTA Circular 4220.1F requirements for 'Third Party Contracting'; and,

WHEREAS, each proposer submitted updated Price Proposals and Management Team Proposals, to be evaluated and scored, based on a weighted point system; and,

WHEREAS, a reconstituted Evaluation and Selection Committee (Committee) was established that consisted of seven (7) members plus one (1) alternate, including representatives from the GTA Board, Transportation Departments, PART, City of High Point, City of Winston-Salem, and the local ADA advocacy community; and,

WHEREAS, the proposers' Proposed Management Team and Price Proposals were received by the City/GTA on May 24, 2018, and the City received proposals from First Transit, Inc., Keolis Transit Services, LLC and the incumbent contractor Transdev Services Inc.; and,

WHEREAS, on June 6, 2018, the Evaluation and Selection Committee met to evaluate all proposals. Prior to these meetings, each committee member performed individual assessments of the proposals, and at these meetings, they discussed their individual assessments; and,

WHEREAS, the Committee conducted oral interviews with the three proposers on June 21, 2018 in order to address questions and deficiencies in their proposals; and,

WHEREAS, The City/GTA received the Best and Final Offers (BAFOs) on June 29, 2018; and,

WHEREAS, the Committee, pursuant to the RFP, focused on "Best Value" rather than low bid, and evaluated the proposed costs in relation to the quality and level of service provided. The qualifications of the proposers and the proposed staffing levels, the proposed operating methodology, and the proposed cost component were considered in evaluating cost effectiveness; and,

WHEREAS, following the review by the Committee of the Management Team and Price Proposals, Interviews, and BAFOs, the seven (7) committee members and one (1) alternate, in a secret ballot, rated each proposal by the individual criteria of the RFP; and,

WHEREAS, after reviewing the total weighted scores, the Committee agreed unanimously that the scoring reflected their consensus of the most advantageous proposal for the City of Greensboro; and,

WHEREAS, at the August 2, 2018 GTA Board meeting, the GTA Board approved recommending to City Council, to award the contract for the Management and Operation of Transit Services provided by GTA to Keolis Transit Services, LLC.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That the City Manager is authorized to enter into a contract Awarding Service Contract To Keolis Transit Services, LLC For The Management And Operations Of Transit Services Provided By The Greensboro Transit Authority effective January 1, 2019 – June 30, 2022 with two one year options to renew.

18-119 ORDINANCE TO AMEND CHAPTER 12 OF THE GREENSBORO CODE OF ORDINANCES WITH RESPECT TO HUMAN RELATIONS

Section 1. Chapter 12, Article II, Sec. 12-22 shall be amended to read as follows:

ARTICLE II. - COMMISSION ON HUMAN RELATIONS[2]

Sec. 12-22. - Membership.

The commission on human relations shall be composed of nine (9) members who shall be appointed by the city council for terms to expire on August 15. All members of the commission shall be bona fide adults maintaining a permanent residence inside the corporate limits of the city. The terms of office of the members of the commission shall be three (3) years.

(Code 1961, §§ 2-253, 2-254; Ord. No. 89-119, § 1, 8-31-89)

Section 2. That all sections not amended herein shall remain in full force and effect.

Section 3. This ordinance shall become effective upon adoption.

Moved by Councilmember Hoffmann, seconded by Councilmember Hightower to appoint James D. Gaylon, Jr. to the Greensboro Transit Authority. The motion carried by voice vote.

Councilmember Hoffmann spoke to a rescheduled event to review the draft Arts Master Plan at Union Square tomorrow; and to an interactive presentation.

Councilmember Kennedy spoke to a previous appointment of Heidi Fleshman to the Minimum Housing Commission as an At-Large alternate position; referenced conversations with Mayor Pro-Tem Johnson; and spoke to the decision to move Ms. Fleshman to the At-Large regular position. Councilmember Kennedy highlighted the start of the

Greensboro Criminal Justice Advisory Commission (GCJAC); spoke to the work done during the recent hurricane and bad weather; voiced appreciation to staff; and spoke to the number of sheltered residents during the event.

Mayor Vaughan acknowledged the work of staff transitioning from the North Carolina Folk Festival (Folk Festival) to hurricane preparedness and relief; and voiced appreciation of staff for work during the fun times as well as a time of crisis.

Discussion took place regarding flooding at the Interactive Resource Center, and appreciation to Good Will Industries for providing vouchers to displaced persons.

Councilmember Wells placed the name of Joanna Cockburn into the databank for future use on a Board or Commission; spoke to the 20th Anniversary of East Greensboro NOW; highlighted the Invest East initiative; spoke to the ribbon cutting for a new student center at North Carolina Agricultural and Technical State University (A & T); highlighted events and activities at City Libraries; a ground breaking at PrintWorks; community forums to be held at the Renaissance Co-Op; and to Parks and Recreation receiving a National grant.

Mayor Pro-Tem Johnson echoed comments regarding the A & T student center; East Greensboro NOW; recognized members of the organization; highlighted the recognition of what had been accomplished over the past 20 years; and spoke to attending an event for Sleep Out for Homelessness.

Councilmember Abuzuaiter placed the name of Susan Phillips into the databank; and requested the consent of Council to make the appointment.

It was the consent of Council to suspend the rule for making appointments to Boards and Commissions.

Moved by Councilmember Abuzuaiter, seconded by Mayor Pro-Tem Johnson to appoint Susan Phillips to the Community Sustainability Commission. The motion carried by voice vote. Councilmember Abuzuaiter recognized Guilford County and the City of Greensboro CrimeStoppers for awards received; commented on the success of the Folk Festival; highlighted an event for Operation Life Saver; and spoke to the need for a reduction in railway deaths.

Councilmember Outling provided an update on the Comprehensive Long Range Plan; announced the kickoff event scheduled at Center City Park on October 5th; congratulated Folk Festival partners; and commended Councilmember Abuzuaiter for volunteering.

Councilmember Thurm highlighted the Wyndham Championship; spoke to the event being an economic driver; to the Folk Festival; voiced appreciation to the Fire Department working in the eastern part of the state after the hurricane; and stated Pride Day had been rescheduled to October 21st.

Councilmember Hightower inquired about the Black Television Network (BNT) lawsuit; requested an update on the involvement of the Civil Emergency Unit (CEU) at Chapel Hill incident on August 30th; and requested information regarding statistics for traffic stops.

City Attorney Carruthers confirmed staff had provided an amended answer to the BNT lawsuit; spoke to the ongoing discovery for the case; and to a meeting scheduled in mid-October.

Assistant City Manager Harris confirmed information would be provided for CEU and traffic stops.

Councilmember Hightower spoke to the closing of the hurricane relief shelters; voiced appreciation for the assistance provided by the Salvation Army; to Good Will Industries for contributions during the disaster relief; highlighted the student center at A & T; referenced Minority/Women Business Enterprise goals; spoke to the East Greensboro NOW meeting and the Invest East initiative; and referenced the Paint the Town event that targeted assistance for the April tornado sites.

Moved by Mayor Pro-Tem Johnson, seconded by Councilmember Hightower that the City Council adjourn to a

closed session pursuant to North Carolina General Statutes Chapter 143, Section 318.11 in order to: prevent the disclosure of information that is confidential pursuant to North Carolina General Statutes Chapter 160A, Section 168; establish the amount of compensation and other material terms of an employment contract; and to consider the qualifications, competence, performance, character, fitness, and conditions of employment of a public employee.

Council recessed to closed session at 6:39 p.m. Council reconvened into open session at 8:11 p.m. with all members in attendance.

Moved by Councilmember Kennedy, seconded by Councilmember Hightower to return to open session. The motion carried by voice vote.

**Adjournment**

Moved by Councilmember Abuzuaiter, seconded by Councilmember Kennedy, to adjourn the meeting. The motion carried by voice vote.
