- \* The first meeting of the month will allow for 30 minutes of speakers from the floor, ceremonial/presentational items, consent items, time sensitive business items, and any remaining speakers from the floor. Speakers will be grouped together according to topic. The second meeting of the month will consist of consent items, public hearings, and business items; public comments must be associated with agenda items and will be limited to three (3) minutes. Council reserves the right to change the format of the meeting. A Closed session may be held at this meeting.
- \* All attendees are to conduct themselves in a civil and respectful manner at all times. Any disruption of the meeting will not be tolerated. If this occurs, the person will be identified and asked to stop. If the behavior continues, they will be removed from the Council meeting.
- \* The zoning application hearing process allows proponents and opponents a total of fifteen (15) minutes notwithstanding the number of persons desiring to be heard. Proponents shall be heard first followed by comments from opponents. Each side may speak a total of five (5) minutes rebuttal.
- \* The next regular City Council meeting will be held on Tuesday, April 7, 2020 at 5:30 p.m. in the Council Chamber of the MMOB.
