TO THE CITY COUNCIL OF THE CITY OF GREENSBORO:

The undersigned, being the owners of (all) majority (circle one) of the property abutting the street named below, or portion of street, request that said street, or portion of street, be permanently closed and abandoned as a public street. The street, or portion of street, being as follows:

The westernmost +/- 260 feet of the 50-foot wide Walker Avenue right-of-way west of Tate Street shall be permanently closed and abandoned as a public street, become State property allocated to UNC Greensboro, and combined with Guilford County parcel number 9325. The City of Greensboro shall retain public access utility and drainage easements as shown on the attached preliminary plat (Exhibit A) and further described on Exhibit B.

The undersigned believes that the closing and abandonment of the above described street, or portion of street, is not contrary to the public interest, and no individual or other party, owning property in the vicinity of the street, or in the subdivision in which the street is located, will be deprived of reasonable means of ingress or egress to his or its property.
