## Meeting Minutes - Final Infrastructure Committee

Thursday, November 12, 2015

### Call to Order

This Infrastructure Committee meeting of the City of Greensboro was called to order at 3:30 p.m. on the above date in the Council Chamber of the Melvin Municipal Office Building with the following members present:

### Council Procedure for Conduct of the Meeting

Councilmember Outling explained the Council procedure for conduct of the meeting.

Moved by Councilmember Abuzuaiter, seconded by Councilmember Fox to excuse Councilmember Hoffmann from the meeting. The motion carried by voice vote.

## **III. INFORMATIONAL ITEMS**

Assistant City Manager Parrish stated Items #17 - #23 were informational items; there were no controversies regarding the annexations; and spoke to providing additional information for the committee as needed.

Councilmember Fox asked if staff had heard anything from the community regarding the annexation.

Planning Director Sue Schwartz spoke to conversations regarding the street name change; public safety interest; and stated the annexation had been requested by the property owner.

Assistant City Manager Parrish referenced previous discussions at a Work Session prior to the Committee Structure; stated ReCommunity had been a long time partner; spoke to the restructuring of the contract; stated staff recommended the item; and recognized Field Operations Director Dale Wyrick to present the item.

Mr. Wyrick spoke to the proposed deal; and recognized ReCommunity President and CEO Shawn Duffy to address the current state of the recycling industry.

Mr. Duffy made a PowerPoint Presentation (PPP); spoke to the distress of the recycling markets; recycling companies asking to renegotiate contracts; provided information on volume and weight; spoke to equipment challenges; the cost of recycling; material-average commodity revenue; outlined industry quotes from Forbes and the Washington Post; and to a long standing relationship with Greensboro.

Mr. Wyrick continued the PPP; outlined Greensboro's current contract for recycling; spoke to the expiration of the

contract in April 2018; stated ReCommunity currently lost approximately \$1.5 million annually; spoke to a proposed agreement to be effective January 1, 2016; reduction of cost per ton; outlined options for 2018 through 2020; stated the City would be responsible for disposal of non-recyclables; ReCommunity would continue to collect ABC glass at market rate; and spoke to revenue impacts.

Councilmember Abuzuaiter left the meeting at 3:44 p.m. and returned at 3:46 p.m.

Mr. Wyrick outlined the current agreement versus the proposed agreement; revenue impacts; and voiced the compromise would provide financial relief to ReCommunity to allow continued service.

Discussion took place regarding the contract effective date; negotiation specifics; an option to push back to 2017; long term security for the City; providing relief for ReCommunity; the history of charges; the City's responsibility to collecting non-recyclables; contamination rates; and the recommendation of staff.

Assistant City Manager Parrish stated the item would be presented at a future Council meeting.

Assistant City Manager Parrish provided an image of the poster; spoke to discussions at a previous Committee meeting; the community indicators; to updating the poster as information changed; and to reminders of City services.

Ms. Schwartz spoke to the color schemes; display locations for the poster; and swapping out data as needed.

Councilmember Abuzuaiter asked if the poster was complete or in draft form; inquired about the differences in water lines and sewer lines; and asked to include information regarding tax rates to show Parks and Recreation and the Libraries Departments.

Ms. Schwartz confirmed the poster was complete; spoke to the facts provided; highlighted the population figures; spoke to a useful tool; and to citizens paying for Parks & Recreation and Library services.

Assistant City Manager Parrish spoke to the breakdown of tax rates; and to areas that the City provided only water service and areas that only received sewer services.

Councilmember Fox voiced appreciation to staff for the item; requested the poster be displayed in all City facilities; and to include the information with water bills, with the City and County Academy information, and for it to be posted in the Manager's Office.

A copy of the document is filed in Exhibit Drawer X, Exhibit No.31 which is hereby referred to and made a part of these minutes.

## Matters to be discussed by the Committee Members

Councilmember Fox requested staff to provide an update on the landfill; on the White Street project; and on the Urban Farms project.

Assistant City Manager Parrish confirmed staff would be providing updates as requested.

Councilmember Outling requested an update on the scheme the City used to address properties Downtown.

Assistant City Manager Parrish stated the item had been delayed in order for Councilmember Hoffmann to be present.
