**SUBJECT:** Townsend WTP Basin and Filter Improvements Project Contract #2011-066B

The M/WBE Office reviewed the documentation submitted by HDR Constructors, Inc., CMAR for the Townsend WTP Basin and Filter Improvements Project to determine compliance with the City of Greensboro's M/WBE Plan. The contract goals established for the project were MBE 8% and WBE 7%; both goals were achieved.

HDR proposed to commit 8.02% or \$1,496,137 to MBE firms and 13.01% or \$2,428,070 to WBE firms.

HDR has agreed to meet its M/WBE commitment utilizing the following 1<sup>st</sup> and 2<sup>nd</sup> tier certified firms:
