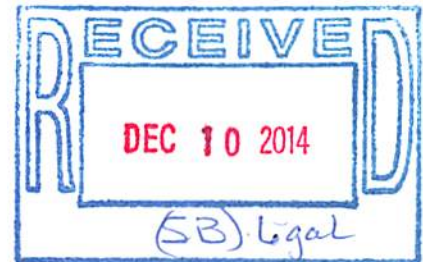

Dear Mayor Vaughan:

This law office is now representing the City taxpayers identified in Exhibit A hereto in connection with their demands for refunds pursuant to N.C.G.S. § 105-381, in whole or in part, of City property taxes paid for their Cardinal Manor addresses for tax years 2013, 2012, 2011, 2010 and 2009.

As you are obviously aware, in the fall of 2007 the City initiated action to annex these residential properties (annexation zone 2008-12), which annexations became effective on June 30, 2008. Since that date, our clients have dutifully paid their full schedule of City property taxes. The City, on the other hand, has not provided our clients the full City services due them in consideration of those taxes, including street maintenance, street lighting, snow and ice removal, garbage and trash collection, loose leaf collection and sewer line maintenance.

In the fall of 2007, numerous Cardinal Manor residents and their then-existing leadership attended the City Council hearings at which the annexation was discussed as well as the statutorily required public information meetings relating to the annexation. At these meetings, City Staff informed these property owners that they would not be receiving many City services, including garbage collection, sewer and water line maintenance, street lighting, road maintenance, snow and ice removal and loose leaf collection.

In response to this information, and prior to the favorable City Council vote on the annexation on November 20, 2007, Cardinal Manor residents collectively submitted to Mayor

Keith Holliday their November 15, 2007 letter expressing their concerns over the lack of services despite taxation and a petition opposing annexation in the event the City elected to not provide the required City services. A copy of this letter and petition are attached as Exhibit B. Our clients did not oppose annexation. They only requested the City services for which they would soon be paying.

This letter and the accompanying petition apparently fell on deaf ears. To the best of our information and knowledge, the City did not address, consider or in any manner act upon this letter or petition. We are unaware of any record or Council minutes reflecting that the letter, petition and our clients' concerns had been considered or, for that matter, ever presented to full Council for consideration and discussion. It is indeed possible that Council, as then constituted, voted favorably on the subject annexation petition, and the resulting taxes, without knowing or being made aware of the fact that Cardinal Manor property owners would be paying full City taxes while at the same time being denied the City services being provided to other property owners in their annexation zone. This is plainly a denial of their right to due process.


Again, and as in 2007, our clients are not challenging the annexation. However, we do believe the subject taxes are unlawful within the meaning of N.C.G.S. § 105-381 in that our clients were and still are being treated differently than other taxpayer citizens who became part of the City as a result of the 2008-12 annexation. For example, we are aware that certain sections of the Carlson Farms neighborhood were excluded from the annexation because the City determined that, due to terrain, it would be too costly for the City to install the water lines necessary for providing City water services. In Cardinal Manor, however, when Staff learned that Cardinal Manor streets were below City standards, Staff told Cardinal Manor that *it* would be required to bear the costs of the necessary repairs upgrades before the City would begin providing street maintenance. This is unfair and unequal treatment that has resulted in the unlawful imposition and collection of City taxes. If the prohibitive cost of providing water to certain sections of Carlson Farm warranted exclusion of those property owners from annexation so too should have the costs of street repairs warranted exclusion of Cardinal Manor from annexation.

It is our also our understanding that the City is providing full City services, including garbage collection, street lighting, snow and ice removal and loose leaf collection to other taxpayers in that annexation zone while at the same time, and without any reasonable or rationale basis or justification, refusing to provide certain of those services to Cardinal Manor property owners. We view this to be disparate treatment that renders the City taxes constitutionally unlawful, an illegal tax and an unjust enrichment to the City, among other things.

Demand is now respectfully made for an appropriate refund of these taxes and a change in either services policy or tax rates, or some combination thereof, moving forward. I appreciate the City's consideration of this request and I look forward to receiving the City's response within the time allowed under N.C.G.S. § 105-381. My clients will also appreciate the City's prompt and public statement of the reasons the City believes support its decision to not provide Cardinal Manor property owners with the services for which they are paying.

Dear Mr. Mayor and Council Members:

Many of our residents have attended the recent annexation meetings of October 25th and the two Council meetings culminating with the one on November 5th. We have met and talked with members of the city staff concerning the services we may receive from the city, if annexation is approved by the City Council. Many of the services afforded other city residents are not included for our residents.


We understand from these meetings that the city services Cardinal Manor residents will NOT receive are: (1) Maintenance of all sewer lines and most water lines. (2) Maintenance of street lights and payment of electric bills for same. (3) Adequate trash pickup from dumpsters for the town homes. (4) Only possible partial maintenance of two of our streets, depending on the composition/construction of these streets. (5) Snow and ice removal from the streets in Winter. If we are annexed, we will have to pay for these same services in addition to city taxes, even if they are not provided by the city.

We have excellent response from the Sheriff's Department and from Fire and EMS, even though we realize these city services are excellent too.

If we were to receive all of the services from the city that are afforded to other city residents, then we could not object to being annexed into the city of Greensboro. However, based on the items listed above, we are submitting the enclosed petition, signed by Cardinal Manor residents requesting that the City Council of Greensboro NOT include the Cardinal Manor neighborhood in the current annexation plan.

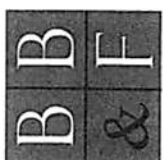
