# Meeting Minutes - Final Infrastructure Committee

# **III. INFORMATIONAL ITEMS**

**18.** <u>ID 16-0093</u> Ordinance Rezoning Property Located at 4803, 4807 Hardindale Drive & 635 Muirs Chapel Road

Councilmember Hoffmann stated the rezoning item would be presented to Council on February 16th; and stated the item was for informational purposes only.

#### **19.** ID 16-0099 Status Report: Sustainability Action Plan

Community Planning Manager Hannah Cockburn provided a history of the Sustainability Action Plan; made a PowerPoint Presentation; outlined eight areas; highlighted implementation action items; spoke to the completion of items; continued revisions; successes of the plan; the next steps; new initiatives including Smart Cities Challenges and Solar Road Maps; enhancement of online information; establishing a green practices recognition program; referenced a handout provided to Committee members; and recognized members of the Sustainability Community in attendance.

Discussion took place regarding the Green Team program; energy savings for the City; outreach to neighborhood associations; the Better Buildings program; and previous rebates for green installations.

Councilmember Fox requested staff to research working with North Carolina State A & T University for the Better Buildings program; and to research the use of the Combined Federal Campaign.

Councilmember Hoffmann acknowledged Community Sustainability Council members; spoke to the history of the Committee; referenced a meeting at Ashway and reporting what the City had done; and voiced excitement for the increase in square footage and the decrease in cost.

# **20.** ID 16-0122 Presentation - Greensboro Zoning Process (Zoning 101)

Planning Director, Mike Kirkman spoke to Council's request for a zoning process update; stated a presentation had been given to the Neighborhood Congress; made a PowerPoint Presentation; outlined zoning regulations; outlined the three types of zonings; spoke to quasi judicial hearings associated with the special use permit; explained the zoning and application process; and reviews by the Zoning Commission. Mr. Kirkman highlighted the process for staff review and analysis; spoke to site visits; staff reports; impacts on adjacent properties; outlined the public notification process; reviewed state law requirements; spoke to the distribution list used for notices; and stated notices were posted to the website. Mr. Kirkman explained the use of the PeaceMaker for advertising; spoke to zoning hearings; commission and staff recommendations; outlined the appeals process; spoke to engaging the community; and the availability of zoning ordinances online.

Discussion took place regarding citizens contacting Councilmembers; staff limitations due to state regulations; providing earlier notices; and adjusting application deadlines.

Councilmember Outling requested information on procedures used by other municipalities; inquired if staff could send additional notices prior to the 10 - 25 day regulation; requested staff research what would constitute reasonable action; cost to the City; and the use of social media for notifications.

City Attorney Tom Carruthers confirmed the City would have to incur the cost associated with the additional notice; and that staff would research the matter.

Discussion took place regarding the use of the PeaceMaker; and the requirements of the North Carolina General Statues.

Councilmember Abuzuaiter recognized Triad Real Estate and Building Industry Coalition (TREBIC) President, Marlene Sanford to speak to the item.

Ms. Sanford spoke to contributions to the zoning process by TREBIC; public meetings and deadlines; explained conditional zonings; the quasi judicial process; spoke to a fair process; referenced previous conversations encouraging communications with neighbors; stated the majority of rezonings were not controversial; spoke to the cost associated with the appeals process; and to working together as a community.

Council requested staff to make the presentation at a future City Council meeting.
