OPINION OF COUNSEL

With respect to Schedule A #24079 dated December, _____, 2016 to that certain Equipment Lease Agreement # 23036 dated 3/31/2011 by and between Motorola Solutions, Inc. and the Lessee, I am of the opinion that: (i) the Lessee is a state or a fully constituted political subdivision or agency of the State of the Equipment Location described in Schedule A hereto; (ii) the execution, delivery and performance by the Lessee of the Lease have been duly authorized by all necessary action on the part of the Lessee, (III) the Lease constitutes a legal, valid and binding obligation of the Lessee enforceable in accordance with its terms; and (iv) Lessee has sufficient monies available to make all payments required to be paid under the Lease during the fiscal year this the Lease is adopted, and such monies have been properly budgeted and appropriated for this purpose in accordance with State law.

It is also my opinion that N.C.G.S. 159-148 does not apply to this transaction. This lease contains a "non appropriation clause" that allows the local government to cancel the contract and is not therefore expressly or impliedly obligated to exercise its powers to levy taxes. See 159-148(a)(4).

In addition this is not a lease of a capital asset; this is a lease of rapidly depreciating high tech dispatch console communication device.

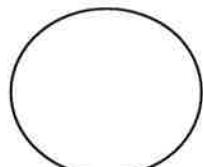

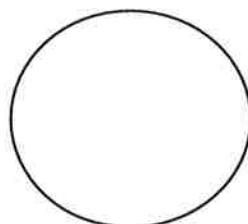
