AMENDING CHAPTER 30 (LDO) AN ORDINANCE AMENDING THE GREENSBORO CODE OF ORDINANCES WITH RESPECT TO ZONING, PLANNING AND DEVELOPMENT

Section 1. That Section 30-15-6, Terms Beginning with "E," is hereby amended by inserting a new definition for "Electronic Sweepstakes Operations" within alphabetical order and to read as follows:

Electronic Sweepstakes Operations

Any business enterprise, whether as a principal or accessory use, where persons utilize electronic machines, including but not limited to, computers or other electronic terminals (collectively the "electronic sweepstakes machines"), to reveal the content of a sweepstakes entry, whether by a simulated electronic game or otherwise, and where cash, merchandise, or other items of value are redeemed or otherwise distributed at the location where the electronic sweepstakes operation is conducted, whether or not the value of such distribution is determined by electronic games played or by predetermined odds. Electronic sweepstakes operations shall not include any lottery approved by the state of North Carolina or any nonprofit operation that is otherwise lawful under state law (for example church or civic organization fundraisers).

Section 2. That Section 30-8-10.3, Recreational Uses, is hereby amended by adding a new subsection "L" to read as follows:

L. Electronic Sweepstakes Operations


1. Establishment Separation

No such establishment may be located within 200 feet of property containing a place of religious assembly, an elementary or secondary school, a public park, a residence or a lot that is residentially zoned;

2. Use Separation

No such establishment may be located within 1,000 feet of any other Electronic Sweepstakes Operations establishment; and

3. An accessory use containing 2 or fewer machines shall not be subject to the separation requirements contained in subsections 1. or 2. above.



Section 3. That the "Indoor Recreation" Use Category and the "Accessory Use and Structure Category" within Section 30-8-1 and Table 8-1, Permitted Use Table, is hereby amended to read as follows:

Section 4. That Subsection (A) of Section 30-8-7.2, Indoor Recreation, is hereby amended to read as follows:

A. Typical Use Types

- 1. Bingo hall, billiard parlor, bowling alley, game arcade, skating rink
- 2. Club and lodge
- 3. Coin operated amusement
- 4. Dance school
- 5. Electronic Sweepstakes Operations
- 5 <u>6</u>. Fortune teller, palm reader, astrologer

- 6-7. Movie and other theaters
- 7–8. Physical fitness center
- <u>8-9</u>. Shooting range
- $9 \underline{10}$. Sports instructional school, gymnastic facility, martial arts academy

Section 5.All ordinances in conflict with the provisions of this ordinance are repealed to the extent of such conflict.

Section 6. This ordinance shall become effective upon date of adoption.
