

City of Greensboro Audit Committee Meeting March 26, 2015 3PM



- City has history of long relationships with selected auditor
 - A.M. Pullen from 1963 1982 (19 years)
 - Deloitte & Touche from 1983 1994 (12 years)
 - Cherry Bekaert from 1995 2014 (20 years, with partner rotations)
- 5 Year Audit Request for Proposal (RFP) cycle implemented in 1983
 - Initial Term of 3 years with (2) one-year extensions
 - Consistent with City's Service Contract Policy
 - Additional extensions with approval of CMO or Audit Committee, (established in October 2010) followed by approval of full governing board
 - RFP Conducted in 1983, 1988, 1995, 2000, 2006, 2015



- Since 1990's, large national firms in NC are moving away from governmental audit practice
- Regional firms are strengthening their government presence
 - More representation on govt. standard-setting and other boards
 - Specialized staffing in more than one office
 - Provide governmental training opportunities to others
 - Built a significant client base
 - Pricing is very competitive
 - Less on-site work; more electronic file transfer and paperless workpapers
- Additional audit staff training requirements needed to work on a governmental audit
- LGC must approve all audit contracts
 - LGC accounting and financial reporting guidance; state statutes must also be followed by units

County audit fees are typically higher than City fees due to extensive audit work for social services and health-related grants



- Solicited proposals from NC firms with audit experience in governmental units with 100,000+ population centers
 - Also, sent RFP to NC firms who requested to be on City's bidder's list
 - Posted on City E-Procurement (Purchasing) Portal for further distribution
- Pre-Bid conference call was well-attended

Evaluation Score:

- Top 3 firms selected based on:
 - 60% govt. audit experience, staff qualifications, understanding of work to be performed, ability to provide consulting services and audit firm references
- Then, fee proposals opened for Top 3
 - 30% -- overall contract \$ fee, cost per hour, staffing levels for fee
- Best meets needs of City
 - 10%
- M/WBE Component; 20 additional points possible
 - Aspirational goal is 6% MBE and 5% WBE



- Experience auditing governments in North Carolina
 - Familiarity with NC laws and regulations
 - Ongoing relationship with LGC staff
- Similar complexity of financial issues as Greensboro

 Bond and investment transactions
- Extensive audit and consulting work for complex ERP

systems

- City uses Lawson (Infor) Financial and HR
- Number of audit hours proposed
- Partner rotation

- RFP Evaluation Committee is prepared to make audit contract recommendation at Audit Committee meeting
- If Audit Committee concurs, full City Council approval is scheduled for April 7 meeting
- Audit fieldwork would begin in late April-early May



- RFP Evaluation Committee recommends selecting McGladrey for an initial audit period of three (3) years beginning June 20, 2015
 - Two (2) annual extensions possible
- 5th Largest audit firm in U.S; 8,000 employees
- 114 government sector partners
- 700 governments audited, including 10 in NC
- 10% 15% MBE proposal
- Greensboro office location
- Familiar with Lawson financial/HR systems
- Pricing is less than FY14 fees, more audit hours proposed
