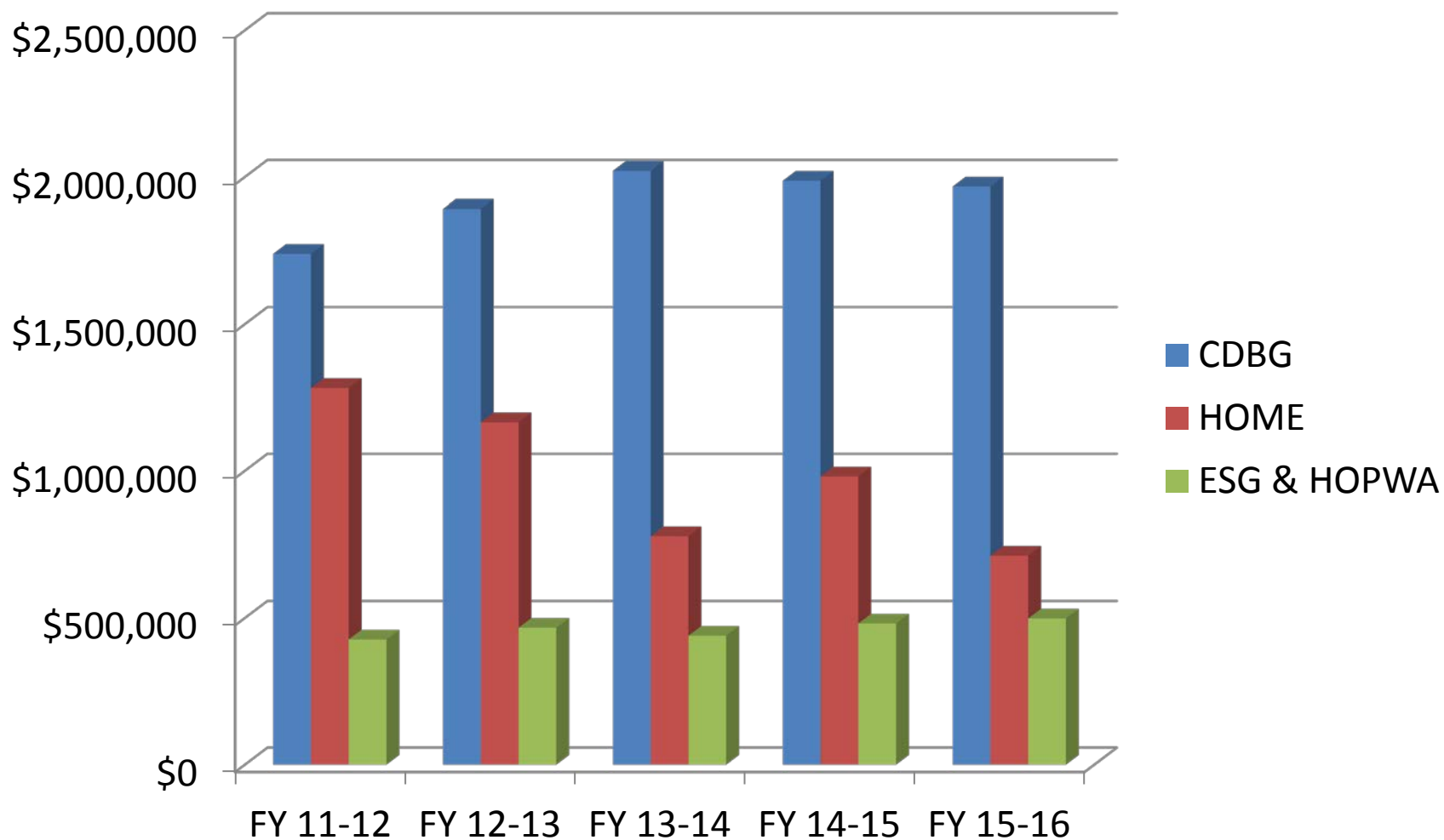
Home Investment Partnership Program (HOME).....\$710,534

Emergency Solutions Grant (ESG).....\$177,108



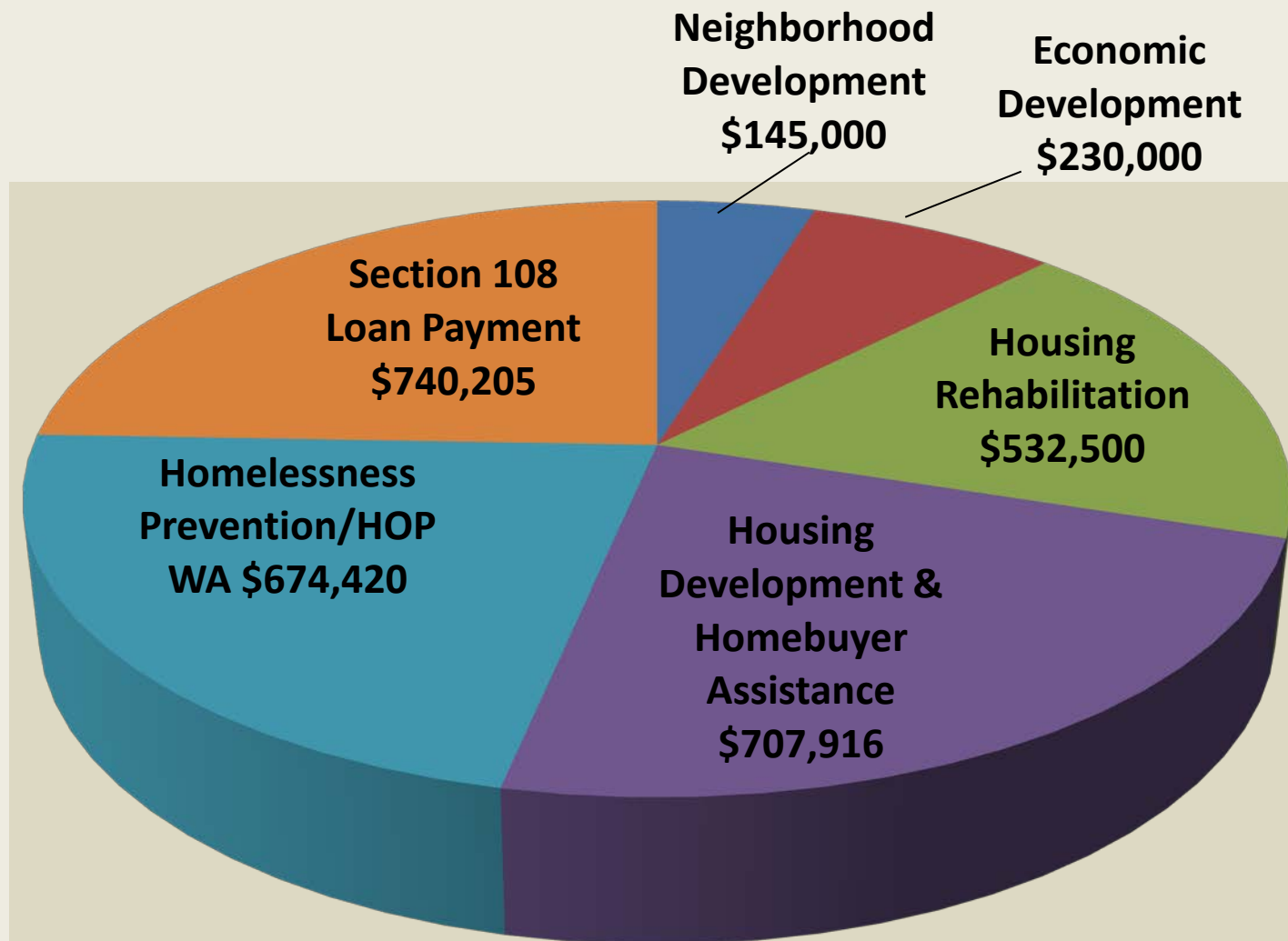
Federal HUD Funding Over the Years
