PURPOSE:

Annually, the City of Greensboro applies for FTA and NCDOT funding to support the City's public transportation program and the Greensboro Transit Authority. The City is required to hold a Public Hearing to inform the general public about the proposed operating, planning and capital projects and the estimated costs. The City Council is also required to adopt a resolution authorizing the filing and/or execution of subsequent grant agreements for the proposed projects.

BACKGROUND:

The City of Greensboro has developed a detailed Program of Projects recommended for funding under the Moving Ahead for Progress in the 21st Century Act (MAP-21) Legislation. These projects include the following: FTA Section 5307 Urban Area Formula Grant Program, Section 5303 Metropolitan Planning Program, Section 5310 Enhanced Mobility of Seniors an Individuals with Disabilities, Section 5339 Bus and Bus Facilities, Surface Transportation Program -Direct Apportionment, and Congestion Mitigation and Air Quality Improvement Program. In addition, the City will apply to the North Carolina Department of Transportation State Maintenance Assistance Program for funding. The Greensboro Transit Authority Board approved the GTA FFY 2014-2015 Program of Projects at its March 25, 2014 meeting.

1. Description of Projects - Section 5307 Urbanized Area Formula Grant-FFY 2014

a. The City of Greensboro is applying for Federal assistance to support up to 10% of the Total Net Operating Expenses of ADA-Complementary Paratransit Services. GTA SCAT service has continued to meet the increased demand for the service. The estimated total project costs are:

b. The City of Greensboro is applying for Federal assistance to support up to 80% of the preventive maintenance costs for the Greensboro Transit Authority (GTA). The estimated total project costs are:

More specifically, part of the funds will be used to conduct public transportation studies and plans in coordination with the MPO. These studies/plans will be used to assess system data in order to refine services and increase system efficiency, productivity and responsiveness to the community needs for Fixed Route, Paratransit and Flex Route Services. The other part will be used to conduct a Feasibility Study of Upgrades,

RESOLUTION AUTHORIZING THE FILING AND/OR EXECUTION, AS APPROPRIATE, OF FEDERAL TRANSIT ADMINISTRATION (FTA) AND NORTH CAROLINA DEPARTMENT OF TRANSPORTATION (NCDOT) GRANT AGREEMENTS, GRANT APPLICATIONS, ANNUAL OR BIENNIAL APPLICATIONS, ANNUAL BUDGETS, AND OTHER SUCH DOCUMENTS, AS APPROPRIATE, PURSUANT TO RELEVANT SECTIONS OF THE FEDERAL TRANSIT ADMINISTRATION MOVING AHEAD FOR PROGRESS IN THE 21ST CENTURY ACT (MAP-21), AS AMENDED

WHEREAS, the City of Greensboro and the North Carolina Department of Transportation will apply and receive grants from the U.S. Department of Transportation as authorized by Chapter 53 of Title 49, U.S.C. (Sections 5307 Urbanized Area Formula Grant, Section 5303 Planning Assistance and Section 5339 Bus and Bus Facility of the MAP-21, as amended to provide operating, capital and planning projects; and

WHEREAS, the Federal Transit Administration under the MAP-21, provides Federal funds to support public transportation services;

WHEREAS, the City of Greensboro and the North Carolina Department of Transportation will apply and receive grants from the U.S. Department of Transportation as authorized by the Federal Transit Administration;

WHEREAS, the purpose of these transportation funds is to provide grant monies to local agencies to support planning, operating and capital assistance projects and provision of public transportation services; and

WHEREAS, Article 2B of Chapter 136 of the North Carolina General Statutes and the Governor of North Carolina have designated the North Carolina Department of Transportation as the agency responsible for administering funds received through the Federal Transit Act of 1991 legislation; and

WHEREAS, the contracts for financial assistance will impose certain obligations upon the City of Greensboro, including the provision of the local project costs; and

WHEREAS, it is required by the U.S. Department of Transportation and the North Carolina Department of Transportation in accord with the provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of an application for assistance under the MAP-21, as amended, the City of Greensboro, as applicant, gives assurance that it will comply with Title IV of the Civil Rights Act of 1964 and other pertinent directives and the U.S. Department of Transportation and the North Carolina Department of Transportation requirements thereunder; and

WHEREAS, it is the goal of the City of Greensboro, as an applicant, that Disadvantaged Business Enterprises (DBEs) be utilized to the fullest extent possible in connection with the project, and that definitive procedures shall be established and administered by the City of Greensboro as applicant to ensure that DBEs shall have the maximum feasible opportunity to compete for contracts and purchase orders when procuring construction contracts, supplies, equipment contracts, or consultant or other services; and

WHEREAS, the City of Greensboro hereby assures and certifies that it will comply with the Federal Statutes, regulations, executive orders, the Section 5333(b) Labor Protection requirements, and all administrative requirements which relate to the applications made to and grants received from the Federal Transit Administration; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF GREENSBORO:

- 1. That the City of Greensboro is authorized to file and execute FTA and NCDOT Grant Agreements, Annual or Biennial Applications, Annual Budgets, and other such documents, as appropriate, on behalf of the City of Greensboro with the North Carolina Department of Transportation, to aid in the financing of public transportation services as described therein.
- 2. That the City of Greensboro is authorized to furnish such additional information as the Federal Transit Administration and the North Carolina Department of Transportation require in connection with such FTA and NCDOT Grant Agreements, Annual and Biennial Applications, Annual Budgets, and other such documents, as appropriate.
- 3. That the City of Greensboro is authorized to set forth and execute Disadvantaged Business Enterprise (DBE) policies and procedures in connection with all procurement needs associated with such FTA and NCDOT Grant Agreements, Annual and Biennial Applications, Annual Budgets, and other such documents, as appropriate.
- 4. That the City of Greensboro is authorized to execute grant agreements on behalf of the City of Greensboro with the Federal Transit Administration and the North Carolina Department of Transportation to aid in the financing and effectuating of the purposes of such FTA and NCDOT Grant Agreements, Annual and Biennial Applications, Annual Budgets, and other such documents, as appropriate.

Award Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities Program Fund and Concur with NCDOT's Intent to Fund Greensboro MPO Area Job Access Reverse Commute Projects

Background

The Coordinated Plan provides a framework for the MPO from which to award funding to projects using available human services public transportation funding. Such funding includes an annual allocation of federal Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities Program Funds as well as any remaining MAP-21 era Section 5316 Jobs Access & Reverse Commute funds or Section 5317 New Freedom funds that NCDOT and/or FTA may make available.

The MPO's Coordinated Human Services Transportation Plan (Coordinated Plan) has been updated to include funding eligibility for non-profit organizations. The Plan has also been updated in terms of the needs assessment, the profile of existing services, the project selection criteria, and the list of eligible projects from which funding awards may be made. Additionally, text was added to the plan to specifically enable it to serve as the framework for selecting projects for any remaining MAP-21 era Section 5316 Jobs Access & Reverse Commute funds or Section 5317 New Freedom funds that NCDOT and/or FTA may make available. The reason for this last change is the fact that this year the North Carolina Department of Transportation (NCDOT) allowed the MPO to solicit projects and provide recommended funding requests for left over SAFETEA-LU era Section 5316 JARC Funds lapsing at the end of Federal Fiscal Year September 30, 2014. Concurrent with Coordinated Plan development the MPO also conducted a *Call for Projects* and a project evaluation and ranking process. This process was used to identify recommendations for approval by the MPO (Section 5310), as well as by the NCDOT (Section 5316).

Therefore, two MPO actions are needed at this time: action to direct available Section 5310 funds to area projects consistent with the Coordinated Plan and the project evaluation process and action to concur with NCDOT's direction of lapsing JARC funding consistent with the Coordinated Plan and the project evaluation process.

Program Background

The Section 5310 program supports projects that serve the special needs of transit-dependent populations beyond traditional public transportation service, exceed the requirements of the Americans with Disabilities Act (ADA) act, improve access to fixed route service and decrease reliance on complementary paratransit, and provide alternatives to public transportation. Projects that used to be funded through the New Freedom transit grant program may also be eligible for funding through Section 5310.

The Job Access and Reverse Commute program supports projects to improve access to employment and employment-related activities for people with lower incomes, including reverse-commute services. It is intended to develop transportation services to transport welfare recipients and low-income persons to and from jobs (Job Access); and to transport residents to suburban employment opportunities (Reverse Commute).

Funding Recommendations

MPO staff recommendation was developed in consideration of the application review process. The applications were evaluated using criteria from the Coordinated Human Services Transportation Plan. The review team included MPO staff and third party reviewers from the Winston Salem MPO. All proposed projects were deemed eligible.

The amount of JARC and Section 5310 funding requested exceeds the total amount currently available.

PURPOSE:

The Federal Transit Administration (FTA) has awarded grant funds under the Section 5310 Enhance Mobility for Seniors and Individuals with Disabilities Program to the Greensboro

Urban Area. The Section 5310 program supports projects that serve the special needs of transit dependent populations beyond traditional public transportation service, exceed the requirements of ADA act, improve access to fixed route service and decrease reliance of complementary Paratransit, and provide alternatives to public transportation. As the designated recipient for these funds, City Council approval is required to establish the grant project budget.

BACKGROUND:

After a competitive selection process, the Transportation Advisory Committee at the June 23, 2014 meeting awarded Section 5310 program funding to (1) the City of Greensboro Public Transportation Division/Greensboro Transit Authority, (2) Guilford County Transportation and Mobility Services (TAMS), and (3) the Senior Resource Center to support eligible operating expenses.

The City of Greensboro will use Section 5310 funding in the amount of \$168,161 to provide early morning dialysis trips during weekdays and Saturdays for seniors and individuals with disabilities who meet the program goal and when public transportation is insufficient, inappropriate, or unavailable. The City will also provide paratransit service beyond the normal, fixed-route service hours. In addition, as the designated recipient for Section 5310 funds, the City of Greensboro Public Transportation Division will utilize \$20,760 of the area allocation to support program administration costs, including administering the grant application and funding to the successful sub-recipients and ensuring that federal reporting requirements are met.

Guilford County TAMS will use Section 5310 funding in the amount of \$97,380 to provide transportation services for elderly individuals with disabilities and low income individuals that are on the waiting list to access transportation to employment, education, and medical trips.

The Senior Resource Center will use Section 5310 funding in the amount of \$40,500 to purchase a 15-20 passenger vehicle to provide round trip, door to door transportation for elderly refugees who participate in English for Speakers of Other Languages (ESOL) classes and other programmed activities at the Senior Center. The vehicle will also be used to provide quality of life/pharmacy/grocery shopping trips for seniors who participate in and attend the Community Nutrition sites located in the greater Greensboro area.

BUDGET IMPACT:

The City of Greensboro is required to provide a local match of 20% for the enhanced service. Funding for this project is as follows:
