# Meeting Minutes - Draft City Council

# **Call to Order**

This City Council meeting of the City of Greensboro was called to order at 5:30 p.m. on the above date in the Council Chamber of the Melvin Municipal Office Building with the following members present:

# **Moment of Silence**

The meeting opened with a moment of silence.

# Pledge of Allegiance to the Flag

Councilmember Wilkins recognized the American Language Academy attendees to lead the Pledge of Allegiance to the Flag.

Jill Wagner provided information on the Academy; recognized countries that were represented; and thanked Council for allowing the students to see government in action.

# **Recognition of Courier**

City Manager Westmoreland recognized Kiran Purswani of the Information Technology Department who served as the Courier for the meeting.

City Manager Westmoreland also recognized Khadara Jennings as Junior Courier who is a Sophomore at the Middle College at Greensboro Technical Community College; and provided an overview of Ms. Jennings' community involvement and accomplishments.

Councilmember Hightower spoke to the success of the summer Junior Courier program; and voiced her hope to continue the program after the school year began.

Mayor Vaughan thanked Councilmember Hightower for her participation in the program.

# 0247-15 RESOLUTION DECLARING THE MONTH OF AUGUST BLACK PHILANTHROPY MONTH

WHEREAS, Dr. Jacqueline Copeland-Carson of Pan-African Women's Philanthropy Network (formerly affiliated with AWDF USA) established the month of August as Black Philanthropy Month in 2011 with recognition by the United Nations as part of its Declaration of 2011 as the International Year for People of African Descent; and

WHEREAS, Black Philanthropy Month is an annual, global celebration of African-descent giving in all its forms; and

WHEREAS, the month-long observance invites all people of African ancestry and allied brothers and sisters to take August and beyond to promote the power of giving to transform lives; and

WHEREAS, Black communities have vested reasons to celebrate and renew their rich, shared traditions of giving, self-help, and innovation throughout the United States and the world; and

WHEREAS, an extraordinary legacy of philanthropy and ongoing achievement in philanthropy merit a concerted effort to lift up important stories, spotlight good work, educate the generations, and inspire giving; and

WHEREAS, understanding and generosity are instrumental to improving social, educational, economic and health outcomes in Black communities; and

WHEREAS, the citizens of Greensboro are asked to celebrate the cultural richness and philanthropic spirit of the community and to recognize the role generosity plays in ensuring a healthy, safe and prosperous community in which to live, work, and play during the month of August.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

# 2. ID 15-0683 BE Greensboro Employee Recognition

City Manager Westmoreland provided a brief history of the BE Greensboro program; spoke to employees that took extra steps, showed acts of kindness and made a impact across the City; reminded citizens they could still recommend employees for recognition; and recognized employees in attendance.

Mayor Vaughan stated the BE Greensboro program would be through August; and spoke to recognizing employees year round.

# **II. PUBLIC COMMENT PERIOD**

Congresswoman Alma Adams, 2109 Liberty Road addressed the minimum wage item; spoke to the ultimate goal of reaching \$15 per hour by the year 2020; elected leaders doing the right thing; provided percentages for people working below the poverty line; spoke to federal and state minimum wages; and stated people should not have to work multiple jobs. Congresswoman Adams continued by voicing she was proud of the Greensboro City Council; spoke to quality of life improvements; requested Council to protect the people of Greensboro; spoke to getting closer to a living wage; and thanked Council for their service.

Zac Engle, 403 Hammel Road stated he represented Synergy; advocated for young professionals; spoke to attracting Trader Joes to Greensboro; referenced the Friendly area property; spoke to a great economic impact, and to getting the word out that Greensboro wanted a Trader Joes.

Dr. Bill Blaylock, 209 West Bessemer Avenue stated he was the Director of Missions for Mercy; provided details for a dental clinic at the Coliseum on August 28th and 29th; spoke to the volunteers that would come to treat people; thanked City Manager Westmoreland and Coliseum Director Matt Brown for their assistance; provided history of previous clinics; and invited Council to attend.

Terry Power, 910 Merritt Drive spoke to art programs in Greensboro; free workshops for children and adults at the City Arts Drama Center; program benefits; extended an invitation to everyone to attend; and thanked Council for past support.

Greensboro Realtors Association President Kevin Green, 23 Oak Branch spoke to a solid real estate market; seeing positive signs; strong quarterly sales; referenced the recession and a bad economy; creating an environment where jobs were a priority; referenced the Wyndham and the upcoming Folk Festival; and people coming to Greensboro.

Kathryn Fields, 1906 Strathmore Drive, stated she was a student at George Washington University; provided a brief history of her life experiences in City arts; highlighted her theatre involvement; spoke to obtaining the Presidential Scholarship at George Washington; and how City Arts had changed her life.

Andre' Robinson, 4425 Lake Walk Drive provided a Brian Stevenson quote regarding poverty; spoke to a history of oppression; connecting City sectors; police accountability and transparency; attacks on the Civil Rights Museum; and referenced the Beloved Community Center.

Sherry Giles, 212 Tate Street spoke to a research project done with the Beloved Community Center; to police accountability; provided outcome percentages of the project; spoke to a lack of trust by residents; to a fair and transparent process; Council holding Police accountable; and to Greensboro serving as an example across the Country.

Toni Etheridge, 529-D College Road, Youth Active Organizer and concerned mother referenced statements made by previous speakers; spoke to justice and injustice; listening to black youth in the community; confrontations with the police; police accountability; and stated black lives did matter.

Councilmember Barber entered the meeting at 6:26 p.m.

Reverend Nelson Johnson, 2115 Murrayhill Road spoke to the importance of community safety and the welfare of citizens; increased wages; fair treatment by the police department; asked Council to take action; referenced a request regarding a shooting in 2014; spoke to access to video footage; and encouraged Council to be proactive.

Alan Ferguson, 4794 Troy Smith Road, Liberty and business owner at 314 North Church Street spoke to an update on the Mega site in Randolph county; provided Council with a handout for Nissan Motor Corporation; spoke to efforts to obtain a automobile company at the site; Nissan, Honda and Toyota being out of the running; and requested Council to consider how it would spend taxpayer dollars.

Mayor Vaughan referenced the financial commitments regarding water lines; and spoke to looking at other advanced manufacturers.

Michelle Kennedy, 806 Fairmont Street spoke to messages from the community to Council regarding police accountability; cases being reviewed; unarmed African Americans; revisions needed; exceptional policing; internal review process; safety and just treatment all of citizens; and requested clarification on the issue.

Mayor Pro-Tem Johnson asked Greensboro Police Chief Wayne Scott to address Ms. Kennedy's concerns.

Police Chief Scott spoke to reviewing actions of officer's regarding complaints; the code of conduct; investigation by the professional standards division; the overlap in criminal and internal investigations; and availability of the code of conduct to the community.

Mayor Vaughan asked for clarification on justified stops; and if professional standards would determine when a stop was justified.

City Manager Westmoreland referenced a letter sent in response to the Scales cases; the Citizens Review Committee's decision; spoke to the findings by the District Attorney; the authority of the City; and to the authority he had as Manager.

City Attorney Carruthers spoke to reasonable suspicion; the policy and procedures of the City; and the duty of Internal Affairs.

Police Chief Scott spoke to standard questions an investigator would ask; and to the code of conduct mirroring State law.

Reverend Johnson spoke to dropped charges; people deserving a clear answer; police profiling; and to officers that needed to be either terminated or retrained.

Mayor Vaughan voiced concern regarding the ability to view body worn camera video; spoke to footage being part of a personnel file; providing accountability; expressed disappointment with Legislature; and stated technology was ahead of legislation.

Discussion took place regarding reviewing footage through the criminal discovery process in closed session; the inability to discuss footage in open session; transparency; a developed study committee to review the issue; sensitive police video; the usage of personal cell phones capturing footage; and addressing issues as they arose.

#### PROGRAM FY 2015

WHEREAS, the Edward Byrne Memorial Justice Assistance Grant (JAG) Program, authorized under Federal Regulation 42 U.S.C. 3751(a), is the primary provider of federal criminal justice funding to state and local jurisdictions; and

WHEREAS, the JAG Program (CFDA #16.738) provides states and units of local governments with critical funding necessary to support a range of program areas including law enforcement, prosecution and court programs including indigent defense, prevention and education programs, corrections and community corrections, drug treatment and enforcement, crime victim and witness initiatives, and planning, evaluation, and technology improvement programs; and

WHEREAS, this grant is a disparate allocation between the Greensboro Police Department, High Point Police Department and Guilford County Sherriff's Department which requires an application process for the funder to approve the proposed use of funds; and

WHEREAS, a disparate allocation occurs when a city or municipality is allocated more funds than the county, while the county bears more than 50 percent of the costs associated with prosecution or incarceration of the municipality's Part 1 violent crimes; and

WHEREAS, approval of the proposed funding and a Memorandum of Understanding (MOU), executed by the participating jurisdiction's is required from all disparate applicants; and

WHEREAS, in accordance with the JAG Program disparate grant formula, the participating jurisdictions agree it is in their best interests to reallocate the \$191,755 in JAG funds to the City of High Point for a total of \$39,974; to Guilford County for a total of \$48,321; and to the City of Greensboro for a total of \$103,460.

8. <u>ID 15-0696</u> Resolution to Modify Rules and Regulations for the Operation of Municipal Cemeteries

0249-15 RESOLUTION APPROVING THE REVISED RULES AND REGULATIONS FOR THE OPERATION OF MUNICIPAL CEMETERIES

WHEREAS, the City currently has Rules and Regulations for the operation of the municipal cemeteries throughout the City;

WHEREAS, staff was previously directed by Council to review and identify opportunities to make modifications to the rules and regulations of the cemeteries;

WHEREAS, staff researched operations of various cemeteries and collaborated with residents and the Friends of Green Hill Cemetery to develop rule modifications;

WHEREAS, upon completion of the collaboration, staff presented the modifications to the Parks and Recreation Commission which voted unanimously in support of the changes;

WHEREAS, the proposed revised rules and regulations are presented herewith this day;

WHEREAS, a summary of the proposed changes is outlined as follows:

- Free ground In those cases where it is determined by the Cemetery Superintendent and confirmed by the guidelines provided by the Guilford County Social Services that a resident is impoverished and unable to pay for a grave, grave and all related services may be provided without charge. Such documentation as is required to make the determination shall be furnished to the Cemetery Superintendent. The location of the lot, date and time of the service will be at the discretion of the Cemetery Superintendent;
- Permitted plantings No person shall plant, remove, or maintain any tree, shrub, or ground cover in a City Cemetery without the permission of the Parks and Recreation Director or Cemetery Superintendent or their designee. The Cemetery Superintendent is authorized to allow the plot owner's permission to install and maintain small flowering trees and dwarf evergreen shrubs, provided that such trees and shrubs are planted in line with monuments or in such areas so as not to substantially interfere with the maintenance of the cemetery. All trees and shrubs must be trimmed in a manner to encourage upward growth and not interfere with future adjacent grave openings. All approved plantings must be within the boundaries of the owner's lot. ONLY the owner or its representative is allowed to plant anything on lots. Application for permission to plant trees or shrubs shall be made to the Cemetery Superintendent and shall be made by the owner or owner's designated representative. Detailed plans showing the plantings desired shall be furnished with any application. In regard to public requests for additional plantings and with the intent to maintain a safe, beautiful and low-maintenance needed cemetery system, the following serves as a recommended guideline to be followed, which could be subject to exception by way of written pre-approval from the Parks and Recreation Director, Cemetery Superintendent or their designee:
- Newly planted trees should be eight feet or more in height, except when planted by individuals on their family plot and only allowed in common areas;
- New trees will not be allowed within five feet of any paved street;
- Shrubs may only be placed in designated natural areas, with the shrub's adult form (height and width) taken into consideration. Trees or shrubs which produce excessive litter (i.e. sweet gum, female ginkgo) or that could provide a hazard to participants, volunteers or staff will not be permitted (i.e. thorns, vines, etc.).

The City reserves the right to trim, prune or remove from any lot or space any tree or shrub which is installed in violation of these regulations or which become unsightly or detrimental to walks, roads, or other lots. Other plantings not presently conforming to these regulations shall be made to conform therewith. The Cemetery Division will be held harmless when the decision is made to remove any existing tree or shrub that is interfering with maintenance practices or grave opening procedures, or which is detrimental to the overall appearance of the cemetery. No plantings will be permitted in sections that are subdivided and platted into grave sites after May 1,

1974

- Conduct in cemeteries Without prior approval from the Parks and Recreation Director or their designee, no person shall:
- Use City Cemetery property for drop-in recreation, equipment/vehicle storage, discharge fireworks or firearms.

Other personal conduct by any guest/visitor deemed to be unreasonable or unlawful in accordance to Parks and Recreation Rules and Regulations 19-1 and City of Greensboro laws and ordinances inside cemetery property is prohibited. Unreasonable behavior includes, but not limited to:

- Failing to comply with rules, regulations and staff directions;
- · Trespassing outside of established operating hours;
- Failure to remain on designated plots, roads and trails;
- Failure to remove pet or service animal waste;
- Behavior that deters the peace of the other guests and/or services
- Vehicles and recreational transportation considerations:
- The speed limit for all traffic is 15 mph;
- All motor vehicles and bicyclists must remain on designated roads and / or paths as directed by Cemetery personnel and be operated in accordance to State, local laws and ordinances;
- Unless prior written approval is received by the Parks and Recreation Director or their designee, horseback riding is prohibited. Exceptions would be considered for services and/or ceremonies;
- Service animals and pets Pets and service animals are permitted, and must remain on leashes at all times. Owners are responsible for the behavior of their pets and/or service animals and are required to remove all waste.
- Operating hours All City Cemeteries shall be closed from sundown until 8:00 AM during the entire year. No person, other than law enforcement personnel or Cemetery Division employees may enter any City Cemetery while it is closed without the permission of the Parks and Recreation Director or their designee. The Parks and Recreation Director or their designee may change hours of operations needed, but not to interfere with previously scheduled services;

WHEREAS, there will be no budgetary impact as a result of the proposed changes.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That the proposed Revised Rules and Regulations for the operation of municipal cemeteries presented herewith this day is hereby approved.

Councilmember Hightower spoke to the initiative; grant funding; referenced collaboration with Commissioner Ray Trapp and the County in providing fresh food access; voiced she would like to see the mobile unit tied into the item; and inquired as to how many citizens had been fed this summer.

Assistant City Manager Wilson spoke to promotion of eating healthy and exercising; the overall health plan; referenced a meeting with the Health Department and Commissioner Trapp; spoke to public involvement; transportation accommodations being provided by the County; confirmed staff would follow up on the mobile market unit; spoke to the Out of the Garden program; and stated approximately 50,000 people had been fed over the summer.

Mayor Vaughan stated Council was not afraid to shine a light on the problems of the City; spoke to partnering with the County; to assisting the residents; and to recognizing and addressing the issue.

# II. PUBLIC COMMENT PERIOD

James King, 4101 Landerwood Court spoke on behalf of Bessemer Curb Market; referenced difficulties in placing Kings BBQ sauce in grocery stores; stated Bessemer Curb Market had been successfully selling it; the store was a community necessity; was well known in the community; and requested Council support to help the store.

Harold Powell, 5506 Ridingate Court spoke to a previous appearance before Council in May; stated Bessemer Curb Market was a landmark serving East Greensboro which had been in business for 63 years; referenced discussions to improve East Greensboro; spoke to a petition requesting assistance; referenced Council campaign statements; and requested grant monies be allocated for the store.

Rhonda Brown, 5506 Ridingate Court spoke to a three year history to attempt to receive grant funds for Bessemer Curb Market; and to communication she had with Mayor Pro-Tem Johnson.

Discussion took place regarding an item initiated by Councilmember Barber; Councilmember's visiting the location; conversations between Councilmembers regarding the store; grant based programs; and the option of low interest loans.

Councilmember Hightower stated she had not been contacted; the needs did not fit any City grant program; spoke to City funded programs; inquired as to the length of time it had taken to get the signatures for the petition; and spoke to looking at strategies.

Ms. Brown referenced people getting money from the City; and stated it had taken less than 2 months to get petition signatures.

Discussion continued regarding up-fits for the business; health regulated requirements; alternative option with East Market Corporation; matching grant funds; the lack of a request to meet with Mayor Vaughan; required parameters; the consistency of Councilmember Wilkins vote regarding giving loans and grants; and the need for a written proposal.

Ms. Brown spoke to upgrades and renovations that were being required to meet code; stated labor was a huge expense; the store was a joint ownership; and spoke to the desire of the community for the store to remain at its current location.

Councilmember Fox requested staff to schedule a meeting with Ms. Brown regarding financial assistance.

Devon King, 836 South Elm Street spoke to running for office; people asking for help; investment of City funds; closed door sessions; vacant buildings; stated he had been a resident for five years; spoke to the Performing Arts Center; small business owners; and bad investments.

Discussion took place regarding the COOP funding; Self Help; Cone Health investments; and privately owned buildings in Downtown.

Gaylan Oliver spoke to food deserts; an on-going project with North Carolina A & T State University (A & T); Urban Farms; health concerns; landfill issues; and requested assistance from Council.

Councilmember Fox thanked Mr. Oliver for championing the Urban Garden; referenced discussions with the Chancellor at A & T; spoke to the White Street Landfill; and requested staff research the status of Mr. Oliver with A & T regarding the Urban Farms project.

Assistant City Manager Parrish provided information on staff's communications with the concerned citizens of Northeast Greensboro and A & T; spoke to community needs; and confirmed staff would research the project.

Discussion took place regarding A & T's involvement in the project; possible contamination of the project location; legal representation for Mr. Oliver; and defining the project.
