The M/WBE Office reviewed the documentation submitted by Garney Construction, CMAR for the T.Z. Osborne Water Reclamation Facility 56 MGD Upgrade – Package 3 Project to determine compliance with the City of Greensboro's M/WBE Plan. The contract goals established for the project were MBE 7% and WBE 5%. The MBE goal was achieved; Garney Construction provided evidence of Good Faith Efforts to try to meet the WBE goal.

Garney Construction proposed to commit 8.3% or \$1,412,903.00 to MBE firms and 3.64% or \$618,386.00 to WBE firms.
