## Attachment 1 – Hauling & Disposal Combined Cost Analysis

July 27, 2016 Note to Reader:

The following five tables present pricing information from the City of Greensboro's recent RFP #2016-10419 for Municipal Solid Waste Hauling Services and GePS Event #8214 for Municipal Solid Waste Disposal Services. Hauling proposals were initially received May 6, 2016 from Atomic Transport, LLC, Stafford Transport of North Carolina doing business as Custom Ecology, Inc. (CEI) and Hilco Transport, Inc. Following initial review, the City shortlisted the hauling proposers to CEI and Hilco and revised permile pricing was requested based on City-provided routes to area landfills. CEI and Hilco provided the revised pricing on June 8, 2016. Disposal proposals were received July 12, 2016 from Republic Services of North Carolina, LLC, Waste Connections of North Carolina, Inc., and Waste Management of the Carolinas, Inc. Following is a summary of the content of the tables:

- Table 1 Round trip mileage to area landfills based on City-approved routes
- Table 2 Hauling prices from revised Price Form 1 of the Hauling proposals as received June 8, 2016
- Table 3 Estimated per-ton hauling costs to each landfill based on assumed 23.5 tons per load
- Table 4 Disposal fee from Price Form 1 of the Disposal proposals received July 12, 2016
- Table 5 Estimated per-ton total (hauling and disposal costs combined) to each landfill based on assumed 23.5 tons per load
