I. Call To Order

This Work Session of the City of Greensboro was called to order at 4:00 p.m. on the above date in the Plaza Level Conference Room of the Melvin Municipal Office Building with the following members present:

Mayor Nancy Vaughan, Mayor Pro-Tem Yvonne Johnson, Councilmembers Marikay Abuzuaiter, Sharon Hightower, Nancy Hoffmann, Michelle Kennedy, Justin Outling, Tammi Thurm, and Goldie Wells

Also present were City Manager Jim Westmoreland, City Attorney Tom Carruthers, and Deputy City Clerk Angela R. Lord.

II. Presentations

1. <u>ID 18-0054</u> Update on the Renaming of Aycock Street - Planning Director Sue Schwartz

Planning Director Sue Schwartz made a PowerPoint Presentation; provided the history of the item; spoke to the request by Lewis Brandon; reviewed options that were presented to Council; confirmed the street numbers assigned would not have to be changed for any of the options; outlined an online survey and an open house held for public input; provided a breakdown of the responses received; stated the majority of those impacted supported the item; staff recommended option 3; confirmed compliance with the Street Naming Manual; voiced the need for a six month head start to give people time to make address changes; outlined additional options in lieu of renaming the street; and the next steps.

Discussion took place regarding the rules of the street suffix; the availability of compensation to those impacted; the cost to the City to replace street signs; the need to update Google Map applications; clarification of which streets were included in the project; and the positive feedback from the online survey.

It was the consensus of Council to move the item forward to the Planning Board on March 21st at 4 p.m.
