Beginning at an existing iron pipe on the eastern margin of Roland Road, said pipe being the southwestern corner of Lot 35 of Woodland Acres as shown on Plat Book 20 page 4 in the Guilford County Registry; thence with the southeastern line of Lot 35 S. 60-05-13 E. 181.38 feet to an existing iron pipe in the western line of Lot 78 of Kings Mill at Sedgefield as shown on Plat Book 92 page 81 in the Guilford County Registry; thence with western line of Lot 78 S. 22-00-28 W. 50.12 feet to an existing iron pipe; thence S. 20-47-23 W. 25.67 feet to an existing iron pipe, the northeastern corner of Lot 39 of Woodland Acres as shown on Plat Book 20 page 4 in the Guilford County Registry; thence with the northwestern line of Lot 39 N. 60-00-00 W. 189.65 feet to an existing iron pipe on the eastern margin of Roland Road; thence with the eastern margin of Roland Road N. 27-50-43 E. 74.75 feet to the point and place of beginning and containing 0.318 acres more or less.
