## Parcel Id 140536

Being a parcel of land on the southeast side of Roland Road, located in Sumner Township, Guilford County, North Carolina and being Lots 28, 29 & 30 of Woodland Acres as shown on Plat Book 20 page 4 in the Guilford County Registry and being more particularly described as follows:

Beginning at an existing iron pipe on the eastern margin of Roland Road, said pipe being the southwestern corner of Lot 27 of Woodland Acres as shown on Plat Book 20 page 4 in the Guilford County Registry; thence with the southeastern line of lot 27 S. 60-18-35 E. 156.11 feet to an existing iron pipe in the western line of Lot 81 of Kings Mill at Sedgefield as shown on Plat Book 92 page 81 in the Guilford County Registy; thence with western line of Lots 81 S. 20-13-09 W. 50.31 feet to an existing iron pipe in the western line of Lot 79 of Kings Mill at Sedgefield; thence with the western line of Lot 79 S. 21-19-38 W. 25.32 feet to an existing iron pipe, the northeastern corner of Lot 31 of Woodland Acres as shown on Plat Book 20 page 4 in the Guilford County Registry; thence with the northwestern line of Lot 31 N. 60-19-19 W. 165.67 feet to an existing iron pipe on the eastern margin of Roland Road; thence with the eastern margin of Roland Road N. 27-50-43 E. 74.75 feet to point and place of beginning and containing 0.276 acres more or less.
