TO AMENDMENT AGREEMENT BETWEEN THE CITY OF GREENSBORO AND ADW ARCHITECTS

THE AGREEMENT signed by the parties on 10/13/17 is hereby AMENDED as follows:

The agreement (Contract #2017-075) is amended to extend the scope of work to include full architectural and engineering services as required to complete the design of Fire Station no. 56 as outlined in the attached proposal dated July 11, 2018. This amendment, in the amount of \$306,000.00, brings the total cost of the contract to \$315,000.00.

It is expressly agreed by the parties that this contract is supplemental to the original contract, number 2017-075, between the parties, which is made a part by reference, and all terms, conditions, and provisions of the original contract, unless specifically modified, are to apply to this contract and are made a part of this contract as though expressly rewritten, incorporated, and included herein.

In the event of any conflict, inconsistency, or incongruity between the provisions of the amended contract and any of the provisions of the original contract, the provisions of the amended contract shall in all respects govern and control.

2018, which is incorporated herein by reference, and all terms, conditions, and provisions of the original Agreement apply to this Addendum and are made a part hereof as though expressly rewritten, incorporated, and included herein. In the event of any conflict, inconsistency, or incongruity between the provisions of this Addendum and any of the provisions of the original Agreement or previous addendums, the provisions of this Addendum shall in all respects govern and control.

 - b. This endorsement does not increase any of the limits of insurance stated in D. Liability And Medical Expenses Limits of Insurance.
