SUBJECT: M/WBE Memo for the New Construction of Fire Station 56

The M/WBE Office completed a review of documentation submitted by Samet Corporation for the above contract to determine compliance with the City of Greensboro M/WBE Program Plan. The M/WBE goals established by the Goal Setting Committee for Fire Station 56 were MBE 25% and WBE 20%. Samet Corporation met the MBE Goal (34.08%); but did not achieve the WBE Goal (9.21%). The M/WBE Office will monitor the CM@R to ensure it continues to make Good Faith Efforts to try to meet the WBE Goal prior to the start of construction.
