Meeting Minutes - Draft City Council Work Session

Tuesday, February 4, 2020

4:00 PM

Plaza Level Conference Room

I. Call To Order

This City Council work session of the City of Greensboro was called to order at 4:00 p.m. on the above date in the Plaza Level Conference Room of the Melvin Municipal Office Building with the following members present:

Mayor Nancy Vaughan, Councilmembers Marikay Abuzuaiter, Sharon Hightower, Nancy Hoffmann, Yvonne J. Johnson, Tammi Thurm, and Goldie Wells.

Absent: Councilmembers Michelle Kennedy and Justin Outling.

Also present were Assitant City Manager Chris Wilson, City Attorney Chuck Watts and Assistant City Clerk Victoria Howell.

II. Presentations

1. [ID 20-0115](#) Storm Water

Assistant City Manager Chris Wilson spoke to the absence of City Manager David Parrish; to flood concerns for the city; and recognized Water Resources Senior Manager, Kristine Williams to provide an update on Storm Water.

Ms. Williams referenced road closures and property damage due to storms; reoccurring events; spoke to mitigation hazards; to the need of funding for water and sewer pipe updates; and recognized Water Resources Manager of Storm Water, David Phlegar and Engineering Manager Virginia Spillman. Ms. Williams made a PowerPoint Presentation; spoke to the property acquisition program; to public safety; to frequency of flood damage; to property purchases; and to Federal Emergency Manangement Agency (FEMA) grant programs.

Ms. Spillman explained infrastructure improvements; the availability of flood plain insurance discounts; outlined challenges and opportunities; and spoke to flood plain regulations.

Discussion took place regarding flood plain prevention and regulation; building designs; restrictions on building sites; builder incentives; vertical structures; and pipes designed for 10 year rains compared to the 100 year rains being experienced.

Mr. Phlegar contributed information on defining floods.

Discussion continued regarding protection and education for homeowners; the need for enforcement regulations; leaf and liter collection; and concerns with the reduction of storm drain size due to road repavements.

2. [ID 20-0116](#) GCJAC Update

Assistant City Manager Trey Davis spoke to criminal justice; to the need to monitor,review,and study crime data; to the mission and vision of the Greensboro Criminal Justice Advisory Commission (GCJAC); to semi-annul updates; provided a historical overview; and spoke to law enforcement attendance at Police Community Reveiw Board

(PCRB) meetings.

Discussion took place regarding District 2 representation; to PCRB cases; training for GCJAC commissioners; community outreach and forums; and phase two of "Know Your Law".

Councilmember Hightower stated for the record "I have never really been fully supportive, but I've always wanted PCRB to hear cases"; and inquired about traffic stop data.

Discussion continued regarding a summary of calls and complaints collected; trends; new restraint policies; training; engaging youth and diversity; community forums; and options for GCJAC oversight.
