General Contract Extension Information

1.0 Contract Type

This Extension of the Agreement is between the State of North Carolina, Department of Public Safety, Division of Emergency Management, acting by and through the Secretary of the Department of Public Safety, (hereinafter STATE) and the City of Greensboro (hereinafter CONTRACTOR) for the provision of regional hazardous materials emergency response services as described herein and authorized pursuant to N.C.G.S. §166A-20 et. seq.

1.1 Recitals:

WHEREAS, to protect life and property against the dangers of emergencies involving hazardous materials, STATE is authorized to assign and make available for use in any county, city or district, all or any part of a Hazardous Materials Regional Response Team or Teams (hereinafter HAZMAT TEAM), the STATE and CONTRACTOR on the 1st day of July 2016, entered into an Agreement establishing CONTRACTOR as a hazmat team, a copy of said Agreement is attached hereto and incorporated by reference herein; and

WHEREAS, STATE and CONTRACTOR each agreed to extend the terms of the Agreement.

NOW, THEREFORE, it is mutually agreed, the Agreement shall continue in full force and effect after the 30TH day of June, 2020. This Agreement shall in all particulars be a continuation of the previous one and shall be identical in all terms, conditions and stipulations for the term beginning on the 1st day of July, 2020 and expiring on the 31st day of October, 2020.

IN WITNESS WHEREOF, the STATE and the CONTRACTOR have each executed this Agreement, this the 15th day of May, 2020, and the parties agree that this Agreement will be effective as of July 1, 2020.
