

A. EXECUTIVE SUMMARY

The City of Greensboro's federal Five-Year Consolidated Plan details the funding strategy for the Community Development Block Grant (CDBG), HOME Investment Partnership Program (HOME), Emergency Solutions Grant (ESG), and Housing Opportunities for Persons with AIDS (HOPWA) for the period of 2015-2019. The Annual Action Plan details each year within the Five-Year Consolidated Plan and outlines the implementation of annual funding, which is developed through public input, analyses, and planning. The Greensboro City Council adopted the 2019-2020 Annual Action Plan (Annual Plan) on May 21, 2019 and submitted the document to the U.S. Department of Housing and Urban Development (HUD) before the required deadline date.

The City's Citizen Participation Plan (CPP) describes the efforts that the City will take to encourage its residents to participate in developing these plans. It also provides requirements for public process when a "substantial amendment" to the Annual Plan is proposed. The following changes constitute a substantial amendment and require public notice as described in the CPP:

- A change in the use of CDBG funds from one eligible activity to another
- Funding of a new project not previously described in the Annual Plan
- A change in the allocation or distribution of funds
 - Defined as when the dollar amount of that change is equal to, or greater than 25% of the City's current fiscal year federal allocation
 - E.g. CDBG is undergoing a substantial change when 25% or more of that year's CDBG allocation is affected
- A significant change to an activity's proposed beneficiaries or persons served

HUD has allocated special funds to the City of Greensboro, as authorized by the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Public Law 116-136, to be used to prevent, prepare for, and respond to the coronavirus pandemic (COVID-19).

Due to COVID-19, HUD has issued guidance that waives the Citizen Participation Plan requirements for entitlement recipients, provided that (1) no fewer than five days are provided for public comment and that (2) reasonable notice and the opportunity to comment is provided. HUD has awarded supplemental funding through the CARES Act that requires programming in the 2019-2020 Annual Action Plan.

The first Substantial Amendment to the 2019-2020 Annual Action Plan to program and authorize \$2,082,964 in CDBG-CV, ESG-CV, and HOPWA-CV funds under the CARES Act was approved by City Council on May 19, 2020 and submitted to HUD. This second Substantial Amendment to the 2019-2020 Annual Plan is to program and authorize \$1,880,847 in additional ESG-CV funds awarded to the City of Greensboro. This additional ESG-CV award brings the total awarded Greensboro CARES Act dollars to \$3,963,811.

B. CITIZEN PARTICIPATION

An eight-day public comment period was published in the *Greensboro News & Record*, *Carolina Peacemaker*, and *Qué Pasa* and posted on the City website, informing the public of the proposed Substantial Amendment and inviting comments. The public comment period will begin on Wednesday July 29, 2020 and will end on Wednesday August 5, 2020. Residents are able to review copies of the Substantial Amendment at www.greensboro-nc.gov/substantialamendment or may request a hard copy

if needed. On August 18, 2020, the Greensboro City Council will approve the submission of the substantial amendment and the CARES Act program funding.

C. CHANGES TO THE 2019-2020 ANNUAL ACTION PLAN

The City is proposing the following amendments to the 2019-2020 Annual Action Plan in order to allocate additional supplemental funding awarded by the CARES Act.

1. Program and authorize \$1,880,847 in ESG-CV funding made available by the CARES Act to provide homelessness prevention, rapid rehousing services, and emergency shelter.

In the event that the forthcoming federal ESG-CV notice provides flexibility for funding new eligible activities, we anticipate the possibility of allocating the balance of any uncommitted ESG-CV funds to new activities based on local needs. Emergency shelter and additional rapid rehousing activities will be considered within 180 days of the date of the HUD grant agreement for Round II ESG-CV funds.

The following Table outlines the project budgets that are being modified to allocate funds to the proposed projects described in this Substantial Amendment:

My comments are the temporary shelter housing would be individual apartments or like hotel suites with bathroom, 1 bedroom, and a modified kitchen. The property could have the look of a apartment complex with a larger building that would have offices and classrooms for case management, homelessness prevention, rapid rehousing services, and mental health services that would include trauma informed therapy, family preservation services and support groups. Included in this building would be showers and bathrooms for chronic homeless individuals to access.

Covid-19 has impacted people across all socioeconomic and racial backgrounds. There are families experiencing homelessness for the first time.

Unfortunately, there is a great amount of stigma that comes along with homelessness. Public bathrooms, libraries and restaurants that were accessible are currently unavailable.
