- Fresh Market: 53 jobs | \$5,400,00 capital investment
- Systems Sunlight: 50 jobs | \$6,500,000 capital investment
- UnitedHealthcare: 400 jobs
- Prepac Manufacturing: 200 jobs | \$27,000,000 capital investment
