Water Resources Focus Areas*

A highly visible, arts driven solution to drainage issues and stream remediation will activate WestWoods, an urban forest and wetland area located between Greensboro's Downtown Greenway and the performing arts campus of Greensboro College. Raleigh NC based artist Thomas Sayre will collaborate with the city's Water Resources department to address challenges posed by the natural landscape. WestWoods will change the public's perception of water use and infrastructure within the context of a natural environment in the midst of the city. It will create a bridge between neighborhoods that share a homeless camp, an unofficial skate park, and a burgeoning community garden. On-site collaborations between Greensboro's seven colleges and universities, with a focus on science, ecology and the arts, will lead to an increasingly engaged student population. The WestWoods project presents an opportunity to drive transformation through art, and aligns with the goals outlined in our mission statement.

Located in Guilford County, the one acre site lies directly adjacent Greensboro's planned Downtown Greenway as it follows an abandoned railroad line that slices through a mixed income neighborhood just a few blocks from our city center. The site is crossed by a highly urbanized stream that drains the southwest portion of downtown Greensboro and eventually flows into the Haw River and then into the Jordan Lake and the Cape Fear River system.






