SUBJECT: M/WBE Memo for Contract 2019-0320 Fire Station 56, Change Order #2

The M/WBE Office reviewed the change request for 2019-0320 Fire Station 56 CMAR project with Samet Corporation to determine continued compliance with the City's M/WBE Program Plan. The contractor is required to maintain the original M/WBE participation throughout the duration of the contract unless approved in advance by the City.

The M/WBE goals established by the Goal Setting Committee for Fire Station 56 were MBE 20% and WBE 20%. Samet Corporation met the MBE Goal (34.10%); but did not achieve the WBE Goal (9.2%). The contract award (preconstruction & change order #1) amount was \$6,528,346 with a commitment of MBE 33.79% and WBE 6.10%. Change order #2 in the amount of \$492,913.50 will increase the total contract value to \$7,021,259.50. The MBE utilization decreased from 33.79% to 31.21% and the WBE utilization increased from 6.10% to 7.33%. The firm proposed to commit \$168,191.22 or 34.12% of the change order amount to the following M/WBE firms:
