I. Call To Order

This virtual City Council work session of the City of Greensboro was called to order at 3:00 p.m. on the above date.

Mayor Vaughan took a roll call to confirm Councilmembers in attendance. The following members were present:

Mayor Nancy Vaughan, Mayor Pro-Tem Yvonne Johnson, Councilmembers Marikay Abuzuaiter, Sharon Hightower, Nancy Hoffmann, Michelle Kennedy, Justin Outling, Tammi Thurm, and Goldie Wells.

Also present were City Manager David Parrish, City Attorney Chuck Watts and Assistant City Clerk, Victoria L. Howell.

II. Presentations

2. [ID 21-0352](#) American Rescue Plan Overview

City Manager David Parrish requested item #2/ID 21-0352 be presented first due to time constraints; and recognized Assistant City Manager Larry Davis.

Assistant City Manager Davis made a PowerPoint Presentation (PPP); spoke to estimated American Rescue Plan (ARP) funding allocations; to the disbursement of a portion of funds in May; to eligible/ineligible uses for funds; to the Government Finance Officers Association (GFOA) guiding principles; to Council priorities; and to a budget public hearing in May.

Mayor Pro-Tem Johnson requested staff to research collaboration with Guilford County regarding American Rescue Plan funding.

Discussion continued regarding public hearings; transforming the City; feedback from the public; small business outreach; stabilizing wages; minority owned businesses; and past due city maintenance.

1. [ID 21-0354](#) Bond Package Discussions

Marlene Druga, Finance and Administrative Services Interim Director, made a PPP; spoke to the 2016 bond referendum; to remaining issuance of funds; to a tax rate impact; identified program area needs; and spoke to implementation of a Housing GSO Plan.

Discussion took place regarding funding for parks; land acquisition; incentives; Windsor Chavis housing; and facility maintenance needs.

Ms. Druga continued the PPP; spoke to general facilities and maintenance; to prioritizing projects; to transportation needs; to housing; to public safety; to community services; and to the bond approval and issuance calendar.

Discussion continued regarding partnerships; fire stations; property tax increases; collaboration with the Greensboro Chamber of Commerce; and higher interest rates.

Ms. Druga spoke to the debt capacity; and staff recommendations.

Discussion ensued regarding the Vandalia Road project; the City's credit rating; and possible tax increases.
