### **Call to Order**

This City Council meeting of the City of Greensboro was called to order at 4:30 p.m. on the above date in the Council Chamber of the Melvin Municipal Office Building with the following members present:

**Moved by Mayor Pro-Tem Johnson, seconded by Councilmember Fox to adjourn to close session to preserve the attorney-client privilege between the City Attorney and Council, give instructions to legal counsel concerning the settlement of a claim and to instruct staff regarding the price and other terms relating to the acquisition of the alley located at 120 West Lewis Street which is owned by Double G Properties, LLC pursuant to N.C.G.S. 143-318.11 (a) (3)& (a) (5). 0283-15 RESOLUTION HONORING THE MEMORY OF THE LATE ODESSA G. KIMBER

WHEREAS, on August 8, 2015, this community lost one of its outstanding community leaders with the death of the late Odessa G. Kimber at the age of 85;

WHEREAS, Kimber, a native of Staley, North Carolina, graduated with the Class of 1948 from Dudley High School and received an Associate Degree in Business Education from Agricultural and Technical College (NC A&T State University) in 1952;

WHEREAS, following graduation Ms. Kimber was employed by Prago & Guyes for five years where she was the first Intergenerational Cashier and Bookkeeper and worked for seventeen years at NC A&T State University as an Administrative Secretary and Supervisor for the Student Aide Personnel and Secretary of Government Projects;

WHEREAS, Ms. Kimber furthered her education at Guilford Technical Community College where she earned an Associate Degree in Criminal Justice, a Certificate of Auxiliary Basic Criminal Justice Instructor Training, and a Special Police Officer Training for the state of North Carolina;

WHEREAS, she owned and operated Kimber Guard & Patrol, Inc. for thirty seven years and was the first woman in the state of North Carolina to obtain the necessary licensing to own and operate a security guard and patrol firm;

WHEREAS, Ms. Kimber served at Saint Stephen United Church of Christ for 79 years in many capacities including Youth Choir, Junior Usher Board and member of the Board of Trustees;

WHEREAS, for many years Ms. Kimber formed and sponsored a T-Ball team in the Ray Warren Homes community for 6 to 9 year old boys;

WHEREAS, some of the many honors and accomplishments Ms. Kimber received include Honorary Attorney General in 1984 by Rufus Edmisten, The February One Society's "One Community Award in 1984", Distinguished Service Award for Distinguished and Meritorious Service from The Piedmont Chapter of The North State Law Enforcement Officers Association, Minority Service Industry Firm of The Year Outstanding Achievements in Developing Minority Business in the Triad for the year 1984, Y.M.C.A. Black Women's Award for Outstanding Service in Business, North Carolina Association of Minority Business, Inc. Award for Outstanding Service and Commitment to Growth and Expansion of Minority Business, United States Congressional Advisory Board for Outstanding Service as State Advisor, and North Carolina Law Enforcement Officers Association: Piedmont Chapter Award for Appreciation of Devoted and Valuable Services;

WHEREAS, Ms. Kimber founded the Triad Sickle Cell Anemia Foundation in Greensboro, was the recipient of WHO'S WHO OF AMERICAN WOMEN, 15th Biennial Edition and was awarded the "National Sojourner Truth Meritorious Service Award";

WHEREAS, the City Council wishes to express its sense of loss and its sincere appreciation and gratitude for the many years of dedicated public service rendered by Odessa G. Kimber, the outstanding contributions she has made to the community, and the legacy she leaves.

WHEREAS, the City of Greensboro is a welcoming place to work by not discriminating on the basis of sexual orientation, gender expression, gender identity or other non job-related factors when making employment decisions;

WHEREAS, Greensboro from its beginning has reflected a diverse and inclusive population of persons of many backgrounds, including citizens who are Lesbian, Gay, Bisexual, and Transgender;

WHEREAS, the City of Greensboro wants to make official its observance of Greensboro Pride and to continue its tradition at the local level of recognizing the impact that lesbian, gay, bisexual and transgender individuals have had on history locally, nationally, and internationally.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That September 19, 2015 is designated as Greensboro Pride Day in the City of Greensboro to commemorate and celebrate lesbian, gay, bisexual and transgender history, along with the history of the gay rights and related gay rights movements in the City of Greensboro.

Mayor Vaughan referenced a meeting with Mr. Waddell along with Councilmember Hightower; referenced suggestions made as a result of the meeting; acknowledged the situation could have been handled differently; made an apology to Mr. Waddell; and spoke to changing things moving forward.

Mayor Pro-Tem Johnson voiced her apologies; and stated citizens deserved to be treated with dignity.

Councilmember Hightower referenced conversations with Mr. Waddell and City staff; offered an apology; and spoke to being respectful of citizens.

Councilmember Hightower left the meeting at 6:40 p.m. and returned at 6:45 p.m.

Reverend Randall Keeney, 1300 Jefferson Road voiced support of Mr. Waddell; continued with Mr. Waddell's statement and complaint; provided information for his involvement in the incident; spoke to the Greensboro Police Department policies; amendment rights; and property damage.

Reverend Doctor T. Anthony Spearman, 4246 Farlow Drive voiced support of Mr. Waddell, continued with Mr. Waddell's statement and complaint; spoke to the Citizens Review Committee investigation; police accountability; and to the Police Department honoring their code.

Reverend Nelson Johnson, 2115 Murrayhill Road voiced support of Mr. Waddell; spoke to ceremonial resolutions adopted; referenced Reverend Jessup's attendance; spoke to hourly wages; and police accountability.

Portia Shipman, 2200 B East Market Street spoke to domestic violence; invited Greensboro to participate in the Paint the City Purple Celebration event on November 7th, spoke to improved services for victims; stated the campaign would start Monday October 26th; Guilford County College would acknowledge domestic violence on October 28th; requested Council participation; stated there were many organizations participating; and suggested using balloons and ribbons to Paint the City Purple.

Mayor Vaughan requested staff to look into lighting up the Greene Street parking deck with purple LED lights.

Marsh Prouse, 516 Woodlawn Avenue requested Council participation in the 6th annual Run for the Greenway on September 26th from 4 p.m. to 8 p.m. at Center City Park; stated this would be the first time dogs would participate; referenced tee shirts that were provided for councilmembers; voiced appreciation to sponsors; spoke to the history of the Greenway; and to Economic Development.

0288-15 RESOLUTION AUTHORIZING EXECUTION OF CONTRACT WITH ARCADIS G&M OF NORTH CAROLINA, INC. FOR THE 2015 SEWER MODEL RECALIBRATION PROJECT



WHEREAS, the City's existing dynamic sewer collection system model needs to be expanded and updated to provide the City a comprehensive update of the City's Sanitary Sewer Master Plan;

WHEREAS, Arcadis G&M of North Carolina, Inc. is one of ten on-call professional services firms utilized by the Water Resources Department which was chosen through a Statement of Qualifications (SOQ) selection process to provide professional engineering and design service in the amount of \$415,000.

That the City is authorized to enter into a contract with Arcadis G&M of North Carolina, Inc. for the 2015 Sewer Model Recalibration project subject to the terms outlined above. Discussion took place regarding additional parking spaces; the location of the parking area in relation to the abutting neighborhood; the lease termination and displacement of the parties on the property; and the legal allowances regarding the lease agreement.

Charlie Melvin, 300 North Greene Street spoke to the legal representation for Cone Health; a pending contract; the need for additional parking; stated two neighborhood meetings had been conducted; referenced traffic concerns; spoke to utilizing the developed property; a positive project for Cone Health and the City of Greensboro; and requested Council to approve staff recommendations.

Discussion continued regarding the potential of approximately fifty new jobs.

Speakers in opposition of the item:

Andrew Shaffner, 4204 Princeton Avenue, a resident of Highland Park Neighborhood spoke to the diverse population; requested Council to reverse the Zoning Commission decision due to safety concerns; spoke to

economic development; egress and ingress; provided the history of the item; spoke to a North Carolina Department of Transportation request; a traffic impact study; unsafe conditions; transportation goals violation; consolidation of jobs; home values; referenced the Zoning Commission meeting and voting results; spoke to the public interest; an alternate parking lot; and requested Council to deny the item.

Discussion took place regarding entrances; current access points; the site plan; the speaker being chosen as a representative for the neighborhood; Councilmember Hoffmann being contacted by a resident; the closing of streets; potential sidewalks; evaluation and site plan development; and public improvements.

Rebuttal In Support:

There were no rebuttal comments in support of the item.

Rebuttal In Opposition:

Mr. Shaffner spoke to the main concerns with the item; highlighted traffic safety and noise issues; spoke to the length of United Street; sidewalk concerns; and voiced a traffic impact statement would be important.

Mayor Pro-Tem Johnson spoke to a compromise; inquired about a recent rezoning; a safer location for children to catch the bus; and if Cone Health had considered the alternate parking lot suggested by Mr. Shaffner.

Mr. Luttrell stated the alternate location had been considered; spoke to alternate parking; reviewed options across West Market; spoke to safety concerns for workers crossing the street; and to the financial investment by Cone Health.

Transportation Director, Adam Fischer stated staff would have to work with Guilford County Schools for an alternate bus stop location; spoke to the sidewalk policies; a completed sidewalk project; and two lanes being eliminated as part of the sidewalk project.

Mr. Shaffner voiced appreciation for the sidewalk project; spoke to an increase in pedestrian traffic; referenced the shopping center across the street; and stated the neighborhood would welcome a Trader Joes.

Discussion continued regarding the hours of operation for Cone Health.

Moved by Councilmember Hightower, seconded by Councilmember Wilkins to close the public hearing. The motion carried by voice vote.

Councilmember Hoffmann spoke to sidewalk improvements; concerns to create a safer environment for students; Highland Park Neighborhood interior streets; maintaining the integrity of the area; the development of the plan; and requested staff to include the neighborhood residents with plan developments in regards to the increased traffic concerns.

Section 1. That Subsection (C) of Section 30-7-1.4, Setbacks, is hereby amended to read as follows:

C. Encroachments into Required Setbacks

The following are allowed in required setbacks provided that compliance is maintained with the provisions of Section 16-8 of the City Code (Obstructions to Cross-Visibility at Intersections):

1. Landscaping features, including but not limited to, ornamental pools, planting boxes, sculpture, arbors, trellises, and birdbaths.
2. Pet shelters; at-grade patios; play equipment; outdoor furniture; ornamental entry columns and gates; flagpoles; lampposts; address posts; HVAC equipment; mailboxes; outdoor fireplaces; public utility lines, poles, pumps, and boxes; wells; fences (see Sec. 30-9-4); and similar structures.
3. Handicap ramps.
4. Steps not connected to any above-grade structure.
5. Gatehouses/guardhouses and bus shelters with approval of the Planning Director and Transportation Director.
6. Cornices, overhanging eaves and gutters, window sills, bay windows, or similar architectural features, chimneys and fireplaces, fire escapes, fire balconies, and fire towers may project up to 2.5 feet into any required setback, but must remain at least 3 feet from any property line.
7. Porches and decks may encroach into required front and rear setbacks as follows:

Type of Porch or Deck	Setback	Maximum Encroachment	Maximum Area
Covered or uncovered	front	5 feet	35 sq. ft.
Uncovered- 4 ft or less above grade	rear	50% of setback	-----

8. Steps attached to above-grade structures:
  - a. if 4 feet or less above grade, may project into an interior side or rear setback, but not within 3 feet of a property line.
  - b. may project anywhere within a street setback; and
9. Retaining walls except in single-family street setbacks where they are not permitted to be more than 4 feet in height.
10. Marquee signs and projecting signs may encroach into required setbacks in accordance with the sign regulations of this ordinance.
11. Waste handling facilities, including dumpsters, recycling bins, grease tanks, and similar accessory waste-handling facilities may be located in a required side or rear setback, but may not be located in a required street setback.

Section 2. All ordinances in conflict with the provisions of this ordinance are repealed to the extent of such conflict.

Section 3. This ordinance shall become effective upon date of adoption.

Ms. Schwartz spoke to the location of the event center on site; and blighted conditions.

Councilmember Wilkins inquired about the homeowners association owning units; an option for taxpayer savings; the requirements for reserve funds usage; the impact of Nussbaum funds; and asked if there would be a cap on the project.

Community Planning Manager Hannah Cockburn spoke to the purchase of the units for failure to pay HomeOwner Association dues.

City Attorney Carruthers spoke to un-appropriated funds; clarified the voting regulations for using reserved funds; and spoke to items adopted during the budget process.

Ms. Schwartz addressed the long term foreclosure process; allocation of Nussbaum funds; tax rate funds; affordable housing activities; and recognized Neighborhood Development Director, Barbara Harris to speak to the impact on affordable housing.

Ms. Harris stated there would be impact in future years.

City Manager Westmoreland spoke to the estimated cost; identifying options; and bringing the item back to Council.

Councilmember Hightower thanked staff for their work on the item; spoke to challenges; the lack of senior housing; potential for some type of housing; the length of the process; homeowner responsibilities; voiced concern with the event center; with the water meter and lighting; spoke to a tax producing property; and to moving forward .

Ms. Schwartz spoke to proposals after acquiring the building; and to adjacent facilities to the site.

Councilmember Outling spoke to a windfall to owners unable to make improvements to properties; attracting jobs; community expectations; stated the building was in poor condition; and voiced his support of the item.

Councilmember Barber spoke to a government decision in the 1980's; inquired about the current order that the property was under; and about clearing title issues.

City Attorney Carruthers spoke to the building inspection authorities; alternatives; appraised value; and stated the County was still taxing the property.

Council requested staff to research the possibility to expedite demolition; calculate the Police service call savings and identify new hot spots; to provide a reassessment of taxes; an email regarding super majority voting

regulations; and to bring the item back to Council at the next meeting to appropriate funding.

Discussion ensued regarding complications associated with expediting demolition; fair market exchange; owners inability to sell units; the foreclosure process; risks to the public; the local agreement with the County; unit taxes; recouping expenses; ownership of units; the last comprehensive analysis; tax fees; property values; and tax foreclosures.

Councilmember Abuzuaiter spoke to the investment of time by staff in developing the Heritage House Redevelopment Plan; to staff recommendations; voiced the need for Council support; and stated the item needed to move forward.

Mayor Vaughan reiterated to have the item on the next agenda to appropriate funding.

WHEREAS, on May 17, 2005, the City Council adopted New Economic Development Guidelines whereby the City may participate financially in the development of certain private improvements to promote economic development in accordance with the Guidelines and NCGS Section 158-7.1;

WHEREAS, Qorvo Inc. ("the Company") is evaluating an investment in new real property improvements on an existing site in Greensboro and investment in new machinery and equipment;

WHEREAS, the Company has requested that the City provide for a grant reimbursement for the construction of a new research and development facility and purchase of new manufacturing equipment which amount of participation is presently estimated at no more than \$544,279.00 based on a portion of anticipated new taxes to be derived by the City and new employment upon completion of the project;

WHEREAS, it is further anticipated that the Company will invest at least \$25,000,000. 00 in capital, and create 100 new jobs by December 31, 2018;

WHEREAS, the site where the Company will be adding capacity is located at Thorndike Road in the City limits of Greensboro;



WHEREAS, the addition of 100 new jobs paying an average wage of at least \$80,000 per year with benefits valued at 25% or more of the average annual wage, are expected to generate public benefit by positively impacting the City's ad valorem, use, and sales tax revenues in addition to increasing business prospects for the City and surrounding area, and therefore the City Council authorizes an Economic Development Incentive Grant of up to \$544,279.00 if the company chooses to expand in the City of Greensboro;

WHEREAS, a public hearing was held in accordance with N.C.G.S. 158-7.1 setting out the particulars of the request and the public benefits to be derived from said improvements;

WHEREAS, it is deemed in the best interest of the City to enter into a participatory agreement with the Company to share the cost of the above mentioned improvements whereby the City shall reimburse the company up to a maximum of \$544,279.00 to be paid in five equal payments of \$108,856.00 based on a portion of new anticipated taxes to be received from the new project and upon the creation of new employment. The grant shall be paid after the capital investment has been made and taxes have been paid.

Councilmember Hightower spoke to the six week FOOD Desert Storm event beginning on Saturday, September 19th at 9 a.m. at the Warnersville Center; to teaching people to live healthy; thanked staff for work on the Folk Festival; commended Assistant City Manager Chris Wilson for his work and leadership; and spoke to celebrating the 100th birthday of Mary Sue Hall.

Mayor Pro-Tem Johnson wished a happy 150th birthday to Providence Baptist Church.

Councilmember Barber requested staff to provide updated information regarding meals provided to Greensboro citizens.

Mayor Vaughan spoke to the National Folk Festival; to the Wyndham Golf tournament; international events; commended staff for clean up efforts for the Folk Festival; voiced pride for the City; stated the 30th anniversary of the Blues Festival was coming; requested staff to focus on helping with that celebration; and spoke to receiving a plaque for Greensboro being a national NASCAR fan city.
