Council Chamber

Call to Order

This City Council meeting of the City of Greensboro was called to order at 4:00 p.m. on the above date in the Council Chamber of the Melvin Municipal Office Building with the following members present:

City of Greensboro, pursuant to G.S. 143-318.11(a) (3). The motion carried by voice vote.

Council recessed to closed session at 4:05 p.m.

Council reconvened into open session at 5:35 p.m. with all members in attendance.

Moved by Councilmember Abuzuaiter, seconded by Councilmember Hightower to return to open session. The motion carried by voice vote.

Moment of Silence

The meeting opened with a moment of silence.

Pledge of Allegiance to the Flag

Mayor Vaughan recognized Councilmember Barber to lead the Pledge of Allegiance to the Flag.

Recognition of Courier

City Manager Jim Westmoreland recognized Chris Johnson of the Fire Department who served as Courier for the meeting.

Moved and read into the record by Mayor Vaughan, seconded by Councilmember Hoffmann that pursuant to the Memorandum of Employment Agreement with City Attorney, entered into on October 1, 2014, that the Council set the City Attorneys salary at \$158,000 per year this will serve as a 3.9 percent merit increase. The salary adjustment shall be effective as of October 1, 2015 based on our evaluation. The motion carried by voice vote.

City Attorney Carruthers voiced appreciation for the confidence by Council; and stated he would continue to do his best.

0309-15 RESOLUTION HONORING THE MEMORY OF THE LATE DR. JOSEPHINE OPHELIA BOYD BRADLEY

WHEREAS, on September 15, 2015, this community lost one of its community leaders with the death of the late Dr. Josephine Ophelia Boyd Bradley at the age of 75;

WHEREAS, Dr. Bradley, a native of Greensboro was the first Black to integrate Greensboro (now Grimsley) High School;

WHEREAS, in 1957 Dr. Bradley graduated with honors as the first African-American person among 1,950 high school students;

WHEREAS, Dr. Bradley obtained a Bachelor of Arts in Political Science from North Carolina Central University, graduating Summa Cum Laude; a Masters in Social Work from Michigan State University; and a Masters in Woman's Studies and Ph. D. in African American Studies from Emory University;

WHEREAS, her professional career included being a social worker in East Lansing Michigan, a writer, board member, department head and educator for five Universities: Southern University Baton Rouge, Louisiana; Tusculum College Greeneville, Tennessee; Agnes Scott College, Morehouse College and Clark Atlanta University in Atlanta, Georgia;

WHEREAS, Dr. Bradley served in various capacities with organizations which included the Association of Social and Behavioral Scientists; National Council for Black Studies; Family Resource Center, DeKalb County; Lupus Research Team at Emory University; and was the founding Board Member of Hope Commitment Services;

WHEREAS, Dr. Bradley was a member of Alpha Kappa Alpha Sorority, Inc. and enjoyed traveling, reading and writing;

WHEREAS, the City Council wishes to express its sense of loss and its sincere appreciation and gratitude for the many years of dedicated public service rendered by Dr. Josephine Ophelia Boyd Bradley, the outstanding contributions she has made to the community, and the legacy she leaves.

WHEREAS, on June 18, 2015, this community lost one of its outstanding community leaders with the death of the late (Mary) Anita Caine Schenck at the age of 80;

WHEREAS, Ms. Schenck received a Bachelor of Arts in English Literature from Guilford College in 1987 and was awarded their Alumni Excellence Award for Humanitarian Service in 1990;

WHEREAS, Ms. Schenck was a founding member of St. Francis Episcopal Church, where she served as Sunday school teacher, Chair of the Episcopal Diocesan Convention, and Chair of the Annual Book Sale;

WHEREAS, Ms. Schenck was instrumental in the founding of Greensboro Day School, and chaired the Greensboro Public Library's Friends of the Library and Member Selection committees;

WHEREAS, her community involvement in numerous civic and local government organizations included: President of the Greensboro Junior League, Chair of Preservation Greensboro Incorporated, President of The Blandwood Guild, Director and Coordinator of The Guilford County American Revolution Bicentennial Commission (1974-1977), Chair of Guilford County Roanoke Voyages Program (1989), Guilford County Historic Properties Commission, and Chairman of the Board of Trustees for the Greensboro Historical Museum;

WHEREAS, Ms. Schenck was an advocate for education, historical preservation and community involvement;

WHEREAS, the City Council wishes to express its sense of loss and its sincere appreciation and gratitude for the many years of dedicated public service rendered by (Mary) Anita Caine Schenck, the outstanding contributions she has made to the community, and the legacy she leaves.

0311-15 RESOLUTION OF GRATITUDE TO THE PUBLIC ART ENDOWMENT

WHEREAS, the Public Art Endowment, an initiative of The Community Foundation of Greater Greensboro, provides public art to the citizens of Greensboro as a way of enhancing and building "community;" and

WHEREAS, the Endowment's recent project, Rise Together Greensboro, set out to "build community," literally and figuratively; and

Mayor Vaughan recognized Councilmember Fox to provide an update for the College Commission.

Councilmember Fox spoke to a commission retreat; and invited College Commission Chairperson Nate Cook to provide an update.

Mr. Cook provided a personal history; highlighted the events from the retreat; reviewed objectives; outlined the makeup of the commission; the five main areas of focus; spoke to job fairs; encouraging students to stay in Greensboro; Police and community relationships; voter engagement; getting information into the community; and thanked Council for the opportunity to provide an update.

II. PUBLIC COMMENT PERIOD

Donna Anderson, One Covey Lane spoke to the Guilford County Animal Shelter; voiced concern with Disabled American Veterans; spoke to moving from the Depot to Friendly Avenue; referenced the involvement of the State Department for misconduct; meetings with City staff; spoke to a change in leadership; and stated there were over 2500 members in Guilford.

Council discussed the Veteran concern being a state issue; the involvement of the City; and providing assistance to Veterans.

Assistant City Manager David Parrish spoke to a long term relationship; assisting with the transition; the lease agreement; criminal activities and violations; and providing housing for Veterans.

Albert White, 2003 Briar Run Drive provided a handout to Council; stated he represented the Benefits Veterans Network; spoke to feeding the homeless; housing for Veterans; City representatives visiting the organization; volunteer services; stated the mission was to serve Veterans; and invited Council to read the mission statement distributed.

Mayor Vaughan requested a copy of the handout to be provided to Neighborhood and Development Director Barbara Harris.

Luther Falls Jr, 1603 Landsdown Avenue spoke to the community having knowledge about the great people in Greensboro; referenced the resolution in honor of Dr. Josephine Bradley; the College Commission presentation; spoke to a Police and community forum on November 19th; a Health and Safety Fair by the Greensboro Police Department; one of the first African American fire fighters in Greensboro; highlighted the election on November 3rd; and spoke to the low turn out for the primary election.

WHEREAS, in connection with the Horse Pen Creek Road widening project, a portion of the property owned by Margaret P. Jessup, Parcels 0078232 and 0078223 is required by the City for said Project, said property being shown on the attached map;

WHEREAS, the required property has been appraised at a value of \$101,320 but the property owner has agreed to settle for the price of \$118,000, which settlement, in the opinion of the City Council, is a fair and reasonable alternative to condemnation;

5. <u>ID 15-0890</u> Resolution Authorizing an Amendment to a Contract with Patriot Services of Greensboro for Various Temporary Labor Services

0313-15 RESOLUTION AUTHORIZING AN AMENDMENT TO A CONTRACT WITH PATRIOT SERVICES OF GREENSBORO FOR VARIOUS TEMPORARY LABOR SERVICES

WHEREAS, the Field Operations Department is responsible for various operations to maintain City streets and facilities; and

WHEREAS, the Field Operations Department has a current contract for temporary labor services to assure that services including loose leaf collection and solid waste operations are adequately performed; and

WHEREAS, in fiscal year 2010-11 services for a five-year contract for Temporary Labor Services were solicited by the Purchasing Division on behalf of the Field Operations Department; and

WHEREAS, a contract was awarded to a single vendor, Patriot Services of Greensboro, a HUB certified Minority Business Enterprise; for an estimated amount of that has totaled up to \$450,000 annually during the five-year contract term.

WHEREAS, the Centralized Contracting Division and Field Operations Department concur in this recommendation to amend the current agreement to be extended through June 30, 2016 and to fund the agreement through the extension for an estimated amount of \$350,000; and

WHEREAS, to accommodate this process, the recommended schedule to begin new annual contracts is at the start of next fiscal year on July 1, 2016; and

WHEREAS, to assure sufficient time for development and conduct of an updated solicitation to cover these services for the next one to five years, the Department and Centralized Contracting Division recommend the following amendments to the current agreement:

- 1) The agreement shall remain in effect through June 30, 2016.
- 2) Funding for this agreement shall be increased in the estimated amount of \$350,000 to
- pay for costs through the extended contract term.
- 3) Funding for this agreement amendment is available in the current fiscal-year budget.

WHEREAS, perfluorooctanesulfonate (PFOS) has been detected in the City's finished water through sampling performed as required under the Environmental Protection Agency's Third Unregulated Contaminant Monitoring Rule (UCMR3);

WHEREAS, the Water Resources Department desires to complete an investigation to ascertain potential sources of PFOS, confirm concentrations of PFOS and other perfluoroalkyl substances (PFASs) in the water supply watershed, and evaluate treatment options that may be considered in the future;

WHEREAS, HDR Engineering, Inc. of the Carolinas has offered to provide the required work for the perflourooctanesulfonate (PFOS) Water Supply Watershed Investigation in the amount of \$143,921.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That the City is authorized to enter into a contract with HDR Engineering, Inc. of the Carolinas for the perflourooctanesulfonate (PFOS) Water Supply Watershed Investigation subject to the terms outlined above. WHEREAS, Water Resources Department is ready to proceed with design phase services for two new water booster stations, with one located at Groometown Road Tank in the City's Main Pressure Zone in order to improve storage tank utilization, and the second located in the vicinity of McCloud Road in order to replace the Regional Road booster station which, due to its location, cannot fully support the entire West Pressure Zone;

WHEREAS, the City Council awarded Contract 2011-062 for the construction of the Mitchell Water Treatment Plant Clearwell Replacement to DH Griffin Construction in the amount of \$5,604,000 on August 18, 2015;

WHEREAS, construction administration services including onsite observations of the work and field check of materials and equipment for the construction of the Clearwell Replacement project are needed;

WHEREAS, CDM Smith, Inc. was selected because of previous design, permitting and bidding assistance of civil, process and finished water storage improvements for the project.

WHEREAS, Guilford County approved an initial appropriation of funding for fiscal year 2015-16 to the City in the

amount of \$1,302,286; and

WHEREAS, based on the formula, the County has appropriated an additional amount for fiscal year 2015-16 not to exceed \$54,561, and

WHEREAS, this interlocal agreement amendment is made as a supplement to the Guilford County Interlocal Agreement on Public Libraries, Contract 36460-03/11-171 and shall not supersede the Interlocal Agreement or vice versa; and

WHEREAS, in consideration for the City's Library Services, the County will pay the lump sum of \$54,561 under the terms of this interlocal agreement for fiscal year 2015-16 by December 31, 2015. This will increase the original Guilford County allocation from \$1,302,286 to \$1,356,847; and

WHEREAS, North Carolina General Statutes require approval of this contract by the Greensboro City Council as the governing board.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

Discussion ensued regarding a 10 minute presentation; the number of speakers to the item; and the time limit per speaker.

Emily Tyler, 6201 Bards Lane, made a PowerPoint Presentation (PPP); spoke to the neighborhood being trapped; referenced the railroad crossing; and provided the history of the neighborhood development

Patti Frascone, 2305 Farm Gate Road continued the PPP; highlighted runoff concerns; spoke to a City owned abandoned home; Greensboro United Soccer Association (GUSA) cited safety concerns; lighting and sound systems; relocation of fields; a second access road; tournament plans; and the potential for accidents.

Councilmember Wilkins spoke to the location of the homes in relation to the City limits; and recognized all the speakers were from Browns Summit.

Mayor Pro-Tem Johnson inquired about the City owned property; and about how quickly the property issues could be addressed.

Parks and Recreation Director Wade Walcutt stated he would speak to the Fire Department about a possible burn project.

Councilmember Hightower spoke to the abandoned property; inquired about relocation of the fields; spoke to railroad schedules for the area; voiced concerns with the location of the railroad to the neighborhood; spoke to the potential for additional accesses; inquired about widening the road; and about buffers.

Mr. Walcutt confirmed ownership of the property; spoke to looking into a demolition or burn project; referenced adjustments made after conversations with with residents; researching an additional access road; the Technical Review Committee; the availability of first responders; addressing parking and traffic concerns; and confirmed staff would look into buffer options.

Councilmember Barber left the meeting at 6:52 p.m. and returned at 6:55 p.m.

City Manager Westmoreland provided information on train schedules.

Trish McDermott, 2400 Farm Gate Road stated she was the Neighborhood Association President; provided a brief history to her knowledge of the project; continued the PPP; highlighted the one access point; spoke to hotel and food location in comparison to the soccer fields; suggested another location; and referenced the trees that would have to be removed.

Keith Wilde, 2306 Farm Gate Road continued the PPP; voiced excitement for the idea of the project; spoke to other Greensboro projects; the entrance to the soccer field; ownership of the property; a National impact; safety concerns; and the use of caution tape to block off parking.

Council discussed the use of caution tape; about the location of parking; and the use of a shuttle.

Mr. Walcutt spoke to parking concerns; stated staff would be working with local businesses for additional parking solutions; and that the staff presentation prepared for Council had been shared with the neighborhood.

Ronnie Jefferson, 2508 Farm Gate Road continued the PPP; stated the major concern was safety; referenced other cities that had implemented shuttles as options; spoke to the location of the railroad tracks; the buffers; and referenced the number of people killed by trains.

Councilmember Hoffmann stated the Wyndham offered shuttle rides as the only access to the golf tournament.

Claude F. Devashia, Jr, 2506 Farm Gate Road continued the PPP; reiterated traffic and parking concerns; spoke to the Bryan Park Wildlife refuge; the use of the abandoned home property for fields; requested the item be tabled so the neighborhood could meet with the Parks and Recreation Commission; referenced Sunday morning traffic issues; and voiced preference for a berm rather than a wall.

Mr. Walcutt spoke to a regional concept; community conversations and feedback; addressing concerns; additional ideas; the Parks and Recreation Commission meeting on August 12th; the item being vetted through the General Government and Community Services Committees; and to the referral to Council.

Councilmember Fox spoke to the location of the project to District 2; stated he had not heard from residents; referenced community conversations; spoke to addressing concerns; referenced the history being vetted at a work session and the Council committees; requested staff to work with the residents; and encouraged Council to move the project forward.

Councilmember Hightower voiced her concerns with the item; stated she would like to see issues addressed; spoke to quality of life; and inquired about the timeline for the project.

Mr. Walcutt voiced there was a second access road through the golf course.

Councilmember Hoffmann referenced Greensboro being a primary destination; long range plans; voiced Greensboro could not lose the opportunity; spoke to economic development; tourism; being attentive to safety concerns; and stated she would like to see the abandoned home addressed immediately.

Mayor Vaughan requested that Mr. Walcutt continue his community involvement.

Mayor Pro-Tem Johnson requested staff to provide an update on the house; and the potential use of the space for fields.

Mr. Walcutt confirmed he would keep the community informed.

WHEREAS, Greensboro United Soccer Association (GUSA; formerly Greensboro Youth Soccer Association) has operated the Bryan Park Soccer Complex through contractual agreements with the City of Greensboro since at least 1984;

WHEREAS, through the existence of this public-private partnership, GUSA has previously made significant improvements to the Bryan Park site valued in excess of \$2,700,000;

WHEREAS, GUSA continues to demonstrate its commitment to inclusion and to reducing financial barriers to playing soccer and has become one of the most diverse soccer clubs in North Carolina;

WHEREAS, together with the support of the City's Parks and Recreation Department and the Greensboro Convention and Visitors Bureau, GUSA wishes to make improvements to the Bryan Park Soccer Complex to better serve the growing demand for soccer in the Greensboro community and to attract national tournaments generating additional significant economic impact for Greensboro;

WHEREAS, the total projected cost of the proposed improvement/expansion project is estimated to be \$4,500,000, and pending approval of this resolution the City's contribution towards the project would be \$1,000,000, representing approx. 22% of the total cost of the project and secured through a reallocation of Parks and Recreation bond funding;

WHEREAS, completion of the project will enable Bryan Park to become eligible to host large regional and national soccer tournaments projected to bring in an additional \$13-18,000,000 in economic impact to Greensboro;

Dolce Ortiz, 2800 Forbes Drive thanked Council for consideration of the resolution; stated the HB would not be good for the community; spoke to the immigrant community; parentless children; a safe community; and voiced the bill did not represent what the community stood for.

Jose' F. Oliva, 2506 Kilbourne Drive, Guilford College Student Body President requested Council to oppose HB 318; referenced an economic development issue in Alabama; spoke to the number of people coming into the City; International business leaders; and to helping people rise from the poverty line.

Mayor Pro-Tem Johnson thanked Mr. Oliva for serving in the International Advisory Committee.

Erencira Mendez, 3007 South Elm Eugene Street thanked Council for consideration of opposition to the HB; stated her daughter wanted to become a police officer; spoke to parents feeling empowered to raise law abiding citizens; and to a better future.

Zac Engle, 405 Hammel Road voiced appreciation of the International Advisory Commission (IAC); recognized members in attendance; urged Council to support the resolution; spoke to a refugee community; to long time residents that did not have citizenship; to a broken system; referenced Faith Action; and spoke to obstacles immigrants faced when trying to obtain water service, birth certificates, and marriage licenses.

Sarah Rawleigh Immigrant Assistance Manager at Faith Action spoke to a welcoming City that valued immigrants; the Faith Action ID program; stated the bill had negative consequences; and urged Council to pass the resolution.

Yubisela Aronda Sandaral, 1202 Quail Drive thanked Council for considering the resolution; spoke to a welcoming community to immigrants; a broken immigration system; stated HB 318 impacted her family; referenced struggles in other counties; and spoke to being raised with morals and responsibilities.

Councilmember Wilkins spoke to the item as an emotional issue; voiced that Council action would not impact the bill which had already passed; referenced a quote that the bill would not effect anyone in the country legally; and voiced he would not support the resolution.

Councilmember Abuzuaiter thanked the speakers; spoke to Veterans; immigrant documentation; assisting with the process; referenced a better quality of life; spoke to the Stranger to Neighbor resolution; International Advisory Committee; a bad economy; voiced her passion for the item; and encouraged Council to oppose the bill.

Mayor Pro-Tem Johnson spoke to ethnic groups; heroic acts of Veterans; referenced segregation; spoke to change; and to embracing the community.

Mayor Vaughan voiced her support of the resolution; stated Greensboro had been targeted by the Legislature; spoke to Faith Action; health care; City services; police interactions; the value of documentation; and Greensboro being a leader for change.

Councilmember Fox spoke to doing what was right for history; and to making an impact for people Council represented.

Councilmember Hightower voiced her dismay with the State of North Carolina; referenced Veterans need to survive; spoke to the speakers regarding Veteran organizations; status of Senate Bill 36; and to doing the right thing.

Councilmember Barber spoke to a collaborative effort; referenced presidential debates; quoted Jefferson; stated the system was broken; and voiced his support.

Councilmember Hoffmann referenced an African prayer; and spoke to issues worth fighting for.

Councilmember Abuzuaiter provided a brief history of the item; and referenced Councilmember Wilkins support of public safety.

0337-15 RESOLUTION IN OPPOSITION OF HOUSE BILL 318: PROTECT NORTH CAROLINA WORKERS ACT

WHEREAS Greensboro, North Carolina has been regarded as a community that values and supports access to and the distribution of resources that enable all residents, regardless of employment, economic, familial, or residential status to live healthy and productive lives; and

WHEREAS Greensboro, North Carolina has been regarded and lauded as a welcoming community for resettlement of immigrants and refugees for the past forty or more years resulting in Guilford County Schools having residents who have immigrated to our community representing more than 79 different countries and who speak nearly 100 different world languages and dialects; and

WHEREAS Greensboro is the leading community in the state legitimizing a form of ID that grants access to city services for all community members regardless of residential status, thereby encouraging the acceptance of the ID across other industries in the city to include banking; and

WHEREAS immigrant and refugees arrive with the understanding that Greensboro is a city that supports opportunity for all residents to thrive economically, access to public safety, and holds the welfare of those who work and play in our community in high regard; and

WHEREAS the Faith Action ID is the locally generated, City-supported ID for all residents in the community, which affords access to water resources, parks and recreation services, local events, and serves as a valid ID for our local law enforcement; and

WHEREAS the Greensboro Human Relations Commission heard the concerns of the community at large, during an HRC meeting, regarding the development of House Bill 318: Protect North Carolina Workers Act, which limits access to Supplemental Nutrition Assistance Program benefits as well as the use of the Faith Action ID to law enforcement interactions which require the presentation of a valid ID, but prohibits use for any other city services; and

WHEREAS the Human Relations Commission recognizes the detriment of restricting SNAP benefits, which are essential to emancipated youth, veterans, college students, and homeless populations, who rely upon those benefits to maintain health and wellness, so that they can lead well-rounded and productive lives; and

WHEREAS the Human Relations Commission recognizes the detriment of restricting the validity of the Faith Action ID, thereby jeopardizing the overall wellbeing of any resident who relies solely on the local ID to access basic resources, voted unanimously in favor of opposing House Bill 318; and

WHEREAS Council recognizes the city's core mission to make Greensboro a community where all residents can access basic resources to include, public safety, a healthy living environment, and the ability to engage in work and play; and

WHEREAS Council recognizes the negative economic impact of legislation which prohibits any contributors to the city's economic engine who live, work, and play, in Greensboro, from using the Faith Action ID to access resources;

WHEREAS, City Council recognizes the concerns coming from the Greensboro Human Relations Commission and supports their request to urge North Carolina Governor Pat McCrory to veto the legislation prohibiting the use of locally-generated and city-supported forms of identification, thereby enabling the City to continue to accept the Faith Action ID.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That it hereby supports the Greensboro Human Relations Commission's request to respectfully urge North Carolina Governor Pat McCrory to veto the legislation prohibiting the use of locally-generated and city-supported forms of identification, thereby enabling the city to continue to accept the Faith Action ID, so that residents may exercise the liberty to access basic needs, further upholding the commitment make Greensboro a community where any resident can work, play and thrive.
