Meeting Minutes - Final City Council

Tuesday, March 7, 2017 5:30 PM Council Chamber

Call to Order

This City Council meeting of the City of Greensboro was called to order at 5:30 p.m. on the above date in the Council Chamber of the Melvin Municipal Office Building with the following members present:

Present: 9 - Mayor Nancy Vaughan, Mayor Pro-Tem Yvonne J. Johnson, Councilmember Mike Barber, Councilmember Marikay Abuzuaiter, Councilmember Jamal T. Fox, Councilmember Sharon M. Hightower, Councilmember Nancy Hoffmann, Councilmember Justin Outling and Councilmember Tony Wilkins

Also present were City Manager Jim Westmoreland, City Attorney Tom Carruthers, and Deputy City Clerk Angela R. Lord.

Moment of Silence

The meeting opened with a moment of silence.

Pledge of Allegiance to the Flag

Councilmember Hoffmann recognized Girl Scout Troop # 2483 to lead the Pledge of Allegiance to the Flag.

Recognition of Courier

City Manager Jim Westmoreland recognized Alyssa Talatzko of the Libraries Department who served as Courier for the meeting.

Council Procedure for Conduct of the Meeting

Mayor Vaughan explained the Council procedure for conduct of the meeting.

I. CEREMONIAL AND/OR PRESENTATION ITEMS

There were no Ceremonial or Presentation items for this agenda.

II. PUBLIC COMMENT PERIOD

Ben Holder, 1306 Oak Street spoke to legal fees and settlement of cases; referenced the David Wray case; and spoke to transparency.

Councilmember Wilkins asked for clarification on statements by the speaker; justification of legal fees; and spoke to settlement of cases to avoid legal fees.

City Attorney Carruthers spoke to public records; referenced statements by Mr. Holder; clarified the City's position on legal cases; and provided the history of the Wray case.

Mayor Vaughan referenced previous Council discussions regarding the case; and spoke to former employee actions being outside the scope of employment.

Discussion ensued regarding the position of the City of Greensboro; closed session votes; Mr. Wray's employment history; decisions based on principles; and City policies.

Robert Moore. 511 Martin Street voiced appreciation to Council, City Attorney Carruthers, and staff for assistance in a matter.

Irvin Allen, 1209 Hawerhill Drive voiced concerns regarding a recent incident involving a 15-year-old and the police; alleged police brutality; spoke to the court system process; review of body worn camera footage; and requested Council release said footage.

Councilmember Hightower referenced an upcoming meeting of the Police Community Review Board (PCRB). Moved by Councilmember Hightower, seconded by Mayor Pro-Tem Johnson for Council to review the footage after the PCRB review of the case. Councilmember Hightower spoke to timeframe requirements for review of the case; and to Council recommendations to the committee.

Discussion took place regarding Council allowing the PCRB to complete the review process; recent changes to the process; tracking cases; staff attending the upcoming meeting and reporting back to Council; and the option for Council members to attend said meeting.

City Attorney Carruthers spoke to the need for a formal motion; outlined the process of the PCRB; spoke to the confidentiality of the process; and to Council allowing the process to play out.

Discussion continued regarding staff recommendations to Council to allow the completion of the process by the PCRB; review of the video; Council speaking with the mother of the minor child; and respecting the process of the PCRB.

Councilmember Abuzuaiter asked for clarification of when the Complaint had been filed.

Director of Human Relations, Love Crossling confirmed the Complaint had been filed in December 2016; and spoke to the challenges faced by the PCRB to review the footage.

Councilmember Outling requested staff to research the process of the release of body worn camera footage for the PCRB without having to go through the court system.

Isa Abuzuaiter, 3601 Brass Field Oak Drive voiced appreciation for the railroad safety meeting; spoke to railroad safety concerns; and commended the City's initiative to discuss ideas.

Councilmember Hightower requested staff to run the railroad safety meeting on the Greensboro Television Network.

Councilmember Abuzuaiter requested staff to relay train safety information to the public.

Nelson Johnson, 2115 Murreyhill Road voiced concerns with the recent incident between the police and a 15-year-old minor child; requested Council review body worn camera footage; provided details of video footage that he had seen; spoke to assault charges on the teen; and voiced concerns the with District Attorney.

Discussion ensued regarding the meeting schedule of the PCRB; delays and organization of the Committee; the mission and focus of the PCRB and the Human Relations Commission (HRC); and the legal advice received.

C. J. Brinson, 504 Gorrell Street voiced concerns with repetitive issues; spoke to the need for Council to protect people of color; to police conduct and brutality; to the need for action; voiced concerns with the Police Department and the District Attorney's office; requested Council to release the body worn camera video; and spoke to transparency.

Lewis Pitts, 129 Tate Street referenced conversations with the family of the minor child involved in the incident; issues concerning the case; spoke to the Cole/Yourse case; referenced conversations in closed session meetings; spoke to staff attending the PCRB meeting; to the Legislative Agenda; and to advocating for change in the law regarding body worn camera footage.

Nego Crosson, 1005 Lexington Avenue voiced concerns with the incident referenced by previous speakers; spoke to her work as a registered nurse; voiced concerns with police accountability; requested Council to review the body worn camera video; and spoke to the process of reviewing videos.

Councilmember Hightower reiterated her request to make a motion; spoke to the need to inform the community of Council's action; Council waiting for the process completion of the PCRB; and expressed the need to vote on the motion to avoid having to discuss the matter again.

Moved by Councilmember Hightower, seconded by Mayor Pro-Tem Johnson that Council should inspect in closed session the body worn camera footage, which had been released pursuant to G.S. 132-1.4A, and the investigative file of the arrest of the minor child of Tamara R. Figueroa that occurred on July 4, 2016 which is necessary and essential to the proper function of Council to inspect.

Council discussed the community volunteers serving on boards; and the charge given to the board members.

Councilmember Outling and Wilkins voiced they would not support the motion.

Councilmember Barber asked Councilmember Hightower to entertain a friendly amendment to include that Council would review the video after the PCRB had completed it's process.

Councilmember Hightower stated she would accept the friendly amendment to include reviewing the video after the complete process had been finalized by the PCRB.

Discussion continued regarding concerns with the motion; the charge given to the PCRB; the amendment to the motion; previous votes in favor of the purchase of body worn cameras; clarity of the motion; the PCRB vetting the case; and having confidence in people..

Councilmember Hightower stated the motion stood as amended; and called the question.

Moved by Councilmember Hightower, seconded by Mayor Pro-Tem Johnson that Council should inspect in closed session the body worn camera footage, which had been released pursuant to G.S. 132-1.4A, and the investigative file of the arrest of the minor child of Tamara R. Figueroa that occurred on July 4, 2016 which is necessary and essential to the proper function of Council to inspect following the completed PCRB process of the case. The motion carried on the following roll call vote:

43-17 RESOLUTION CALLING A PUBLIC HEARING FOR MARCH 21, 2017 ON THE ANNEXATION OF TERRITORY TO THE CORPORATE LIMITS – PROPERTY LOCATED AT 1302 YOUNG'S MILL ROAD – .98 ACRES

WHEREAS, the owner of all the hereinafter described property, which is non-contiguous to the City of Greensboro, has requested in writing that said property be annexed to the City of Greensboro;

WHEREAS, Chapter 160A, Section 58.1 of the General Statutes of North Carolina provides that territory may be annexed after notice has been given by publication one time in a newspaper of general circulation in the city;

WHEREAS, at a regular meeting of the City Council on the 7th day of March, 2017, the following ordinance was introduced:

AN ORDINANCE ANNEXING TERRITORY TO THE CORPORATE LIMITS (PROPERTY LOCATED AT 1302 YOUNG'S MILL ROAD – .98 ACRES)

Section 1. Pursuant to G.S. 160A-58.1, the hereinafter described territory is hereby annexed to City of Greensboro:

Beginning at a point in the existing Greensboro corporate limits (as of December 31, 2016), said point being the southwest corner of that property shown on City of Greensboro Annexation Drawing D-2761; THENCE PROCEEDING WITH THE EXISTING CITY LIMITS N 08° 31' 45" W 47 feet to a point; THENCE DEPARTING FROM THE EXISTING CITY LIMITS in a westerly direction, crossing Young's Mill Road, approximately 60 feet to an existing concrete monument at the northeast corner of Jesse C. and Laura M. Chambers, as recorded at Deed Book 3059, Page 879 in the Office of the Register of Deeds (this property is shown on Drawing G-552C, which is filed with the City of Greensboro's Engineering and Inspections Department, Records Section); thence with the north line of Chambers S 81° 04' 35" W 155.35 feet to a point; thence continuing with said line S 81° 06' 45"W 44.69 feet to the northwest corner of Chambers; thence with the west line of Chambers S 08° 55' 50" E 200.05 feet to an existing concrete monument at the southwest corner of Chambers; thence with the south line of Chambers N 81° 02' 06" E 199.92 feet to the southeast corner of Chambers; thence with the east line of Chambers N 08° 53' 38" W 153 feet to a point; thence in an easterly direction, crossing Young's Mill Road, approximately 60 feet to the point and place of BEGINNING, containing approximately 0.98 acres, of which approximately 0.92 acres is outside street right-of-way.

Section 2. The owner agrees to pay to the City of Greensboro an acreage fee of five hundred eighty dollars (\$580.00) per acre for water service and five hundred eighty dollars (\$580.00) per acre for sewer service immediately prior to the time of annexation, provided that each of these utilities are available at the time of annexation. Any utility line assessments which may have been levied by the County shall be collected either by voluntary payment or through foreclosure of same by the City. Following annexation, the property annexed shall receive the same status regarding charges and rates as any other property located inside the corporate limits of the City of Greensboro.

Section 3. The owner shall be fully responsible for extending water and sewer service to the property at said owner's expense.

Section 4. From and after the effective date of annexation, the above described territory and its citizens and property shall be subject to all debts, laws, ordinances and regulations in force within the City and shall be entitled to the same privileges and benefits thereof, subject to the provisions in Sections 2 and 3 above.

Section 5. From and after March 21, 2017, the liability for municipal taxes for the 2016-2017 fiscal year shall be prorated on the basis of 3/12of the total amount of taxes that would be due for the entire fiscal year. The due date for prorated municipal taxes shall be September 1, 2017. Municipal ad valorem taxes for the 2017-2018 fiscal year and thereafter shall be due annually on the same basis as any other property within the city limits.

Section 6. That this ordinance shall become effective upon adoption.

WHEREAS, the GTA Board approved the award of the contract to Transportation Management and Design (TMD) at their meeting on January 24, 2017;

WHEREAS, the plan is to be funded from the FY2017 FTA Section 5303 Planning Grant and local operating funds.

City Attorney Carruthers spoke to the process of the draft agendas.

Councilmember Outling spoke to his family history; problem solving; referenced his support of the tuition assistance item; body worn cameras; voiced concern with a Legislative Agenda; referenced staff dialogue with the General Assembly; stated he would not put politics over achieving goals; and spoke to voting against the Legislative Agenda.

Mayor Pro-Tem Johnson left the meeting at 6:53 p.m. and returned at 6:55 p.m.

Councilmember Hightower spoke to the purpose of the Legislative Agenda; voting on the items independently;

voiced concerns with item #2; asked about vehicle registration; and to enforcement of parking tickets.

Discussion took place regarding vehicle registration in other municipalities; collection of unpaid parking tickets; and students in the public school system since kindergarten.

Councilmember Wilkins reitereated concerns with item #9; and voiced he would not support the item if the language was not included that had been on the draft Legislative Agenda.

City Attorney Carruthers spoke to the will of Council to amend wording of any item.

Moved by Councilmember Outling, seconded by Councilmember Wilkins to deny the adoption of the Legislative Agenda, to communicate with the General Assembly to acheive all the objectives outlined on the Legislative Agenda, and to disengage work with the lobbyist.

Discussion continued regarding conversations with the General Assembly; review of the Legislative Agenda by the lobbyist; the process used by the General Assembly to review agendas; the time and work contributed by the staff on the item; the importance of the lobbyist weighing in on the agenda; community concerns; and the need for instate tuition.

Councilmember Wilkins asked for confirmation that the lobbyist had reviewed the Legislative Agenda as presented tonight; and that there were no red flags from items on the agenda.

City Attorney Carruthers stated staff would research if the lobbyist had seen the lastest revision of the agenda.

Moved by Councilmember Outling, seconded by Councilmember Wilkins, to deny the adoption of the Legislative Agenda, to communicate with the General Assembly to acheive all the objectives outlined on the Legislative Agenda, and to disengage work with the lobbyist. The motion FAILED on the following roll call vote:

1. ENVIRONMENT/JORDAN LAKE: Greensboro is now completing a \$120M upgrade to its wastewater treatment facilities to meet its obligations to its partners in the Jordan Lake basin. Section 15A NCAC 02B .270 (10) (h) of the rule for nutrient discharges requires the purchase of nutrient offsets in case of an exceedance, which is not a requirement for Greensboro's NPDES permit. Therefore, Greensboro requests the General Assembly remove the requirement to purchase nutrient offsets from the Jordan Lake rules.

Moved by Mayor Pro-Tem Johnson, seconded by Councilmember Outling, to adopt Item #1 of the Legislative Agenda. The motion carried on the following roll call vote:

Councilmember Hightower asked for clairification on the item.

Mayor Vaughan spoke to a local ordinance; and to encouraging the state to be in alignment with the City.

Supreme Court Chief Justice Mark Martin, who convened an independent commission to study this issue. Senate Bill 146 has been introduced to address this matter.

- 7. REPAIR OF NONRESIDENTIAL BUILDINGS AND RE-WRITE OF PLANNING STATUTES. A newly created Chapter 160D would reorganize city and county planning and development statutes. This re-write is spearheaded by the NC Bar Association, along with the NC League of Municipalities and the UNC School of Government, and it has support from local governments across the state. One of the modifications allows a municipality to order

repairs of nonresidential buildings in designated zoning districts.

Moved by Councilmember Outling, seconded by Councilmember Fox, to adopt Item #7 of the Legislative Agenda. The motion carried on the following roll call vote:

Although Greensboro's fees are valid, this amendment will correct the loophole created by the recent Quality Built Homes v. Town of Carthage case which invalidated certain fees charged by cities.

Moved by Mayor Pro-Tem Johnson, seconded by Councilmember Hoffmann, to adopt Item #8 of the Legislative Agenda. The motion carried on the following roll call vote:

Councilmember Wilkins stated he would like to entertain a substitute motion for the item.

City Attorney Carruthers clarified the motion to amend would be appropriate, with the amendment language being "to revert to the original language stating that this benefit is only for those students that have begun the formal process of applying for United States citizenship".

Councilmember Hoffmann asked for clarification on the addition of the language.

City Attorney Carruthers spoke to information regarding undocumented students not having the ability to apply for citizenship; and stated the amendment would exclude those students from the item.

Moved by Councilmember Wilkins, seconded by Councilmember Barber to amend item #9 as said by City Attorney Carruthers. The motion FAILED by a voice vote of 1 - 8; with Councilmember Wilkins voting 'Yes'.

Moved by Councilmember Abuzuaiter, seconded by Mayor Pro-Tem Johnson, to adopt Item #9 of the Legislative Agenda. The motion carried on the following roll call vote:

These funds will be used by local governments to supplement the expenses to purchase and maintain equipment to ensure the viability of search and rescue services. Rep. Hardister introduced HB 189 this session to address this matter, and Greensboro requests that the General Assembly support the bill.

Moved by Councilmember Wilkins, seconded by Councilmember Outling, to adopt Item # 10 of the Legislative Agenda. The motion carried on the following roll call vote:

GREENSBORO CHAMBER OF COMMERCE:

The City of Greensboro adopts the Legislative Agenda for the Greensboro Chamber of Commerce which identifies priority items and support items. The highlights are as follows:

- 1. Workforce Development. Create a pipeline of skilled manufacturing workers by supporting apprenticeship programs and expanding recruiting efforts and training programs.
- 2. MegaSite Infrastructure. Request that the General Assembly activate and fund the Site Infrastructure Development Fund with \$50M to promote sites such as the Megasite as "site ready."
- 3. High Point Market. Request continued funding of \$1,2000,000 for transportation and \$1,755,472 for marketing and for those funds to be included in the 2017-2019 budget as recurring funds.
- 4. Effective Water Quality Management: Request the continuation of two current studies and the overhaul of statewide Stormwater Basin Nutrient Management Rules. This would enable the building of multi-acre buildings in the Triad so the region can build the manufacturing sites that the 21st century requires.
- 5. Aviation. Seek continuation of planned funding and a commitment to the success of local and regional airports.
- 6. Transportation. Seek continued investment in transportation infrastructure to support job growth. Seek a continuation of planned funding for the Greensboro Urban Loop to ensure its completion in 2020.

Moved by Councilmember Fox, seconded by Councilmember Hoffmann, to adopt the Greensboro Chamber of Commerce Legislative Agenda. The motion carried on the following roll call vote:

Moved by Councilmember Barber, seconded by Mayor Pro-Tem Johnson to amend the resolution by removing language from paragraph six. Councilmember Barber spoke to the removal of jurisdictional responsibility and science based detail.

Councilmember Abuzuaiter voiced concern with last minute items; referenced discussions over the past couple of weeks; spoke to the Federal Clear Water Act; jurisdictional nutrients; staff research; the need for clean water; referenced an adopted resolution from 2015; asked if the City had maintained membership with the Haw River Nutrient Compliance Association; and spoke to the need to save money.

City Attorney Carruthers spoke to creating dialogue with the General Assembly and Senator Trudy Wade regarding the Jordan Lake rules; regulations on water levels; required mandates effective in 2021; compliance with regulations; stormwater mandates; the passing of a bill in 2016 by the General Assembly in which the resolution was drafted after; stated the resolution language was appropriate based on conversations with Senator Wade; spoke to funding and science support; and stated Senator Wade had expressed appreciation for the resolution but clarified it had been the General Assembly that had taken action.

Discussion took place regarding the clarity of the item; concerns in regards to the Haw River Nutrient Compliance Association; compliancy in 2021; the number of versions of the resolution; set back requirements; and the requirement for developers to spend more in Greensboro than in other counties.

Moved by Councilmember Barber, seconded by Mayor Pro-Tem Johnson, to adopt the resolution as amended. The motion carried on the following roll call vote:

49-17 RESOLUTION THANKING THE GENERAL ASSEMBLY AND SUPPORTING THE DEVELOPMENT OF A NEW COMPREHENSIVE NUTRIENT MANAGEMENT REGULATORY FRAMEWORK

WHEREAS, the Jordan Lake Rules mandate reducing nutrients from point source wastewater discharge and non-point source stormwater runoff in both new and existing development in the Jordan Lake Watershed; and

WHEREAS, these rules were enacted in 2009 and last amended in 2016 by adoption of session law 2016-94: Development of New Comprehensive Nutrient Management Regulatory Framework; and

WHEREAS, it is necessary for the State to have a comprehensive management strategy to protect and improve water quality; and

WHEREAS, over the last 20 years, comprehensive watershed nutrient management strategies and buffer rules have been implemented in several river basins and watersheds in North Carolina where surface water quality has been impaired by excess nutrients; and

WHEREAS, it is in the interest of the State to review the costs and benefits of existing nutrient management strategies and determine whether those nutrient management strategies should be modified in order to maintain and improve water quality in nutrient sensitive waters; and

WHEREAS, the City of Greensboro supports the General Assembly's effort to ensure the Jordan Lake Rules are science-based and equitable with clear and achievable goals. The absence of clear, science-based rules for protecting our water is arbitrary, inequitable, and harms the business community and the economic future of all our citizens; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO THAT:

The City of Greensboro thanks the General Assembly for the recent enactment of Session Law 2016-94 and agrees that the State should promote proven measures, incorporate new technological and management innovations, recognize previous investments in water quality, and ensure that costs are shared equitably.
