WHEREAS, in 2003 the City purchased the Customer Information and Billing System (enQuesta) from Systems and Software;

WHEREAS, the original Contract No. 2003-1295 requires annual maintenance agreements for continued use of the software;

WHEREAS, Systems and Software is the only company that can provide the maintenance;

WHEREAS, the cost of the annual maintenance agreement will be \$515,722.26 and includes technical support and maintenance releases;

WHEREAS, a sole source purchase from Systems and Software is being requested to ensure maintenance to the enQuesta system used by the City; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That the sole source purchase of \$515,722.26 for the upgrade to the enQuesta system used by the City is hereby approved.

WHEREAS, the City conducted a request for proposals for non-profit HUD-certified housing counseling agencies to provide homebuyer counseling, loan underwriting and processing services, and lender training for the City's HousingConnect GSO homebuyer assistance programs;

WHEREAS, the City and Guilford County have authorized an additional homeownership program that will utilize funding from the Guilford County HOME program grant funds through the HOME Program Consortium to assist new homebuyers in Guilford County outside the cities of Greensboro and High Point, which will be included in the services provided under the contract award;

WHEREAS, Housing Consultants Group is the selected provider and will provide initial housing counseling sessions, loan underwriting and processing services, and quarterly lender training on loan package submittals and program processes for the City and Guilford County programs;

WHEREAS, the contract with Housing Consultants Group is for \$101,000.00 for one year with up to two additional one year extensions; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That City Council authorizes professional services agreements with Housing Consultants Group totaling \$101,000.00 for a one year term, with up to two additional one year extensions, for homebuyer counseling, loan underwriting and processing services, and lender training for the HousingConnect GSO and Guilford County homebuyer assistance programs, and the City Manager is authorized to execute the agreements.

WHEREAS, the State of North Carolina issued a Request for Applications for HIV Patient Management Model Networks of Care asking for regional HIV/AIDS services agencies to align themselves in a services network under one administrative organization for HIV/AIDS pass through funding;

WHEREAS, Central Carolina Health Network was selected by the state as the Project Sponsor for the Region 4 network of HIV/AIDS services agencies through fiscal year 2020;

WHEREAS, it is in the City's interest to maintain the collaborative network model established by the State of North Carolina and utilize Central Carolina Health Network as the Project Sponsor in the network administrator role for the HOPWA funds for fiscal year 2020;

WHEREAS, City Council is requested to approve a professional services agreement with Central Carolina Health Network for \$419,625 in HOPWA grant funds, with administration limited to 7 percent of the grant and with a contract start date of October 1, 2019; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That the City Manager is hereby authorized to enter into a professional services agreement with Central Carolina Health Network for \$419,625 in Housing Opportunities for Persons with AIDS [HOPWA] grant funds.

WHEREAS, Water Resources requests approval to pursue and negotiate a Special Order by Consent (SOC) with the North Carolina Department of Environmental Quality;

WHEREAS, the T. Z. Osborne Water Reclamation Facility has a permit to discharge treated wastewater to South Buffalo Creek, a tributary to the Haw River, classified WS-V waters of this State in the Cape Fear River Basin;

WHEREAS, the discharge is allowed under National Pollutant Discharge Elimination System (NPDES) Permit Number NC0047384 effective July 1, 2014, and expired on June 30, 2019, and administratively extended until reissued by the state;

WHEREAS, the City of Greensboro has voluntarily worked to reduce the concentrations of the unregulated constituent, 1,4-dioxane, discharged from the T. Z. Osborne Water Reclamation Facility;

WHEREAS, the SOC will officially outline the steps that Greensboro will continue to take to further reduce concentrations of 1,4-dioxane in order to protect downstream drinking water sources;

WHEREAS, the T. Z. Osborne Water Reclamation Facility agrees to maintain and operate the wastewater treatment system at its maximum level of efficiency during the interim period of the Special Order by Consent and

thereafter; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That the City is authorized to enter into a Special Order by Consent from the Environmental Management Commission and the City hereby authorizes Steven D. Drew, Water Resources Director, to sign and execute this document on behalf of the City of Greensboro.

7. <u>ID 19-0751</u> Resolution Authorizing Execution of a Contract in the Amount of \$255,652 with Meritech, Inc. for Professional Laboratory Services

316-19 RESOLUTION AUTHORIZING EXECUTION OF A CONTRACT IN THE AMOUNT OF \$255,652 WITH MERITECH INC. FOR PROFESSIONAL LABORATORY SERVICES

WHEREAS, the City of Greensboro was issued its current National Pollutant Discharge Elimination System (NPDES) permit NC0047384 on July 1, 2014. This permit contains effluent limits, monitoring requirements as well as general Standard Conditions that need to be met;

WHEREAS, the City collects influent and effluent samples from the T. Z. Osborne Water Reclamation Facility, along with surface water samples and industrial pretreatment samples;

WHEREAS, professional laboratory services are needed to provide analyses for analytical tests the City does not perform;

WHEREAS, Meritech Inc. was one of four firms that submitted for the work and was selected to perform professional laboratory services over a three-year period in the amount of \$255,652; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That a three-year contract for \$255,652 with Meritech, Inc for laboratory services including payment to be made provided sufficient appropriations in succeeding fiscal years are hereby approved.

WHEREAS, the Webster Road Stream Stabilization project is needed to improve stream bank stabilization and avoid potential issues in the Webster Road area;

WHEREAS, the stream that travels through the Stoneybrooke Apartments on Webster Road has experienced significant erosion;

WHEREAS, this erosion has impacted the public sanitary sewer outfall and will soon create issues for the private property if not addressed. The purpose of the project is to design a stream restoration project to stabilize the stream banks;

WHEREAS, the stream has been mapped by FEMA and will require floodplain modeling and a no-rise certification; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That the contract for \$106,630.45 with CH Engineering, Inc. for Professional Services for the Webster Stream Stabilization Project is hereby approved and the associated budget adjustment.

WHEREAS, the Water Resources department seeks to use a lawn mowing service to maintain the grounds of the plant;

WHEREAS, Sharpe's Landscaping & Design, Inc. submitted for the work and was selected to perform mowing services over a two-year period in the amount of \$139,200; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That a two-year contract with Sharpe's Landscaping & Design, Inc. for mowing services is hereby authorized. WHEREAS, City Council approved the sole source purchase of a wet scrubbing emission control system from EnviroCare International, Inc. located in American Canyon, California;

WHEREAS, the purchased Wet Scrubbing Emission Control System was originally purchased as a modification to the existing EnviroCare Tray Scrubber unit. After the purchase was approved, EnviroCare determined that providing a new complete scrubber unit was more cost effective and would insure the unit working in compliance;

WHEREAS, this fabrication change created an opportunity to separate the emission system from one scrubber unit

to service both incinerators into two separate emission systems. This change will help enable both incinerators to be operated at the same time;

WHEREAS, the City's design engineer has reviewed the quote to ensure the quoted change order meets the required design and performance specifications, and is quoted at a fair and reasonable cost; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That the contract with EnviroCare International, Inc. for the sole source purchase of a VenturiPak Wet Scrubbing Emission Control System with EnviroCare International, Inc. for the T. Z. Osborne Water Reclamation Facility including is hereby approved and the associated budget adjustment.

WHEREAS, work under this contract consists of pre-construction phase services, construction phase services, construction observation (resident project representative services) and additional services related with the construction administration of the project; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That the Construction Administration Services contract for \$299,500 with Arcadis G&M of North Carolina, Inc. for the Groometown Road Water Booster Station construction is hereby approved and the associated budget adjustment.

"Enhance Neighborhood Gateways" and "Neighborhood Identity";

WHEREAS, the selected service provider was identified through a competitive RFP process; WHEREAS, a public hearing was held on October 30, 2019 at the Greensboro Historic

Preservation Commission meeting where the commission made a recommendation in support of the contract;

WHEREAS, the term of the proposed contract is for a 24 month period not exceed \$100,000 with the option to extend the contract for an additional 12 months; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:
