### **Call to Order**

This City Council meeting of the City of Greensboro was called to order at 4:00 p.m. on the above date in the Council Chamber of the Melvin Municipal Office Building with the following members present:

340-19 RESOLUTION AUTHORIZING ACCEPTANCE OF DEDICATION OF NINE DRAINAGE WAY, FLOODPLAIN, AND OPEN SPACE PARCELS FROM WESTMINSTER HOMES, INC. / LAKESHORE VILLAGE HOMEOWNERS ASSOCIATION, INC., D.R. HORTON, INC., CORNWALLIS DEVELOPMENT COMPANY / CONE MILLS CORPORATION (REORGANIZED CONE MILLS CORPORATION), KOURY CORPORATION, STARMOUNT COMPANY, CHANDLER OAKS, LLC / CHANDLER OAKS SUBDIVISION OWNERS ASSOCIATION, W.C. WHEREAS, pursuant to North Carolina General Statutes Section 160A-374, the approval of a plat does not constitute the acceptance by a city or the public of the dedication of any street or other ground or public facility shown on the plat; however, a city council may by resolution accept the dedication made to the public of lands or facilities for streets, parks, public utility lines, or other public purposes;

WHEREAS, Parcel #92090 was dedicated by Westminster Homes, Inc. to the City of Greensboro, Guilford County,

and the public for drainage way and open space and utility easement on the Final Plat of Section 3 Lakeshore Village recorded in Plat Book 127 Page 19 on December 4, 1997. This parcel, also known as 5702 R1 River Glen Drive, is approximately 3.2 acres, zoned R-3, and is located in Council District 3. The parcel was conveyed to Lakeshore Village Homeowners Association, Inc. by General Warranty Deed recorded in Book 4764 Page 54 provided that any land designated as "Open Space" which was accepted for maintenance purposes by a public authority was not included;

WHEREAS, Parcel #85094 was dedicated by D.R. Horton, Inc. to Guilford County, City of Greensboro, and the public as drainage way and open space and utility easement on the Final Plat of Longmorn Village – Section 2 aka Hartwood Village – Phase 1 recorded in Plat Book 138 Page 6 on June 30, 2000. This parcel, also known as 5401 ZZ Bradburn Drive, is approximately 5.49 acres and is located in Guilford County;

WHEREAS, Parcel #65762 was dedicated by Cornwallis Development Co. and Cone Mills Corporation to the City of Greensboro for drainage way and open space on the Final Plat Map 2 of 3 Section Five Phase One Lake Jeanette Subdivision recorded in Plat Book 113 Page 67 on August 29, 1994. This parcel, also known as 2005 Near Regents Park Lane, is approximately 0.04 acres, zoned R-3, and is located in Council District 3. The successor in interest to the dedicators is Reorganized Cone Mills Corporation, a Delaware corporation;

WHEREAS, Parcel #51868 was dedicated by Koury Corporation to City as drainage way and open space on the Final Plat for Dover Elevator Company recorded in Plat Book 109 Page 145 on October 8, 1993. This parcel, also known as 103 YY E. JJ Drive, is approximately 0.4 acres, zoned LI, and is located in Council District 1;

WHEREAS, Parcel #68980 was dedicated by Starmount Company to the City of Greensboro as drainage way and open space on the Plat of Map 1 Weston Woods recorded in Plat Book 118 Page 46 on October 25, 1995. This parcel, also known as 4004 Near Friendly Acres Drive, is approximately 5.33 acres, zoned CD-RM-12, and is located in Council District 4;

WHEREAS, Parcel #85359 was dedicated by Chandler Oaks, LLC to the City of Greensboro and public as drainage way and open space on the Final Plat of Chandler Oaks Phase II, Section 1 recorded in Plat Book 166 Page 116 on September 14, 2006. This parcel, also known as 5249 Near Chandler Oaks Lane, is approximately 1.3 acres, zoned CD-R-5, and is located in Council District 1. The Guilford County Tax Office lists the current owner as Chandler Oaks Subdivision Owners Association due to a General Warranty Deed recorded in Book 6702 Page 1407 on April 4, 2007, conveying the common elements and wet detention ponds;

WHEREAS, Parcel #23504 was dedicated by W.C. Hobbs as a park on the Plat of Lennox Park Subdivision recorded in Plat Book 31 Page 60 on November 9, 1961. This parcel, also known as 1501 Open South English Street, is approximately 2.62 acres, zoned R-5, and is located in Council District 1;

WHEREAS, Parcel #85219 was dedicated by D.R. Horton, Inc. to Guilford County, the City of Greensboro, and the public as drainage way and open space, stream buffer and utility easement on the Final Plat of Longmorn Village – Section 3 aka Laurel Park – Phase 2A recorded in Plat Book 157 Page 79 on December 1, 2004. This parcel, also known as 5220 ZZ Cragganmore Drive, is approximately 10.86 acres and is located in Guilford County;

WHEREAS, Parcel #56723 was dedicated by Brown Realty Company to the City of Greensboro for flood plain and open space on the Plat of Section 8 Friendly Acres recorded in Plat Book 84 Page 96 on January 15, 1997. This parcel, also known as 1504 YY Worthington Place, is approximately 0.26 acres, zoned R-3, and is located in Council District 4;

WHEREAS, the indicated drainage way, floodplain, and open space areas on the recorded subdivision plats have been reviewed and recommended for acceptance by the Greensboro Parks and Recreation Commission;

WHEREAS, it is deemed in the best interest of the City to formally accept the dedication of these drainage way, floodplain, park, and open space parcels; and

This parcel, also known as 5004 YY Black Forest Drive, is approximately 0.43 acres, is zoned PUD, and is located in Council District 2;

WHEREAS, Parcel #230054 was dedicated by GHD – Reedy Fork, LLC to the City of Greensboro and the public for drainage way and open space on the Final Plat for Reedy Fork Ranch entitled “5100 Turner Smith Road Tract 7 & 8 – Phase 1” recorded in Plat Book 200 Page 148 on July 29, 2019, and re-recorded in Plat Book 201 Page 98 on October 10, 2019. (c) The City further determined to initially finance the costs of acquiring, constructing and equipping one of the two downtown parking decks known as the Eugene Street Parking Deck (the "2019 Project"), which 2019 Project constitutes a portion of the Project.

(d) In furtherance thereof, the City issued a first series of the Bonds pursuant to the Master Trust Agreement and a First Supplemental Trust Agreement, dated as of October 1, 2019, between the City and the Trustee in the aggregate principal amount of \$29,685,000 (the "2019 Bonds") to provide funds, together with any other available funds, to pay (i) the costs of the 2019 Project, (ii) interest on the 2019 Bonds during construction of the 2019 Project and (iii) the fees and expenses incurred in connection with the sale and issuance of the 2019 Bonds.

(e) In order to secure its obligations under the Master Trust Agreement, the City executed and delivered a Deed of Trust, dated as of October 1, 2019 (the "Deed of Trust"), for the benefit of the Trustee granting a lien on the site of the 2019 Project, together with any improvements or fixtures located or to be located thereon, subject to permitted encumbrances.

(f) The City has now determined to finance the two fire stations, fire training facilities and emergency alerting systems for the City (the "2020A Project"), which 2020A Project constitutes a portion of the Project.

(g) In furtherance thereof, the City has determined to issue a second series of the Bonds pursuant to the Master Trust Agreement and a Second Supplemental Trust Agreement, to be dated as of February 1, 2020 or other mutually agreeable date (the "Second Supplemental Trust Agreement" and, together with the Master Trust Agreement, the "Trust Agreement"), between the City and the Trustee in an aggregate principal amount not to exceed \$15,250,000 (the "2020A Bonds") to provide funds, together with any other available funds, to pay (i) the costs of the 2020A Project and (ii) the fees and expenses incurred in connection with the sale and issuance of the 2020A Bonds.

(h) In connection with the issuance of the 2020A Bonds, the City intends to execute and deliver a First Supplement and Amendment to Deed of Trust, to be dated as of February 1, 2020 or other mutually agreeable date (the "First Supplement to Deed of Trust"), for the benefit of the Trustee granting a lien on the sites of the 2020A Project (in addition to the lien on the site of the 2019 Project), together with any improvements or fixtures located or to be located thereon, subject to permitted encumbrances. The Deed of Trust, as supplemented and amended by the First Supplement to Deed of Trust, will secure all of the obligations of the City under the Master Trust Agreement, including the 2019 Bonds, the 2020A Bonds and any other bonds issued thereunder.

(i) It is in the best interest of the City to enter into the Second Supplemental Trust Agreement and to issue the 2020A Bonds pursuant thereto and the Master Trust Agreement in that such plan of finance will result in the financing of the 2020A Project in an efficient and cost effective manner.

(j) Entering into the Trust Agreement and issuing the 2020A Bonds pursuant thereto is preferable to a general obligation bond issue or revenue bond issue in that (i) the City does not have sufficient constitutional authority to issue non-voted general obligation bonds pursuant to Article V, Section 4 of the North Carolina Constitution because the City has not retired a sufficient amount of general obligation debt in the preceding fiscal year to issue a sufficient amount of general obligation bonds for the financing of the 2020A Project; (ii) there are no revenues to be generated

by the 2020A Project that allow for the issuance of revenue bonds to finance the costs of the 2020A Project; (iii) the costs of the 2020A Project exceed the amount to be prudently provided from currently available appropriations and unappropriated fund balances; (iv) the circumstances existing require that funds be available to commence the 2020A Project as soon as practicable and the time required for holding an election for the issuance of voted general obligation bonds pursuant to Article V, Section 4 of the North Carolina Constitution and the Local Government Bond Act would delay the 2020A Project by several months; and (v) there can be no assurances that the issuance of general obligation bonds to finance the 2020A Project would be approved by the voters and the current interest rate environment dictates the financing of the 2020A Project be accomplished in a timely and expedient manner.

(k) Based upon information provided to the City Council, the costs of the financing the 2020A Project as described above is reasonably comparable to the costs associated with other alternative means of financing and is acceptable to the City Council.

(l) Counsel to the City will render an opinion to the effect that the proposed undertaking as described above is authorized by law and is a purpose for which public funds may be expended pursuant to the Constitution and laws of the State of North Carolina.

(m) The debt management policies of the City have been carried out in strict compliance with law, and the City is not in default under any obligation for repayment of borrowed money.

(n) No valorem tax rate increase is currently expected to be necessary to pay principal of and interest on the 2020A Bonds.

Section 2. The City Council hereby authorizes and approves the filing of an application with the Local Government Commission for approval of the 2020A Bonds and the Trust Agreement and requests the Local Government Commission to approve the 2020A Bonds and the Trust Agreement and the proposed financing in connection therewith.

(c) The annual audits of the City show the City to be in strict compliance with debt management policies and that the budgetary and fiscal management policies are in compliance with law.

Section 2. The filing of an application of the City with the Local Government Commission for approval of the issuance of the Refunding Bonds of the City is hereby authorized, ratified and approved.

Section 3. The law firm of Womble Bond Dickinson (US) LLP is hereby appointed to serve, but solely at the pleasure of the City Council, as bond counsel to the City in connection with the authorization, sale and issuance of the Refunding Bonds.

Section 4. First Tryon Advisors is hereby appointed to serve, but solely at the pleasure of the City Council, as financial advisor to the City in connection with the sale and issuance of the Refunding Bonds.

**374-19 ORDER AUTHORIZING \$57,000,000 GENERAL OBLIGATION REFUNDING BONDS**

BE IT ORDERED by the City Council of the City of Greensboro, North Carolina:

1. That pursuant to The Local Government Bond Act, as amended, the City of Greensboro, North Carolina, is hereby authorized to contract a debt, in addition to any and all other debt which said City may now or hereafter have power and authority to contract, and in evidence thereof to issue General Obligation Refunding Bonds in an aggregate principal amount not exceeding \$57,000,000 for the purpose of providing funds, together with any other available funds, to (a) refund all or a portion of the City's outstanding (i) General Obligation Housing and Redevelopment Bonds, Series 1998 - Taxable, dated March 3, 1998, (ii) General Obligation Public Improvement Bonds, Series 2003B, dated February 19, 2003, (iii) General Obligation Street Improvement Bonds, Series 2006, dated February 9, 2006, (iv) General Obligation Public Improvement Bonds, Series 2008B, dated February 1, 2008, and (v) General Obligation Public Improvement Bonds, Series 2010B (Federally Taxable Direct Subsidy Build

America Bonds), dated November 2, 2010, and (b) pay certain expenses related thereto.

2. That taxes shall be levied in an amount sufficient to pay the principal of and the interest on said bonds.
3. That a sworn statement of debt of said City has been filed with the City Clerk and is open to public inspection.
4. That this order shall take effect upon adoption.

The City Council thereupon designated the Finance Director of the City to make and file with the City Clerk the sworn statement of debt of the City which is required by The Local Government Bond Act, as amended, to be filed after the bond order has been introduced. The City Council also designated the Finance Director to file with the City Clerk the statement of total estimated interest which is required by The Local Government Bond Act, as amended, to be filed with the City Clerk at the time the bond order is introduced and further directed the City Clerk to file a copy of such statement with the Local Government Commission.

Thereupon, the Finance Director of the City caused to be filed with the City Clerk, in the presence of the City Council, the sworn statement of debt and the statement of total estimated interest as so required.

The City Clerk was thereupon directed to publish the aforementioned order entitled "ORDER AUTHORIZING \$57,000,000 GENERAL OBLIGATION REFUNDING BONDS," together with the appended statement as required by The Local Government Bond Act, as amended, once in The Greensboro News & Record.
