# Meeting Minutes - Final City Council

Monday, November 2, 2020 5:30 PM VIRTUAL

#### **Call to Order**

This Virtual City Council meeting of the City of Greensboro was called to order at 6:00 p.m. on the above date. Mayor Vaughan stated that the Council meeting was rescheduled due to national elections; and took a roll call to confirm the following members were present:

295-20 RESOLUTION HONORING THE MEMORY OF THE LATE RUSSELL WIGGIN BARRETT

WHEREAS, on September 5, 2020, this community lost one of its outstanding community leaders with the passing of the late Russell Wiggin Barrett at the age of 91;

WHEREAS, Russell Wiggin Barrett was born May 22, 1929 in Pitt County, North Carolina; and was the son of

sharecroppers on the Cotton Dale Plantation;

WHEREAS, Mr. Barrett began his education at Bruce Falkland Elementary School, (now Falkland Elementary School,) a three room school for the education of African-American students in Greenville, North Carolina at that time; graduated from H. B Sugg High School, a historically black school in Farmville, North Carolina; earned a four-year Mortician's Degree in Mortuary Science from Gupton-Jones College of Funeral Service in Nashville, Tennessee, as one of two African-Americans in the class, although he did not pursue a career in this field; earned a Bachelor of Science Degree in Industrial Arts Education from North Carolina Agricultural and Technical University (NCA&T) School of Technology; and also a Master's Degree in Industrial Arts/Counseling from NCA&T;

WHEREAS, Mr. Barrett served in the United States Army, 1st Cavalry Division from 1948 to 1952 as a Private First Class; and earned a Good Conduct Medal;

WHEREAS, in 1955, while at NC A & T, then part of the Central Intercollegiate Athletic Association (CIAA), Mr. Barrett was awarded a Golden Glove in boxing;

WHEREAS, utilizing his educational degrees, Mr. Barrett taught at the historic Church Street School in Thomasville, North Carolina; continued his teaching career at Kiser Junior High School (now known as Kiser Middle School) in Greensboro North Carolina; and retired after serving forty years as an educator;

WHEREAS, Mr. Barrett was awarded Teacher of the Year in 1975; and given a Certificate of Honor as an Outstanding Teacher in 1976 by the State of North Carolina;

WHEREAS, as a faithful member of United Institutional Baptist Church, Greensboro, North Carolina for over thirty years, Mr. Barrett participated as a bible study student;

WHEREAS, Mr. Barrett had several pastimes including playing the piano and the guitar, singing folk music, was an artist, an inventor, an event organizer, a mentor, a teacher, an engineer; and a mechanic;

WHEREAS, Mr. Barrett served as activist and treasurer for his community, Arlington Park Neighborhood Association, advocating for sidewalk and street improvements including crossing lights, handicap accesses and overall upgrades;

WHEREAS, Mr. Barrett actively participated in local, state, and national organizations including the Alliance of Retired Americans, the Veterans of Foreign Wars, the St. John's Lodge #12, the National Education Association, and was a lifetime member of the National Association for the Advancement of Colored People (NAACP); and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

- 1.That the City Council wishes to express its condolences, and offer its sincere appreciation and gratitude for Russell Wiggin Barrett many years of dedicated public service. His legacy will be remembered by the outstanding contributions he made to the community.
- 2. That a copy of this resolution shall be delivered to the family of the late Russell Wiggin Barrett as a symbol of the gratitude of the people of Greensboro for his many contributions to this community.

296-20 RESOLUTION DESIGNATING THE WEEK OF NOVEMBER 9-15, 2020 AS VETERANS WEEK

WHEREAS, Veterans Day honors military personnel who served the United States (U.S.) in war; and their contributions and sacrifices in maintaining the freedoms and way of life we enjoy in this country;

WHEREAS, in 1938, Congress designated November 11th as a legal holiday, originally referred to as Armistice Day, to commemorate the signing of the armistice, which ended World War I hostilities between the Allied nations and Germany in 1918;

WHEREAS, in 1954, Congress changed the word "Armistice" to "Veterans," expanding the federal holiday to recognize those who served in World War II, the Korean War, and subsequent conflicts;

WHEREAS, according to 2018 U.S. Census data, there were 718,481 United States (U.S.) veterans in North Carolina; 30,628 U.S veterans in Guilford County; and 14,586 U.S. veterans in the City of Greensboro;

WHEREAS, nationwide observances include an official holiday, parades, art exhibits, historical recognitions, public gatherings and fellowship to show appreciation; and the American flag is flown at half-mast;

WHEREAS, the intent of Veterans Week is to expand the commemoration of the observance, heighten awareness of the importance of the accomplishments of those who have served in all Armed Forces, both U.S. and our allies, with or without the declaration of war; and to understand the history of military action;

WHEREAS, designating Veterans Week will emphasize the need to develop educational programming regarding the contributions of veterans; understand the sacrifices made in service to country; and address physical, mental and emotional stressors; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

The City of Greensboro resolves that the week of November 9-15, 2020 is hereby recognized as Veterans Week in the City of Greensboro to honor military personnel and to encourage citizens to celebrate their lives, contributions and sacrifices in service to the United States of America.

297-20 RESOLUTION DECLARING SATURDAY, NOVEMBER 28, 2020 SMALL BUSINESS SATURDAY IN THE CITY OF GREENSBORO

WHEREAS, the City of Greensboro, celebrates its local small businesses and the contributions they make to the local economy, community and growth with unique gifts and personalized services;

WHEREAS, the United States Small Business Administration (SBA) was created in 1953; and help small business owners and entrepreneurs pursue the American dream;

WHEREAS, consumers in the United States value the contributions small businesses make in communities and those who plan to shop on Small Business Saturday® say the day inspires them to go to small, independently-owned retailers or restaurants that they have not been to before, or would not have otherwise tried;
