Meeting Minutes - Final City Council

Monday, March 2, 2020 5:30 PM Council Chamber

Call to Order

This City Council meeting of the City of Greensboro was called to order at 5:48 p.m. on the above date in the Council Chamber of the Melvin Municipal Office Building with the following members present:

Also present were City Manager David Parrish, City Attorney Chuck Watts, and City Clerk Angela Lord.

Council returned to the Council Chamber from a closed session called during the work session in the Plaza Level Conference Room.

Mayor Vaughan requested a motion to return to open session. Moved by Councilmember Hoffmann, seconded by Councilmember Kennedy to return to open session at 5:46 p.m. The motion carried by voice vote. The City Council reconvened with all members in attendance.

Jim Galyon voiced appreciation to Council; spoke to the character of his father; to the participation in public service by family members; commended Councilmember Hoffmann for efforts on the Greensboro Alcohol and Beverage (ABC) Commission; spoke to the loss of his sister and his dad; and extended birthday greetings to Mayor Vaughan.

060-20 RESOLUTION HONORING THE MEMORY OF THE LATE J. DOUGLAS GALYON, SR.

WHEREAS, on April 7, 2019, this community lost one of its outstanding community leaders with the passing of the late J. Douglas Galyon, Sr.;

WHEREAS, Mr. Galyon was born in Knoxville, Tennessee on September 5, 1930; and moved to Greensboro, North Carolina (NC) at age 13;

WHEREAS, he graduated from Greensboro High School, now known as Grimsley High School in 1949; attended Duke University in Durham, NC; and graduated from Guilford College in 1953;

WHEREAS, Mr. Galyon served our country in the United States Marine Corps from 1954 to 1956;

WHEREAS, his successful textile career included extended service with Burlington Industries, Allied Chemical, and Guilford Mills:

WHEREAS, Mr. Galyon believed in civic duty; volunteered with the Greensboro Sports Council; Greensboro Jaycees; Guilford College Board of Visitors; Greensboro Rotary Club; and Iron Dukes, an organization to provide resources to Duke University student-athletes;

WHEREAS, he was instrumental in facilitating the return of the Professional Golf Association (PGA) tour to the Greater Greensboro Open, now widely known as the Wyndham Championship; and securing airing of the tournament on the national broadcast television station, CBS in 1988;

WHEREAS, Mr. Galyon served on the Greensboro War Memorial Commission, from 1976 to 1981; the Greensboro City Council from 1981 to 1983; and the Guilford County Board of Commissioners from 1985 to 1988 to which he was twice elected as the Vice Chairman to the Board:

WHEREAS, he was a vital member of the North Carolina Board of Transportation, representing the Greensboro area from 1992 through 2008; chaired the Board of Transportation for nine years; and was influential in key policy and planning decisions which continued to label North Carolina as a "Good Roads State", based on a national movement for road construction and maintenance in rural areas and from which the North Carolina State Highway Commission, now the North Carolina Department of Transportation, was founded;

WHEREAS, in honor of Mr. Galyon's transportation-related achievements, the City of Greensboro named the 1927 railroad depot the "J. Douglas Galyon Depot" after the facility's redesign and restoration to a multi-model terminal for trains, buses, and other ground transport; and in November 2019 Governor Roy Cooper dedicated a portion of the Greensboro Urban Loop in honor of Mr. Galyon;

WHEREAS, he helped inspire a regional transit program in 1997 which grew to become the Piedmont Authority for Regional Transportation (PART); made advancements towards creating the Greensboro Urban Loop; and had significant involvement in the Piedmont Triad International Airport (PTIA) taxiway bridge relocation which created the availability of hundreds of acres for aviation-related development;

WHEREAS, Mr. Galyon was awarded the prestigious Order of the Long Leaf Pine, the state's highest civilian honor,

by Governor Beverly Perdue on January 5, 2001 for exemplary service to the State of North Carolina; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

- 1. That the City Council wishes to express its sense of loss and offer its condolences, sincere appreciation and gratitude for the many years of dedicated public service by J. Douglas Galyon, Sr. The legacy he leaves will be remembered by the people of Greensboro.
- 2. That a copy of this resolution shall be delivered to the family of the late J. Douglas Galyon, Sr. as a symbol of the gratitude of the citizens of the City of Greensboro and the State of North Carolina for his many contributions to this community and beyond.

061-20 RESOLUTION HONORING THE MEMORY OF THE LATE STEPHEN DALE SHOWFETY

WHEREAS, on October 31, 2019, this community lost one of its outstanding community leaders with the passing of the late Stephen Dale Showfety;

WHEREAS, Mr. Showfety, born on March 10, 1947, a native of Guilford County and resident until his passing at the age of 72;

WHEREAS, Mr. Showfety graduated from Grimsley High School in 1965; earned a Bachelor of Science degree in Education from East Carolina University (ECU) in 1970; and was a 1982 graduate of Leadership Greensboro;

WHEREAS, he remained active with the ECU by serving six years as an officer of the ECU Board of Visitors; an eight year member of the Board of Trustees where he served six years as an officer and two years as Chairman; served as a member of the Board of the ECU Foundation; and was recognized with the Distinguished Service Award in 2008 and the Advocacy Award in 2018;

WHEREAS, Mr. Showfety began his 41 year career with The Koury Corporation in 1978 where he served as President, retiring in 2019; and during his time with the corporation, he remodeled the Sheraton Hotel and Koury Convention Center with a 22-month, \$30 million renovation;

WHEREAS, as an active member with local community boards and commissions, Mr. Showfety served three terms as Treasurer with the Greensboro Regional Realtors Association, and as Chairman of the Commercial and Industrial Division; served on the Greensboro Builders Association, Greensboro Merchants Association, Greensboro Area Chamber of Commerce, Greensboro Economic Development Alliance, Triad Real Estate Building Industry Coalition, the Greensboro Convention and Visitors Bureau, served as a past President and Chairman of the Greensboro Sports Council; the University of North Carolina at Greensboro (UNC-G) Human Environmental Sciences Foundation; Central North Carolina Chapter of the National Multiple Sclerosis Society; served as Chairman of the Board for the Piedmont Triad Airport Authority (PTI); and continued to participate in PTI board meetings via

telephone until his passing;

WHEREAS, in 2019 he was awarded the Stanley Frank Economic and Workforce Development Award by the Greensboro Area Chamber of Commerce; and the Order of the Long Leaf Pine, the highest civilian honor, in 2019 from North Carolina Governor Roy Cooper;

WHEREAS, Mr. Showfety was repeatedly identified by the Triad Business Journal as one of the area's "Most Influential People"; and Business North Carolina listed him among its "Power 100";

WHEREAS, he provided valuable service to the community by demonstrating a strong work ethic; and instilled hard work, commitment, and the importance of education;

WHEREAS, Mr. Showfety was described as a respected business leader that displayed the values of kindness, humor, humbleness, faith, and generosity; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

- 1. That the City Council wishes to express its condolences, and offer its sincere appreciation and gratitude for the many years of dedicated public service of Stephen Dale Showfety. His legacy will be remembered by the outstanding contributions he made.
- 2. That a copy of this resolution shall be delivered to the family of the late Stephen Dale Showfety as a symbol of the gratitude of the people of Greensboro for his devoted support and contributions to the community.

I. PUBLIC COMMENT PERIOD

Vickie Motley voiced concerns with Specialized Community Area Transportation (SCAT); and with the customer service.

Jamey Gaddy voiced concerns with SCAT ride times.

Larsina Johnson provided letters to Council for review from the Greensboro Department of Transportation; referenced conversation at Riders Advisory Committee (RAC) meeting; and spoke to a meeting with Assistant City Manager Kim Sowell.

Councilmember Hightower confirmed the staff letters were written with the supervision of the managers office.

Mayor Vaughan requested staff provide copies of the letters to all Council members: and City Manager Sowell provide a history of the matter.

Laura Way representing Arts Greensboro and the Cultural Center spoke to I Heart Month; and voiced appreciation for support from Council.

Ben Holder voiced concerns with the Greensboro Police Department (GPD); spoke to the David Wray case; and voiced concern with cost to taxpayers.

Curtis Cazoe with SSME, Inc. voiced concerns with non-payment for services provided.

Assistant City Manager Sowell explained the conflict regarding unsatisfactory work; and spoke to an investigation.

Discussion ensued regarding the need for documentation; an upcoming meeting with the project manager; and collaboration with small firms and primary contractors.

Brian Watkins voiced concerns with the GPD; consent to search policies; civil rights; and spoke to the Zared Jones incident.

Hester Petty spoke to the Zared Jones incident; and to a letter to Council from Attorney Graham Holt.

Fields Ketteman referenced an incident in January; voiced concerns with GPD; spoke to hate crimes; to Lesbian, Gay, Bi-Sexual, Transgender (LBGT) protection; and to running for office.

Discussion took place regarding the Prosecutors' determination in charges.

Jay Williamson spoke to the need for additional glass recycling drop off locations; voiced concerns with transporting glass to the locations; and encouraged residents to go vote.

Councilmember Abuzuaiter explained the recycling process; and recommended involvement of high school groups and Boy Scout Troops.

Councilmember Hightower spoke to the need for a location in District 1.

Madison Dunlap spoke to the recognition of Creek Week on the consent agenda; to celebrations for Women History Month; and to progression of females in the community.

Council highlighted a tribute to women at the Barber Park, Ruth Wicker Event Center; and an upcoming recognition of nominees.
