Meeting Minutes - Final City Council Work Session

I. Call To Order

This City Council Work Session of the City of Greensboro was called to order at 4:00 p.m. on the above date in the Plaza Level Conference Room of the Melvin Municipal Office Building with the following members present:

Mayor Nancy Vaughan, Councilmembers Marikay Abuzuaiter, Sharon Hightower, Nancy Hoffmann, Yvonne J. Johnson, Tammi Thurm, Goldie Wells, Justin Outling, and Michelle Kennedy.

Also present were Assistant City Manager David Parrish, City Attorney Chuck Watts and Assistant City Clerk Victoria Howell.

II. Presentations

1. [ID 20-0114](#) Comprehensive Plan Update

City Manager David Parrish recognized Planning Director, Sue Schwartz for a PowerPoint Presentation (PPP) on the Comprehensive Plan.

Ms. Schwartz spoke to the Greensboro (GSO) 2040 Comprehensive Draft-Plan; to public engagement; to community values; to the vision; to implementation; to scheduling; and to public comment.

Discussion took place regarding pop-up stations for forums; frame work strategies; inclusiveness; changes to the North Carolina Statues; integration with existing plans; an online presence; to R7 and R5 differences; walkable communities; and transportation options.

Mayor Vaughn spoke to an implementation timeline.

Discussion ensued regarding transportation by the airport; changes in zoning requirements; training; and policy goals.
