## Meeting Minutes - Final City Council Special Meeting

Tuesday, March 17, 2020

3:00 PM

Council Chamber

### I. Call To Order

This City Council meeting of the City of Greensboro was called to order at 3:00 p.m. on the above date in the Council Chamber of the Melvin Municipal Office Building with the following members present:

Present 9 - Councilmember Marikay Abuzuaite, Mayor Nancy Vaughan, Councilmember Nancy Hoffmann, Councilmember Sharon Hightower, Mayor Pro-Tem Yvonne Johnson, Councilmember Justin Outling, Councilmember Michelle Kennedy, Councilmember Tammi Thurm, and Councilmember Goldie Wells

Also present were City Manager David Parrish, City Attorney Chuck Watts, and City Clerk Angela Lord.

### II. Presentations

#### [ID 20-0278](#) Council Discussions Regarding COVID-19

City Manager David Parrish spoke to concerns with the COVID-19 virus; to the reduction of operational hours; to additional restrictions and closing to be announced at a 3:30 p.m. press conference; stated staff had been in continuance communications with the Emergency Management team; encouraged residents to follow guidelines provided by the Center for Disease Control (CDC); spoke to code enforcement reductions; to health inspections; to staff telecommuting; and to notification of a positive test in Guilford County.

Assistant City Manager Chris Wilson reiterated the detailed operational changes to be shared with the press; emphasized the CDC recommendations; spoke to daily updates; and to providing support and hope to the community.

Assistant City Manager Trey Davis provided an overview on protocol changes for public safety; spoke to coordinated efforts; to proper adjustments for the Greensboro Police Department; and to precautions for first responders.

Councilmember Thurm requested staff implement a Task Force with community partners.

Mayor Vaughan spoke to volunteer opportunities with non-profit organizations; to donations for the Unity Way of Greensboro; and encouraged residents to utilize non-profit organizations for contributions.

Discussion took place regarding assistance in east Greensboro; leadership efforts; additional food support for residents; the use of recreational facilities for food drop sites; use of bus drivers for deliveries; concerns for small businesses and families; and sites identified by the school system for food drop-offs.

Councilmember Outling spoke to unexpected household expenses; to financial disasters; to state and federal support; voiced the need to analyze circumstances thoroughly; spoke to the role of Council; and voiced support for the creation of a Task Force.

Councilmember Kennedy requested information to be posted to the city website.

City Manager Parrish confirmed there would be daily updates provided; spoke to staffing levels; to childcare concerns for staff; and to personal sick leave.

Discussion continued regarding innovative and creative programs implemented; the need to debunk of rumors; the closures of facilities with continued services

Moved by Mayor Pro-Tem Johnson, seconded by Councilmember Abuzuaiter, to adjourn the Emergency meeting. The motion carried by voice vote.
