Call to Order

This hybrid City Council meeting of the City of Greensboro was called to order at 5:47 p.m. on the above date in the Council Chamber of the Melvin Municipal Office Building with the following members present:

The meeting opened with a moment of silence.

Former Fire Department Fire Chief Ray Flowers voiced appreciation; spoke to his work history with the City of Greensboro; and to service to others.

Discussion ensued regarding appreciation to Former Fire Chief Flowers for leadership; serving as a trailblazer; community work; and mentorship.

145-21 Resolution to Honor and to Support the Dedication of Greensboro Fire Station #7 for Former Greensboro Fire Department Fire Chief Ray K. Flowers

Whereas, Ray K. Flowers began employment with the City of Greensboro Fire Department (GFD) in 1961 as one of the first African American firefighters with the GFD;

Whereas, setting a legacy within the GFD, Former Fire Chief Flowers was also the first African American to become a Battalion Fire Chief, an Assistant Fire Chief, and Deputy Fire Chief;

Whereas, making history, Former Fire Chief Flowers served the City of Greensboro as the first, and thus far the only, African American Fire Chief of the Greensboro Fire Department from 1993 to 1999;

Whereas, continuing to make history, Former Fire Chief Flowers led the GFD to become only one of seven fire departments globally to achieve accreditation with The Commission on Fire Accreditation International;

Whereas, the GFD was the first of few fire departments to achieve accreditation with The Commission on Fire Accreditation International and maintain an Insurance Service Office (ISO) Class 1 rating;

Whereas, in addition to serving the City in a formal capacity, Former Fire Chief Flowers has made a mark within the community with participation in the Prince Hall Mason Freemasonry which is a branch of the North American Freemasonry for African Americans founded in 1784;

Whereas, Former Fire Chief Flowers is a member and past Master of Morning Star Lodge #691 (PHA), a member of Greensboro Consistory # 106 A.A.S.R. of Freemasonry (PHA), and a member and past Potentate of Khalif Temple #144 A.E.A.O.N.M.S., Inc.;

Whereas, he was a long time member of Reid Memorial CME Church where he served on the Finance Committee and as President of the Steward Board;

Whereas, Former Fire Chief Flowers currently holds membership at Bethel AME Church and has also served as a member of the Steward Board, has participated in hosting the Bethel Golf Tournament, and has partnered with the initiation of a Public Safety recognition day;

Whereas, in appreciation and honor of Former Fire Chief Flowers, Samet Corporation will place a bronze plaque of dedication on Fire Station #7; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

1. That the City Council wishes to express its deep gratitude and appreciation to Former Greensboro Fire Chief Ray K. Flowers for his many years of dedicated public service and outstanding contributions to the community.

146-21 RESOLUTION RECOGNIZING AND CELEBRATING JULY AS PARKS AND RECREATION MONTH

WHEREAS, the National Recreation and Park Association has celebrated the month of July as National Parks and Recreation Month since 1985; and our own Parks and Recreation Department has served Greensboro since 1933;

WHEREAS, during this time, the Parks and Recreation Department has established itself as both an integral, trusted part of the Greensboro community, and as an industry leader in being innovative, collaborative, and efficient towards meeting community needs;

WHEREAS, parks and recreational programs and amenities are vitally important to establishing and maintaining the quality of life in Greensboro, ensures the health of all citizens, and contributes to the economic and environmental well-being of the community and region;

147-21 RESOLUTION RECOGNIZING THE SIXTH ANNIVERSARY OF THE FAMILY JUSTICE CENTER (FJC)

WHEREAS, the Guilford County Family Justice Center (FJC) opened June 15, 2015, with a mission to empower family violence victims to live free from violence and abuse, and hold offenders accountable by providing easily accessible, coordinated, and comprehensive services in a single location;

WHEREAS, FJC is a "one stop shop" for victims of domestic violence, sexual assault, child abuse, and elder abuse that incorporates more than 100 professionals from 18 different disciplines who work together to provide consolidated and coordinated safety, legal, social, and health services to those in need;

WHEREAS, through FJC, survivors have access to a wide range of supportive resources such as victim advocacy; filing a restraining order; civil and criminal legal support; law enforcement follow-up; medical care; counseling; and assistance accessing shelter as well as other community resources;

WHEREAS, the success of the FJC is rooted in partnerships, and through its work and services there has been significant overall decrease in the number of domestic violence related homicides since the FJC's inception;

WHEREAS, some of the key accomplishments over the past six years include, but are not limited to the following: service to over 45,000 individuals and families, opening a second location in High Point, increased access to emergency legal assistance, availability of electronic filing for restraining orders, establishment of a specialized medical clinic for abused children, nationally recognized programming focused on reducing child trauma and elder abuse, and continued in-person operations throughout the COVID-19 pandemic;

WHEREAS, the City Council commends FJC for their work and contributions to the City of Greensboro and to Guilford County; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That it hereby recognizes the Guilford County Family Justice Center on its sixth anniversary and extends appreciation for the contributions FJC has made to the community over the past five years.

148-21 RESOLUTION APPROVING FY 2021-2022 CONTRACT AWARD IN THE AMOUNT OF \$156,762 FOR FIREFIGHTER MEDICAL EVALUATIONS AND PHYSICALS

WHEREAS, the Greensboro Fire Department, in accordance with the National Fire Protection Association's Standard on Comprehensive Occupational Medical Programs for Fire Departments (NFPA 1582) and the Standard on Fire Department Occupational Safety and Health Program (NFPA 1500) has established and maintained a medical evaluation program for its sworn firefighters;

WHEREAS, providing annual medical evaluations for firefighters is considered the best practice for making a difference in the lives of firefighters because it has resulted in the early diagnosis of existing and/or potential health issues;

WHEREAS, the City of Greensboro has contracted with Moses H. Cone Memorial Hospital Operating Corporation for over eleven years to provide annual medical evaluations and physicals for firefighters;

WHEREAS, a total amount of one hundred fifty six thousand, seven hundred and sixty two dollars (\$156,762) is allocated to provide annual medical evaluations for firefighters; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That the City Manager is authorized to execute the Contract between the City of Greensboro and the Moses H. Cone Memorial Hospital Operating Corporation, for annual medical evaluations of all sworn firefighters for the contracted amount of \$156,762.

IV. PUBLIC HEARING AGENDA

12. [ID 21-0407](#) Public Hearing on Access GSO Fares

Mayor Vaughan stated this was the time and place set for a public hearing to receive public input on Access GSO Fares; and recognized Transportation Department Director Hanna Cockburn.

Ms. Cockburn made a PPP; spoke to a required public hearing; to fares being reflected in the FY 21-22 budget; recognized the assistance of Keolis; provided the history of Access GSO; spoke to the i-Ride program; to the pandemic fare free program; to Americans with Disabilities Act (ADA) service areas; to para-transit ridership; and to Council priorities. Ms. Cockburn spoke to the GSO 2040 plan; to GSO4Ward and the GARE Program; to operational costs; to anticipated revenue shortfalls and challenges; to fixed routes; to peer city comparisons; to public engagement; and to staff recommendations for a multi-year fare increase.

Discussion took place regarding the current year budget; revised adjustments; federal funding; the upcoming closure of Duke Energy funding; incremental increases; transportation deficits; a phased approach; potential revisions; program sustainability; presentation shared during public hearings; demographics and socio-economic

status of riders; an operational analysis of ADA services; and national rates.

Deanna De'Liberto voiced appreciation for the services; concern with cost to riders; spoke to financial hardships; requested rates for premium and fixed routes to remain the same; and spoke to a service for low income people.

AJ Inglesby referenced attendance at the public hearings; voiced concern regarding a portion of the presentation not being shared previously; stated rider support for a minimum increases up to \$3; spoke to premium service areas; and to weekend availability.

BJ Gerald-Covington voiced concern with fare increases; spoke to fixed incomes; to large city budgets; and to limited employment hours.

Councilmember Hightower voiced support for a fifty cent increase; requested staff to research partnerships; stated opposition to an increase to \$3.00; requested staff evaluate each year; and spoke to fair treatment.

Mayor Vaughan stated many departments did not generate a profit margin; voiced support for a fifty cent increase; and spoke to the need to plan for future improvements.

City Manager Parrish explained the fifty cent incremental increases; spoke to service sustainability; to a premium service base; and to an upcoming agenda item.

Moved by Councilmember Wells, seconded by Mayor Pro-Tem Johnson to close the public hearing. The motion carried by the following roll call vote:

Councilmember Hightower voiced concerns with workforce challenges; and with a request for additional funding by the current contractor.

Assistant City Manager Davis spoke to a summary provided previously; to quarterly updates; to a delayed Gate City Coalition database training due to the pandemic restrictions; to participant criteria; to community partnerships; to job and interview training; to stable housing; to community trust; outlined violence interruption tracking; and provided current crime statistics.

150-21 RESOLUTION AUTHORIZING SUBMISSION OF THE ANNUAL ACTION PLAN APPLICATION FOR \$2,493,298 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM FUNDS AND THE CONDUCT OF CDBG PROGRAM ACTIVITIES FOR THE 2021-2022 FISCAL YEAR

WHEREAS, the Department of Neighborhood Development has prepared a 2021-2022 Annual Action Plan that states goals and objectives for affordable housing, neighborhood development, and economic development for the coming year;

WHEREAS, under Title 1 of the Housing and Community Development Act of 1974 (Public Law 93-383), as amended, the Secretary of the Department of Housing and Urban Development is authorized to award Community Development Block Grants (CDBG) for the conduct of Community Development Programs;

WHEREAS, it is desirable and in the public interest for the City of Greensboro to prepare and submit a One-year Action Plan for conducting Community Development activities in the City of Greensboro;

WHEREAS, it is understood that acceptance of a Community Development Block Grant obligates the City of Greensboro to conduct and administer Community Development Program activities in accordance with the requirements of Title 1 of the Housing and Community Development Act of 1974, as amended, applicable Federal and State laws, and implementing rules and regulations officially adopted by the Department of Housing and Urban Development; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO;

That the 2021-2022 Annual Action Plan is hereby approved.

That the submission of an Annual Action Plan applying for FY 2021-2022 Community Development Block Grant funds in the amount of \$2,493,298, which includes \$150,000 in estimated local program income, is hereby authorized and approved and supersedes any previous submission.

That the conduct of Community Development Block Grant activities in whole or in part by the City of Greensboro and/or designees is hereby authorized and approved.

That the City of Greensboro is fully cognizant of the obligations, responsibilities, and requirements accompanying the acceptance of a Community Development Block Grant and that it is the sense of this body that such obligations, responsibilities, and requirements will be fulfilled.

That the City Manager is designated as the official representative of the City of Greensboro, and is authorized to submit the final statement, all understandings and assurances contained therein, and directed to act in connection with the submission of the final statement and to provide such additional information as may be required.

That the Mayor, as Chief Elected Officer, or their designee, is authorized and consents on behalf of the City of Greensboro and her/himself (1) to assume the status of a responsible Federal official under the National Environmental Policy Act of 1969, insofar as the provisions of such act apply to the administration and conduct of local Community Development Program activities as referred to above; and (2) to accept the jurisdiction of the Federal courts for the purpose of enforcement of their responsibilities as such an official.

WHEREAS, the North Carolina General Statutes in Chapter 160A, Article 20, provide that units of local government may enter into agreements in order to execute an undertaking providing for the continual exercise by one unit of any power, function or right, including the collection of taxes;

WHEREAS, the CITY and COUNTY agree that this amended Interlocal Agreement shall continue for eight (8) years, from July 1, 2016 to June 30, 2024, unless terminated pursuant to the terms herein;

WHEREAS, the governing bodies of the CITY and COUNTY have ratified this Interlocal Agreement by resolutions recorded in their respective Minutes; and

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO:

That the resolution authorizing an amended interlocal agreement between the City of Greensboro and the County of Guilford for the collection of taxes is hereby approved.
