PURPOSE:

SMHM Properties LLC is requesting original zoning from County AG (Agricultural) to City R-3 (Residential Single Family) for portions of property located at 1801 Cude Road and 1199 Pleasant Ridge Road, generally described as north of Pleasant Ridge Road and west of Cude Road.

As this request is associated with a voluntary annexation petition, the City Council will conduct a public hearing to consider and take action on this request at its **June 21, 2016** meeting.

BACKGROUND:

Following a public hearing on May 16, 2016, the Zoning Commission voted 8-0 to recommend approval of this request. One person spoke in favor of the request and none in opposition.
