### PURPOSE:

The bids for Contract 2017-035 - Mitchell Filter Plant Structural and Durability Improvement Project have been received. In order for the work to proceed on this contract, City Council approval is requested for award of the contract to Freyssinet, Inc. in the amount of \$6,303,077.00.

### BACKGROUND:

This work consists of structural repairs to existing reinforced concrete members and durability repairs and enhancements to existing concrete surfaces in walls, beams, and slabs. The bids for this project were opened on July 20, 2017 and the apparent lowest, responsible bidder is Freyssinet, Inc. (Sterling, VA) with a bid of \$6,303,077.00.

The contractor's commitment is MBE 0% and WBE 0%.
