PURPOSE:

Allocations are for programs funded through the Workforce Innovation and Opportunity Act (WIOA) administered by the City of Greensboro's Office of Workforce Development. A budget amendment needs to be approved to allow the expenditure of funds.

BACKGROUND:

1. Includes Detail Section 1 in Attachment A. The Community Foundation of Greater Greensboro has received a grant under the Eastern Triad Workforce Initiative (ETWI). The Guilford WDB, as a subgrantee, has been granted funds in the amount of \$655,000 effective 7/1/2018, expiring 6/30/2019.

The Guilford WDB ETWI Fund is created in the amount of **\$655,000**.

2. Includes Detail Section 2 in Attachment A. The NC Department of Commerce provides business services funds to local WDBs based on request. The Guilford WDB has been granted funds in the amount of \$75,000 effective 7/13/2018, expiring 12/31/2019.

The Guilford WDB 2018 Business Services Fund is created in the amount of \$75,000.
