PURPOSE:

The bids for Contract 2010-034, Battleground Avenue (US 220) and Westridge Road Intersection Improvements, have been received. In order for work to proceed, City Council approval is requested for award of the contract to Atlantic Contracting Company, Inc. in the amount of \$7,594,923.50.

BACKGROUND:

The work consists of all labor, equipment, and materials required for installation of roadway improvements: fine grading, storm drainage, asphalt paving, pavement markings, retaining wall, erosion control, and ADA compliant concrete curb cuts and driveways.

The bids were opened on June 20, 2019 and the apparent lowest, responsive, responsible bidder is Atlantic Contracting Company, Inc. (Greensboro, NC) with a bid of \$7,594,923.50.

The DBE goal was 10%.

The contractor's commitment is DBE 10.0%.

Note: the DBE is also a WBE within the City's MSA.

Other bid received:

Yates Construction Company, Inc. \$7,770,793.15 DBE 10.4% Stokesdale, NC

The proposed date of start for construction is August 26, 2019. The proposed date of completion is May 27, 2021.
