#### **PURPOSE**:

Javier Saidana is requesting original zoning from **County RS-40** (Residential Single Family) to **City R-3** (Residential Single Family - 3) for 4504 Pine Vista Lane, generally described as south of Pine Vista Lane and east of Circleview Drive.

As this request is associated with a voluntary annexation petition, the City Council will conduct a public hearing to consider and take action on this request at its **July 16**, **2019** meeting.

#### **BACKGROUND:**

Following a public hearing on June 17, 2019, the Zoning Commission voted 6-1 to recommend approval of this request. There was one speaker in opposition. (See minutes of the June 17, 2019 Zoning Commission

meeting). This request is associated with a voluntary annexation petition in order to access City water and sewer for a new residential dwelling.
