PURPOSE:

This Microsoft Enterprise Agreement is entered into between the Microsoft and the City of Greensboro as of the effective date. The Enterprise Agreement consists of: (4000) Core CAL's with Software Assurance, access to Microsoft Exchange, SharePoint, SQL Server Enterprise and Standard, Microsoft Server Standard and Datacenter. The service agreement is currently in effect until November 30 2019.

BACKGROUND:

The Microsoft suite of software is used to conduct the business of the City. Included in the original contract is the expection that the City would enter into an enterprise agreement, for the renewal of software licenses for as long as they choose to use this software solution to meet those needs.
