PURPOSE:

City Council approval is requested to authorize the city manager to execute a contract modification in the contract (2017-5251) with Arbor E&T, LLC d/b/a ResCare Workforce Services in the amount of \$45,000 to fund Workforce Innovation and Opportunity Act Adult and Dislocated Worker services through June 30, 2020.

BACKGROUND:

The Workforce Development Board/City of Greensboro has contracted with Arbor E&T, LLC d/b/a ResCare Workforce Services to provide comprehensive workforce services for Adults and Dislocated Workers since October 2014.

Due to high demand of services, additional funds are needed in the contract to effectively deliver services through June 30, 2020.
