PURPOSE:

The bids for Resurfacing of Streets - 2020-001A - Part 2, have been received. In order for the work to proceed on this contract, City Council approval is requested for award of the contract to Blythe Construction, Inc. in the amount of \$2,162,755.85.

BACKGROUND:

This work consists of all labor, equipment, and incidentals required for both demolition and resurfacing of various streets. The bids were opened on February 27, 2020 and the apparent lowest, responsible bidder is Blythe Construction, Inc. (Charlotte, NC) with a bid of \$2,162,755.85.

The M/WBE utilization goal was MBE 6.0% and WBE 13.0%. The contractor's commitment is MBE 6.0% and WBE 13.0%.
