#### **PURPOSE:**

The City of Greensboro Metropolitan Planning Organization received a grant award from the Federal Transit Administration (FTA) and North Carolina Department of Transportation (NCDOT) to support on-going short-range service planning activities for the Greensboro Transit Authority (GTA). A resolution must be adopted to authorize the City Manager to enter into this agreement.

#### **BACKGROUND:**

The Greensboro Urban Area Metropolitan Planning Organization (GUAMPO) adopted a resolution authorizing GTA's FY20-21 Program of Projects, including the FY2021 FTA Section 5303 Planning Assistance grant on June 24, 2020. This grant allows the City (through the Public Transportation Division) to commission an ADA Operational Analysis. The grant also supports two full-time Transit Services Planner positions for the City of Greensboro Department of Transportation.
