## PURPOSE:

Ian Phillips of the Crown Companies, LLC for Janice Hancock and Thomas Watson, is requesting rezoning from **R-3** (Residential Single Family - 3) to **R-5** (Residential Single Family - 5) for 1300 Covered Wagon Road, generally described as west of Covered Wagon Road and north of Chandler Oaks Lane.

As the Zoning Commission approved this request with less than 6 favorable votes, the City Council will conduct a public hearing to consider and take action on this request at its **March 16, 2021** meeting.

# **BACKGROUND:**

Following a public hearing on January 20, 2021, the Zoning Commission voted 5-2 to approve this request.

There was one speaker in favor and seven in opposition. (See minutes of the January 20, 2021 Zoning Commission meeting).

The Zoning Commission recommended approval of this request 5-2
