PURPOSE:

City Council is requested to approve donating the surplus vehicle to The Interactive Resource Center (IRC) for daily o perations and transportation during sheltering operations. North Carolina General Statute§ 160A-280 authorizes a city to donate personal property to a nonprofit organization following the governing board declaring the property to be donated as surplus and giving its approval for the donation.
